9 An Act relating to general appropriations for the  
10 expenses of various agencies of the executive,  
legislative and judicial departments of the state;  
11 making appropriations to the State Board of  
Education, the Oklahoma Arts Council, the State Board  
12 of Career and Technology Education, the Commissioners  
of the Land Office, the Oklahoma Educational  
Television Authority, the Oklahoma State Regents for  
13 Higher Education, the Oklahoma Department of  
Libraries, the Physician Manpower Training  
14 Commission, the Oklahoma Board of Private Vocational  
Schools, the Board of Trustees of the Oklahoma School  
15 of Science and Mathematics, the Oklahoma Center for  
the Advancement of Science and Technology, the  
16 Oklahoma Commission for Teacher Preparation, the  
Office of the State Auditor and Inspector, the Office  
17 of the State Bond Advisor, the State Election Board,

3 and Youth, the Office of Disability Concerns, the  
4 Department of Human Services, the Office of Juvenile  
5 Affairs, the State Department of Rehabilitation  
6 Services, the Oklahoma Department of Agriculture,  
7 Food, and Forestry, the Oklahoma Department of  
8 Commerce, the Rural Economic Action Plan Fund, the  
9 Oklahoma Conservation Commission, the Department of  
10 Consumer Credit, the Corporation Commission, the  
11 Department of Environmental Quality, the Oklahoma  
12 Historical Society, the Oklahoma Horse Racing  
13 Commission, the Insurance Department, the J.M. Davis  
14 Memorial Commission, the Department of Labor, the  
15 Department of Mines, the Scenic Rivers Commission,  
16 the Oklahoma Tourism and Recreation Department, the  
17 Oklahoma Water Resources Board, the Will Rogers  
18 Memorial Commission, the Alcoholic Beverage Laws  
19 Enforcement Commission, the Department of  
20 Corrections, the Office of the State Fire Marshal,  
21 the Oklahoma State Bureau of Investigation, the  
22 Council on Law Enforcement Education and Training,  
23 the Board of Medicolegal Investigations, the Oklahoma  
24 State Bureau of Narcotics and Dangerous Drugs  
Control, the Department of Public Safety, the Office  
of the Attorney General, the Court of Criminal  
Appeals, district attorneys and the District  
Attorneys Council, the Supreme Court, the Oklahoma  
Indigent Defense System, the Pardon and Parole Board  
and the Workers' Compensation Court; stating amounts  
of the appropriations; stating purposes and  
restrictions; authorizing and requiring certain  
expenditures; authorizing and requiring certain  
transfers; requiring certain deposit; and providing  
an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

EDUCATION

SECTION 1. There is hereby appropriated to the State Board of  
Education from any monies not otherwise appropriated from the

1 General Revenue Fund of the State Treasury for the fiscal year  
2 ending June 30, 2013, the sum of \_\_\_\_\_ Dollars  
3 (\$\_\_\_\_\_.00) or so much thereof as may be necessary for the  
4 financial support of public schools.

5 SECTION 2. There is hereby appropriated to the State Board of  
6 Education from any monies not otherwise appropriated from the  
7 Education Reform Revolving Fund created in Section 34.89 of Title 62  
8 of the Oklahoma Statutes, the sum of \_\_\_\_\_ Dollars  
9 (\$\_\_\_\_\_.00) or so much thereof as may be necessary for the  
10 financial support of public schools.

11 SECTION 3. The State Board of Education is hereby authorized to  
12 expend during the fiscal year ending June 30, 2013, from the Common  
13 Education Technology Revolving Fund of the State Treasury, the sum  
14 of \_\_\_\_\_ Dollars (\$\_\_\_\_\_.00) or so  
15 much thereof as may be necessary for the financial support of public  
16 schools.

17 SECTION 4. There is hereby appropriated to the State Board of  
18 Education from any monies not otherwise appropriated from the  
19 Mineral Leasing Fund of the State Treasury for the fiscal year  
20 ending June 30, 2013, the sum of \_\_\_\_\_ Dollars  
21 (\$\_\_\_\_\_.00) or so much thereof as may be necessary for the  
22 financial support of public schools.

23 SECTION 5. There is hereby appropriated to the State Board of  
24 Education from any monies not otherwise appropriated from the

1 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
2 fiscal year ending June 30, 2013, the sum of \_\_\_\_\_  
3 Dollars (\$\_\_\_\_\_.00) or so much thereof as may be necessary  
4 for the financial support of public schools.

5 SECTION 6. There is hereby appropriated to the State Board of  
6 Education from any monies not otherwise appropriated from the  
7 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
8 fiscal year ending June 30, 2011, the sum of \_\_\_\_\_ Dollars  
9 (\$\_\_\_\_\_.00) or so much thereof as may be necessary for the  
10 financial support of public schools.

11 SECTION 7. There is hereby appropriated to the State Board of  
12 Education from any monies not otherwise appropriated from the  
13 General Revenue Fund of the State Treasury for the fiscal year  
14 ending June 30, 2013, the sum of \_\_\_\_\_ Dollars  
15 (\$\_\_\_\_\_.00) or so much thereof as may be necessary for the  
16 support of public schools activities.

17 SECTION 8. There is hereby appropriated to the State Board of  
18 Education from any monies not otherwise appropriated from the  
19 Special Cash Fund of the State Treasury the sum of \_\_\_\_\_  
20 Dollars (\$\_\_\_\_\_.00) or so much thereof as may be necessary for  
21 instructional expenses.

22 SECTION 9. There is hereby appropriated to the State Board of  
23 Education from any monies not otherwise appropriated from the  
24 General Revenue Fund of the State Treasury for the fiscal year

1 ending June 30, 2013, the sum of \_\_\_\_\_ Dollars  
2 (\$\_\_\_\_\_.00) or so much thereof as may be necessary for  
3 administrative and support functions of the State Department of  
4 Education.

5 SECTION 10. There is hereby appropriated to the State Board of  
6 Education from any monies not otherwise appropriated from the  
7 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
8 fiscal year ending June 30, 2013, the sum of \_\_\_\_\_  
9 Dollars (\$\_\_\_\_\_.00) or so much thereof as may be necessary for  
10 transfer to the School Consolidation Assistance Fund.

11 SECTION 11. There is hereby appropriated to the State Board of  
12 Education from any monies not otherwise appropriated from the  
13 Oklahoma Education Lottery Trust Fund of the State Treasury for the  
14 fiscal year ending June 30, 2011, the sum of \_\_\_\_\_  
15 Dollars (\$\_\_\_\_\_.00) or so much thereof as may be necessary for  
16 transfer to the School Consolidation Assistance Fund.

17 SECTION 12. There is hereby appropriated to the State Board of

13 upon the Oklahoma Arts Council by law.

14 SECTION 15. There is hereby appropriated to the State Board of  
15 Career and Technology Education from any monies not otherwise  
16 appropriated from the General Revenue Fund of the State Treasury for  
17 the fiscal year ending June 30, 2013, the sum of  
18 \_\_\_\_\_ Dollars (\$\_\_\_\_\_.00) or so much thereof  
19 as may be necessary to perform the duties imposed upon the State  
20 Board of Career and Technology Education by law.

21 SECTION 16. There is hereby appropriated to the State Board of  
22 Career and Technology Education from any monies not otherwise  
23 appropriated from the Oklahoma Education Lottery Trust Fund of the  
24 State Treasury for the fiscal year ending June 30, 2013, the sum of

15 Education for the education and general operating budgets of the  
16 institutions and for other programs, construction, renovations or  
17 repairs administered by the State Board of Career and Technology  
18 Education.

19 SECTION 18. There is hereby appropriated to the Commissioners  
20 of the Land Office from any monies not otherwise appropriated from  
21 the Commissioners of the Land Office Fund of the State Treasury for  
22 the fiscal year ending June 30, 2013, the sum of  
23 \_\_\_\_\_ Dollars (\$\_\_\_\_\_.00) or so much thereof as  
24

1 may be necessary to perform the duties imposed upon the  
2 Commissioners of the Land Office by law.

3 SECTION 19. There is hereby appropriated to the Oklahoma  
4 Educational Television Authority from any monies not otherwise  
5 appropriated from the General Revenue Fund of the State Treasury for  
6 the fiscal year ending June 30, 2013, the sum of  
7 \_\_\_\_\_ Dollars (\$\_\_\_\_\_.00) or so much  
8 thereof as may be necessary to perform the duties imposed upon the  
9 Oklahoma Educational Television Authority by law.

10 SECTION 20. There is hereby appropriated to the Oklahoma State  
11 Regents for Higher Education from any monies not otherwise  
12 appropriated from the General Revenue Fund of the State Treasury for  
13 the fiscal year ending June 30, 2013, the sum of  
14 \_\_\_\_\_ Dollars (\$\_\_\_\_\_.00) or so much thereof  
15 as may be necessary for allocation by the Oklahoma State Regents for  
16 Higher Education pursuant to the provisions of Article XIII-A of the  
17 Oklahoma Constitution for the education and general operating  
18 budgets of the institutions and for other programs, construction,  
19 renovations or repairs administered by the Oklahoma State Regents  
20 for Higher Education. Of those funds appropriated, the sum of

5 for allocation by the Oklahoma State Regents for Higher Education

7 Constitution for the education and general operating budgets of the  
8 institutions and for other programs, construction, renovations or  
9 repairs administered by the Oklahoma State Regents for Higher  
10 Education.

11 SECTION 22. The Oklahoma State Regents for Higher Education are  
12 hereby authorized to expend during the fiscal year ending June 30,  
13 2013, the sum of \_\_\_\_\_ Dollars  
14 (\$\_\_\_\_\_.00) from the Oklahoma Student Aid Revolving Fund of  
15 the State Treasury for allocation by the Oklahoma State Regents for  
16 Higher Education pursuant to the provisions of Article XIII-A of the  
17 Oklahoma Constitution for the education and general operating  
18 budgets of the institutions and for other programs, construction,  
19 renovations or repairs administered by the Oklahoma State Regents  
20 for Higher Education.

21 SECTION 23. There is hereby appropriated to the Oklahoma State  
22 Regents for Higher Education from any monies not otherwise  
23 appropriated from the Special Cash Fund of the State Treasury the  
24 sum of \_\_\_\_\_ Dollars (\$\_\_\_\_\_.00) for allocation by

1 the Oklahoma State Regents for Higher Education pursuant to the  
2 provisions of Article XIII-A of the Oklahoma Constitution for the  
3 education and general operating budgets of the institutions and for  
4 other programs, construction, renovations or repairs administered by  
5 the Oklahoma State Regents for Higher Education.

6 SECTION 24. There is hereby appropriated to the Oklahoma State  
7 Regents for Higher Education from any monies not otherwise  
8 appropriated from the proceeds of the sale of bonds deposited in the  
9 Oklahoma Building Bonds of 1992 Fund A in the State Treasury, the  
10 sum of \_\_\_\_\_ Dollars (\$\_\_\_\_\_.00) or so much thereof  
11 as may be necessary for allocation by the Oklahoma State Regents for  
12 Higher Education pursuant to the provisions of Article XIII-A of the  
13 Oklahoma Constitution for the education and general operating  
14 budgets of the institutions and for other programs, construction,  
15 renovations or repairs administered by the Oklahoma State Regents  
16 for Higher Education.

17 SECTION 25. There is hereby appropriated to the Oklahoma State  
18 Regents for Higher Education from any monies not otherwise  
19 appropriated from the proceeds of the sale of bonds deposited in the  
20 Oklahoma Building Bonds of 1992 Fund B in the State Treasury, the  
21 sum of \_\_\_\_\_ Dollars (\$\_\_\_\_\_.00) or so much thereof as may be  
22 necessary for allocation by the Oklahoma State Regents for Higher  
23 Education pursuant to the provisions of Article XIII-A of the  
24 Oklahoma Constitution for the education and general operating

1 budgets of the institutions and for other programs, construction,  
2 renovations or repairs administered by the Oklahoma State Regents  
3 for Higher Education.

4 SECTION 26. There is hereby appropriated to the Oklahoma State  
5 Regents for Higher Education from any monies not otherwise  
6 appropriated from the General Revenue Fund of the State Treasury for  
7 the fiscal year ending June 30, 2013, the sum of  
8 \_\_\_\_\_ Dollars (\$\_\_\_\_\_.00) or so much thereof as  
9 may be necessary for expenditures for concurrent enrollment pursuant  
10 to Section 628.13 of Title 70 of the Oklahoma Statutes.

11 SECTION 27. There is hereby appropriated to the Oklahoma State  
12 Regents for Higher Education from any monies not otherwise  
13 appropriated from the Oklahoma Education Lottery Trust Fund of the  
14 State Treasury for the fiscal year ending June 30, 2013, the sum of  
15 \_\_\_\_\_ Dollars (\$\_\_\_\_\_.00) pursuant to  
16 paragraph 2 of subsection C of Section 713 of Title 3A of the  
17 Oklahoma Statutes for allocation by the Oklahoma State Regents for  
18 Higher Education pursuant to the provisions of Article XIII-A of the  
19 Oklahoma Constitution for construction, renovations or repairs  
20 administered by the Oklahoma State Regents for Higher Education or

21 appropriated from the General Revenue Fund of the State Treasury for  
22 the fiscal year ending June 30, 2013, the sum of  
23 \_\_\_\_\_ Dollars (\$\_\_\_\_\_.00) or so much thereof as

1 may be necessary for the Office of Accountability to perform the  
2 duties imposed upon the Office of Accountability by law.

3 SECTION 31. There is hereby appropriated to the Oklahoma  
4 Department of Libraries from any monies not otherwise appropriated  
5 from the General Revenue Fund of the State Treasury for the fiscal  
6 year ending June 30, 2013, the sum of \_\_\_\_\_

2 hereby authorized to expend during the fiscal year ending June 30,  
3 2013, from the Oklahoma Board of Private Vocational Schools  
4 Revolving Fund of the State Treasury, the sum of  
5 \_\_\_\_\_ Dollars (\$\_\_\_\_\_.00) or so much  
6 thereof as may be necessary to perform the duties imposed upon the  
7 Oklahoma Board of Private Vocational Schools by law.

8 SECTION 35. There is hereby appropriated to the Board of  
9 Trustees of the Oklahoma School of Science and Mathematics from any  
10 monies not otherwise appropriated from the General Revenue Fund of  
11 the State Treasury for the fiscal year ending June 30, 2013, the sum  
12 of \_\_\_\_\_ Dollars (\$\_\_\_\_\_.00) or so  
13 much thereof as may be necessary to perform the duties imposed upon  
14 the Board of Trustees of the Oklahoma School of Science and  
15 Mathematics by law.

16 SECTION 36. There is hereby appropriated to the Oklahoma Center  
17 for the Advancement of Science and Technology from any monies not  
18 otherwise appropriated from the General Revenue Fund of the State  
19 Treasury for the fiscal year ending June 30, 2013, the sum of  
20 \_\_\_\_\_ Dollars (\$\_\_\_\_\_.00) or so  
21 much thereof as may be necessary to perform the duties imposed upon  
22 the Oklahoma Center for the Advancement of Science and Technology by  
23 law. Of those funds appropriated, the sum of  
24 \_\_\_\_\_ Dollars (\$\_\_\_\_\_.00) shall be deposited

1 in the Research Support Revolving Fund created pursuant to Section  
2 5060.11 of Title 74 of the Oklahoma Statutes.

3 SECTION 37. There is hereby appropriated to the Oklahoma  
4 Commission for Teacher Preparation from any monies not otherwise  
5 appropriated from the General Revenue Fund of the State Treasury for  
6 the fiscal year ending June 30, 2013, the sum of  
7 \_\_\_\_\_ Dollars (\$\_\_\_\_\_.00) or so much thereof  
8 as may be necessary to perform the duties imposed upon the Oklahoma  
9 Commission for Teacher Preparation by law.

10 GENERAL GOVERNMENT AND TRANSPORTATION

11 SECTION 38. There is hereby appropriated to the Office of the  
12 State Auditor and Inspector from any monies not otherwise  
13 appropriated from the General Revenue Fund of the State Treasury for  
14 the fiscal year ending June 30, 2013, the sum of \_\_\_\_\_  
15 Dollars (\$\_\_\_\_\_.00) or so much thereof as may be necessary to  
16 perform the duties imposed upon the Office of the State Auditor and  
17 Inspector by law.

18 SECTION 39. There is hereby appropriated to the Office of the  
19 State Auditor and Inspector from any monies not otherwise  
20 appropriated from the General Revenue Fund of the State Treasury for  
21 the fiscal year ending June 30, 2013, the sum of  
22 \_\_\_\_\_ Dollars (\$\_\_\_\_\_.00) or so much thereof  
23 as may be necessary to perform the duties imposed upon the  
24 Commission on County Government Personnel Education and Training.

1 The appropriation made in this section shall be expended exclusively  
2 for the purpose so stated and shall not be transferable.

3 SECTION 40. There is hereby appropriated to the Office of the  
4 State Bond Advisor from any monies not otherwise appropriated from  
5 the General Revenue Fund of the State Treasury for the fiscal year  
6 ending June 30, 2013, the sum of \_\_\_\_\_ Dollars  
7 (\$\_\_\_\_\_.00) or so much thereof as may be necessary to perform  
8 the duties imposed upon the Office of the State Bond Advisor by law.

9 SECTION 41. There is hereby appropriated to the State Election  
10 Board from any monies not otherwise appropriated from the General  
11 Revenue Fund of the State Treasury for the fiscal year ending June  
12 30, 2013, the sum of \_\_\_\_\_ Dollars (\$\_\_\_\_\_.00)  
13 or so much thereof as may be necessary to perform the duties imposed  
14 upon the State Election Board by law.

15 SECTION 42. There is hereby appropriated to the State Election  
16 Board from any monies not otherwise appropriated from the General  
17 Revenue Fund of the State Treasury for the fiscal year ending June  
18 30, 2012, the sum of \_\_\_\_\_ Dollars (\$\_\_\_\_\_.00)  
19 or so much thereof as may be necessary to perform the duties imposed  
20 upon the State Election Board by law.

21 SECTION 43. There is hereby appropriated to the Oklahoma
