6 AS INTRODUCED

7 An Act relating to court clerk fees; amending 22 O.S.
8 2001, Sections 456A and 966A, which relate to fees
9 for the issuance of bench warrants; increasing
10 certain fee; modifying deposit of certain fee;
11 amending 28 O.S. 2001, Section 152A, which relates to
12 fees for civil warrants, body attachments, or bench
13 warrants; increasing certain fee; modifying deposit
14 of certain fee; and providing an effective date.

15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. AMENDATORY 22 O.S. 2001, Section 456A, is
17 amended to read as follows:

18 Section 456A. A. For the issuance of each bench warrant for a
19 defendant's failure to pay court costs, fines, fees, or assessments
20 in felony, misdemeanor, or traffic cases, the court clerk shall
21 charge and collect a fee of ~~Five Dollars (\$5.00)~~ Fifteen Dollars
22 (\$15.00).

23 B. The fee shall be included in the execution bond amount on
24 the face of the bench warrant which is issued for the defendant's
failure to pay and shall be in addition to the delinquent amount
owed by the defendant. ~~This~~

1 C. Ten Dollars (\$10.00) of the fee shall be deposited in the
2 court clerk's revolving fund pursuant to the provisions of Section
3 220 of Title 19 of the Oklahoma Statutes and Five Dollars (\$5.00) of
4 the fee shall be deposited to the general fund of the county.

5 SECTION 2. AMENDATORY 22 O.S. 2001, Section 966A, is
6 amended to read as follows:

7 Section 966A. A. For the issuance of each bench warrant for a
8 defendant's failure to pay court costs, fines, fees, or assessments
9 in felony, misdemeanor, or traffic cases, the court clerk shall
10 charge and collect a fee of ~~Five Dollars (\$5.00)~~ Fifteen Dollars
11 (\$15.00).

12 B. The fee shall be included in the execution bond amount on
13 the face of the bench warrant which is issued for the defendant's
14 failure to pay and shall be in addition to the delinquent amount
15 owed by the defendant. ~~This~~

16 C. Ten Dollars (\$10.00) of the fee shall be deposited in the
17 court clerk's revolving fund pursuant to the provisions of Section
18 220 of Title 19 of the Oklahoma Statutes and Five Dollars (\$5.00) of
19 the fee shall be deposited to the general fund of the county.

20 SECTION 3. AMENDATORY 28 O.S. 2001, Section 152A, is
21 amended to read as follows:

22 Section 152A. A. For the issuance of each civil warrant, body
23 attachment, or bench warrant requiring the arrest of a party to an
24 action for failure to pay court costs, fines, fees, or assessments,

1 the court clerk shall charge and collect a fee of ~~Five Dollars~~
2 ~~(\$5.00)~~ Fifteen Dollars (\$15.00).

3 B. The fee shall be included in the execution bond amount on
4 the face of the civil warrant, body attachment, or bench warrant
5 which is issued for the defendant's failure to pay and shall be in
6 addition to the delinquent amount owed by the defendant. ~~This~~

7 C. Ten Dollars (\$10.00) of the fee shall be deposited in the
8 court clerk's revolving fund pursuant to the provisions of Section
9 220 of Title 19 of the Oklahoma Statutes and Five Dollars (\$5.00) of
10 the fee shall be deposited to the general fund of the county.

11 SECTION 4. This act shall become effective November 1, 2011.
