8 AS INTRODUCED

9 A Concurrent Resolution congratulating Miss Devin  
10 Kerns upon her selection as the Distinguished Young  
11 Woman of Oklahoma for 2011; wishing her the best for  
12 further competition; and directing distribution.

13 WHEREAS, the Distinguished Young Women of Oklahoma Scholarship  
14 Program is held annually to honor the best and brightest high school  
15 senior girls in Oklahoma. This statewide program recognizes,  
16 rewards, and encourages outstanding young women who have  
17 distinguished themselves at school and in their communities. The  
18 Distinguished Young Women of Oklahoma Scholarship Program selection  
19 for 2011 occurred on Saturday, July 24, 2010, at the Bartlesville  
20 Community Center, with six high school senior young women competing  
21 from across Oklahoma; and

22 WHEREAS, Miss Devin Kerns, daughter of Jeff and Susan Kerns of  
23 Stillwater, was selected as the Distinguished Young Woman of  
24 Oklahoma for 2011, winning the Scholastics Award, and was awarded a  
total of \$1300 in college scholarships; and

1       WHEREAS, while holding the title of Distinguished Young Woman of  
2 Oklahoma for 2011, Miss Kerns will be involved in community service,  
3 speaking and performing engagements across the state of Oklahoma,  
4 and presenting her "Be Your Best Self" message of Self-Confidence  
5 and Commitment to Oklahoma's school children, encouraging young  
6 people to: Be Involved, Be Studious, Be Healthy, Be Ambitious, and  
7 Be Responsible; and

8       WHEREAS, Miss Kerns will represent Oklahoma in the 54th annual  
9 Distinguished Young Woman of America program to be held June 23-25,  
10 2011, in Mobile, Alabama, and will compete for a share of \$75,000 in  
11 college scholarships.

12       NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE 1ST SESSION  
13 OF THE 53RD OKLAHOMA LEGISLATURE, THE HOUSE OF REPRESENTATIVES  
14 CONCURRING THEREIN:
