7 AS INTRODUCED

8 A Concurrent Resolution relating to the master lease
9 program; disapproving one capital project submitted
10 by the Oklahoma State Regents for Higher Education
11 for legislative review; and directing distribution.

13 WHEREAS, Section 3206.6a of Title 70 of the Oklahoma Statutes
14 authorizes the Oklahoma State Regents for Higher Education to
15 finance acquisition of or improvements to, or refinance or
16 restructure outstanding obligations for real property pursuant to
17 the master lease program established by the Legislature in Section
18 3206.6 of Title 70 of the Oklahoma Statutes; and

19 WHEREAS, Section 3206.6a of Title 70 of the Oklahoma Statutes
20 requires the Oklahoma State Regents for Higher Education to submit
21 an itemized list of the proposed projects and the terms of the
22 financing to the Governor, the Speaker of the House of
23 Representatives and the President Pro Tempore of the Senate within

1 the first seven (7) legislative days of an annual legislative
2 session and prior to the time any such obligations are sold; and

3 WHEREAS, Section 3206.6a of Title 70 of the Oklahoma Statutes
4 provides that the Legislature shall have a period of forty-five (45)
5 calendar days from the date on which the information is submitted to
6 pass a concurrent resolution disapproving all or part of the
7 proposed issuance; and

8 WHEREAS, the Oklahoma State Regents for Higher Education
9 submitted an itemized list of thirty-three proposed capital projects
10 from fourteen state institutions and the terms of the financing for
11 review to the Governor, the Speaker of the House of Representatives
12 and the President Pro Tempore of the Senate; and

13 WHEREAS, said list was received by all parties on February 6,
14 2012.

15 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE 2ND SESSION
16 OF THE 53RD OKLAHOMA LEGISLATURE, THE HOUSE OF REPRESENTATIVES
17 CONCURRING THEREIN:

18 THAT, pursuant to the authority provided in Section 3206.6a of
19 Title 70 of the Oklahoma Statutes, the Legislature hereby
20 disapproves the Medical Examiner's Facility Project proposed by the
21 University of Central Oklahoma which appears on the list submitted
22 by the Oklahoma State Regents for Higher Education.

23 THAT the Secretary of State is hereby directed to distribute
24 copies of this resolution to the Chancellor of the Oklahoma State

1 System of Higher Education and to the Oklahoma State Regents for
2 Higher Education.
