AS INTRODUCED

An Act relating to general appropriations for the expenses of various agencies of the executive, legislative and judicial departments of the state; making appropriations to the State Board of Education, the Oklahoma Arts Council, the State Board of Career and Technology Education, the Commissioners of the Land Office, the Oklahoma Educational Television Authority, the Oklahoma State Regents for Higher Education, the Oklahoma Department of Libraries, the Physician Manpower Training Commission, the Oklahoma Board of Private Vocational Schools, the Board of Trustees of the Oklahoma School of Science and Mathematics, the Oklahoma Center for the Advancement of Science and Technology, the Oklahoma Commission for Teacher Preparation, the Office of the State Auditor and Inspector, the Office of the State Bond Advisor, the Department of Central Services, the State Election Board, the Oklahoma Department of Emergency Management, the Ethics Commission, the Office of State Finance, the Office of the Governor, the Oklahoma House of Representatives, the Legislative Service Bureau, the Office of the Lieutenant Governor, the Oklahoma Merit Protection Commission, the Military Department of the State of Oklahoma, the Office of Personnel Management, the Office of the Secretary of State, the Oklahoma State Senate, the Oklahoma Space Industry Development Authority, the Oklahoma Tax Commission,

2 Transportation, the State Department of Health, the
3 Oklahoma Health Care Authority, the J.D. McCarty
4 Center for Children with Developmental Disabilities,
5 the Department of Mental Health and Substance Abuse
6 Services, the University Hospitals Authority, the
7 Oklahoma Department of Veterans Affairs, the Oklahoma
8 Commission on Children and Youth, the Office of
9 Disability Concerns, the Department of Human
10 Services, the Oklahoma Indian Affairs Commission, the
11 Office of Juvenile Affairs, the State Department of
12 Rehabilitation Services, the Oklahoma Department of
13 Agriculture, Food, and Forestry, the Oklahoma
14 Department of Commerce, the Rural Economic Action
15 Plan Fund, the Oklahoma Conservation Commission, the
16 Department of Consumer Credit, the Corporation
17 Commission, the Department of Environmental Quality,
18 the Oklahoma Historical Society, the Oklahoma Horse
19 Racing Commission, the Insurance Department, the J.M.
20 Davis Memorial Commission, the Department of Labor,
21 the Department of Mines, the Scenic Rivers
22 Commission, the Oklahoma Tourism and Recreation
23 Department, the Oklahoma Water Resources Board, the
24 Will Rogers Memorial Commission, the Alcoholic
Beverage Laws Enforcement Commission, the Department
of Corrections, the Office of the State Fire Marshal,
the Oklahoma State Bureau of Investigation, the
Council on Law Enforcement Education and Training,
the Board of Medicolegal Investigations, the Oklahoma
State Bureau of Narcotics and Dangerous Drugs
Control, the Department of Public Safety, the Office
of the Attorney General, the Court of Criminal
Appeals, district attorneys and the District
Attorneys Council, the Supreme Court, the Oklahoma
Indigent Defense System, the Council on Judicial
Complaints, the Pardon and Parole Board and the
Workers' Compensation Court; stating amounts of the
appropriations; stating purposes and restrictions;
authorizing and requiring certain expenditures;
authorizing and requiring certain transfers;
requiring certain deposit; and providing an effective
date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

1 EDUCATION

2 SECTION 1. There is hereby appropriated to the State Board of
3 Education from any monies not otherwise appropriated from the
4 General Revenue Fund of the State Treasury for the fiscal year
5 ending June 30, 2012, the sum of One Billion One Hundred Million Six
6 Hundred Forty Thousand Five Hundred Seventy-one Dollars
7 (\$1,100,640,571.00) or so much thereof as may be necessary for the
8 financial support of public schools.

9 SECTION 2. There is hereby appropriated to the State Board of
10 Education from any monies not otherwise appropriated from the
11 Education Reform Revolving Fund created in Section 34.89 of Title 62
12 of the Oklahoma Statutes, the sum of Six Hundred Thirty-four Million
13 Eight Hundred Ninety-four Thousand Five Hundred Sixty-nine Dollars
14 (\$634,894,569.00) or so much thereof as may be necessary for the
15 financial support of public schools.

16 SECTION 3. The State Board of Education is hereby authorized to
17 expend during the fiscal year ending June 30, 2012, from the Common
18 Education Technology Revolving Fund of the State Treasury, the sum
19 of Forty-seven Million Three Hundred Seventy-two Thousand Two
20 Hundred Ninety-nine Dollars (\$47,372,299.00) or so much thereof as
21 may be necessary for the financial support of public schools.

22 SECTION 4. There is hereby appropriated to the State Board of
23 Education from any monies not otherwise appropriated from the
24 Mineral Leasing Fund of the State Treasury for the fiscal year

1 ending June 30, 2012, the sum of Two Million Eight Hundred Fifty
2 Thousand Dollars (\$2,850,000.00) or so much thereof as may be
3 necessary for the financial support of public schools.

4 SECTION 5. There is hereby appropriated to the State Board of
5 Education from any monies not otherwise appropriated from the
6 Oklahoma Education Lottery Trust Fund of the State Treasury for the
7 fiscal year ending June 30, 2012, the sum of Twenty-five Million
8 Nine Hundred Thousand Nine Hundred Eighty-five Dollars
9 (\$25,900,985.00) or so much thereof as may be necessary for the
10 financial support of public schools.

11 SECTION 6. There is hereby appropriated to the State Board of
12 Education from any monies not otherwise appropriated from the
13 Oklahoma Education Lottery Trust Fund of the State Treasury for the
14 fiscal year ending June 30, 2010, the sum of Two Million Nine
15 Hundred Sixty-nine Thousand Eight Hundred Four Dollars
16 (\$2,969,804.00) or so much thereof as may be necessary for the
17 financial support of public schools.

18 SECTION 7. There is hereby appropriated to the State Board of
19 Education from any monies not otherwise appropriated from the
20 General Revenue Fund of the State Treasury for the fiscal year
21 ending June 30, 2012, the sum of Four Hundred One Million Two
22 Hundred Twenty-four Thousand Six Hundred Fifty-five Dollars
23 (\$401,224,655.00) or so much thereof as may be necessary for the
24 support of public schools activities.

1 SECTION 8. There is hereby appropriated to the State Board of
2 Education from any monies not otherwise appropriated from the
3 Special Cash Fund of the State Treasury the sum of Thirty-three
4 Million Dollars (\$33,000,000.00) or so much thereof as may be
5 necessary for instructional expenses.

6 SECTION 9. There is hereby appropriated to the State Board of
7 Education from any monies not otherwise appropriated from the
8 General Revenue Fund of the State Treasury for the fiscal year
9 ending June 30, 2012, the sum of Twenty-one Million Four Hundred
10 Twenty-six Thousand Six Hundred Forty-two Dollars (\$21,426,642.00)
11 or so much thereof as may be necessary for administrative and
12 support functions of the State Department of Education.

13 SECTION 10. There is hereby appropriated to the State Board of
14 Education from any monies not otherwise appropriated from the
15 Oklahoma Education Lottery Trust Fund of the State Treasury for the
16 fiscal year ending June 30, 2012, the sum of Two Million Eight
17 Hundred Seventy-seven Thousand Eight Hundred Eighty-seven Dollars
18 (\$2,877,887.00) or so much thereof as may be necessary for transfer
19 to the School Consolidation Assistance Fund.

20 SECTION 11. There is hereby appropriated to the State Board of
21 Education from any monies not otherwise appropriated from the
22 Oklahoma Education Lottery Trust Fund of the State Treasury for the
23 fiscal year ending June 30, 2010, the sum of Three Hundred Twenty-
24 nine Thousand Nine Hundred Seventy-eight Dollars (\$329,978.00) or so

1 much thereof as may be necessary for transfer to the School
2 Consolidation Assistance Fund.

3 SECTION 12. There is hereby appropriated to the State Board of
4 Education from any monies not otherwise appropriated from the
5 Oklahoma Education Lottery Trust Fund of the State Treasury for the
6 fiscal year ending June 30, 2012, the sum of Two Million Eight
7 Hundred Seventy-seven Thousand Eight Hundred Eighty-seven Dollars
8 (\$2,877,887.00) or so much thereof as may be necessary for transfer
9 to the Teachers' Retirement System Dedicated Revenue Revolving Fund.

10 SECTION 13. There is hereby appropriated to the State Board of
11 Education from any monies not otherwise appropriated from the
12 Oklahoma Education Lottery Trust Fund of the State Treasury for the
13 fiscal year ending June 30, 2010, the sum of Three Hundred Twenty-
14 nine Thousand Nine Hundred Seventy-eight Dollars (\$329,978.00) or so
15 much thereof as may be necessary for transfer to the Teachers'
16 Retirement System Dedicated Revenue Revolving Fund.

17 SECTION 14. There is hereby appropriated to the Oklahoma Arts
18 Council from any monies not otherwise appropriated from the General
19 Revenue Fund of the State Treasury for the fiscal year ending June
20 30, 2012, the sum of Four Million Ten Thousand Eighty-seven Dollars
21 (\$4,010,087.00) or so much thereof as may be necessary to perform
22 the duties imposed upon the Oklahoma Arts Council by law.

23 SECTION 15. There is hereby appropriated to the State Board of
24 Career and Technology Education from any monies not otherwise

1 appropriated from the General Revenue Fund of the State Treasury for
2 the fiscal year ending June 30, 2012, the sum of One Hundred Thirty
3 Million Two Hundred Thirteen Thousand Nine Hundred Sixty-six Dollars
4 (\$130,213,966.00) or so much thereof as may be necessary to perform
5 the duties imposed upon the State Board of Career and Technology
6 Education by law.

7 SECTION 16. There is hereby appropriated to the State Board of
8 Career and Technology Education from any monies not otherwise
9 appropriated from the Oklahoma Education Lottery Trust Fund of the
10 State Treasury for the fiscal year ending June 30, 2012, the sum of
11 Three Million One Hundred Sixty-five Thousand Six Hundred Seventy-
12 six Dollars (\$3,165,676.00) pursuant to paragraph 2 of subsection C
13 of Section 713 of Title 3A of the Oklahoma Statutes for allocation
14 by the State Board of Career and Technology Education for the
15 education and general operating budgets of the institutions and for
16 other programs, construction, renovations or repairs administered by
17 the State Board of Career and Technology Education.

18 SECTION 17. There is hereby appropriated to the State Board of
19 Career and Technology Education from any monies not otherwise
20 appropriated from the Oklahoma Education Lottery Trust Fund of the
21 State Treasury for the fiscal year ending June 30, 2010, the sum of
22 Three Hundred Sixty-two Thousand Nine Hundred Seventy-six Dollars
23 (\$362,976.00) pursuant to paragraph 2 of subsection C of Section 713
24 of Title 3A of the Oklahoma Statutes for allocation by the State

1 Board of Career and Technology Education for the education and
2 general operating budgets of the institutions and for other
3 programs, construction, renovations or repairs administered by the
4 State Board of Career and Technology Education.

5 SECTION 18. There is hereby appropriated to the Commissioners
6 of the Land Office from any monies not otherwise appropriated from
7 the Commissioners of the Land Office Fund of the State Treasury for
8 the fiscal year ending June 30, 2012, the sum of Seven Million One
9 Hundred-nine Thousand Dollars (\$7,109,000.00) or so much thereof as
10 may be necessary to perform the duties imposed upon the
11 Commissioners of the Land Office by law.

12 SECTION 19. There is hereby appropriated to the Oklahoma
13 Educational Television Authority from any monies not otherwise
14 appropriated from the General Revenue Fund of the State Treasury for
15 the fiscal year ending June 30, 2012, the sum of Three Million Eight
16 Hundred Twenty-two Thousand Three Hundred Twenty-eight Dollars
17 (\$3,822,328.00) or so much thereof as may be necessary to perform
18 the duties imposed upon the Oklahoma Educational Television
19 Authority by law.

20 SECTION 20. There is hereby appropriated to the Oklahoma State
21 Regents for Higher Education from any monies not otherwise
22 appropriated from the General Revenue Fund of the State Treasury for
23 the fiscal year ending June 30, 2012, the sum of Seven Hundred
24 Fifty-three Million Three Hundred Seventy-five Thousand Three

1 Hundred Two Dollars (\$753,375,302.00) or so much thereof as may be
2 necessary for allocation by the Oklahoma State Regents for Higher
3 Education pursuant to the provisions of Article XIII-A of the
4 Oklahoma Constitution for the education and general operating
5 budgets of the institutions and for other programs, construction,
6 renovations or repairs administered by the Oklahoma State Regents
7 for Higher Education. Of those funds appropriated, the sum of Three
8 Million Eight Hundred Thirty Thousand Thirty-eight Dollars
9 (\$3,830,038.00) shall be transferred to the Oklahoma Tuition
10 Equalization Grant Trust Fund to implement the provisions of the
11 Oklahoma Tuition Equalization Grant Act.

12 SECTION 21. The Oklahoma State Regents for Higher Education are
13 hereby authorized to expend during the fiscal year ending June 30,
14 2012, the sum of Forty-seven Million Three Hundred Seventy-two
15 Thousand Two Hundred Ninety-nine Dollars (\$47,372,299.00) from the
16 Higher Education Capital Revolving Fund of the State Treasury for
17 allocation by the Oklahoma State Regents for Higher Education
18 pursuant to the provisions of Article XIII-A of the Oklahoma
19 Constitution for the education and general operating budgets of the
20 institutions and for other programs, construction, renovations or
21 repairs administered by the Oklahoma State Regents for Higher
22 Education.

23 SECTION 22. The Oklahoma State Regents for Higher Education are
24 hereby authorized to expend during the fiscal year ending June 30,

1 2012, the sum of Forty-seven Million Three Hundred Seventy-two
2 Thousand Two Hundred Ninety-nine Dollars (\$47,372,299.00) from the
3 Oklahoma Student Aid Revolving Fund of the State Treasury for
4 allocation by the Oklahoma State Regents for Higher Education
5 pursuant to the provisions of Article XIII-A of the Oklahoma
6 Constitution for the education and general operating budgets of the
7 institutions and for other programs, construction, renovations or
8 repairs administered by the Oklahoma State Regents for Higher
9 Education.

10 SECTION 23. There is hereby appropriated to the Oklahoma State
11 Regents for Higher Education from any monies not otherwise
12 appropriated from the Special Cash Fund of the State Treasury the
13 sum of Sixty-five Million Dollars (\$65,000,000.00) for allocation by
14 the Oklahoma State Regents for Higher Education pursuant to the
15 provisions of Article XIII-A of the Oklahoma Constitution for the
16 education and general operating budgets of the institutions and for
17 other programs, construction, renovations or repairs administered by
18 the Oklahoma State Regents for Higher Education.

19 SECTION 24. There is hereby appropriated to the Oklahoma State
20 Regents for Higher Education from any monies not otherwise
21 appropriated from the proceeds of the sale of bonds deposited in the
22 Oklahoma Building Bonds of 1992 Fund A in the State Treasury, the
23 sum of One Hundred Seventy-four Dollars (\$174.00) or so much thereof
24 as may be necessary for allocation by the Oklahoma State Regents for

1 Higher Education pursuant to the provisions of Article XIII-A of the
2 Oklahoma Constitution for the education and general operating
3 budgets of the institutions and for other programs, construction,
4 renovations or repairs administered by the Oklahoma State Regents
5 for Higher Education.

6 SECTION 25. There is hereby appropriated to the Oklahoma State
7 Regents for Higher Education from any monies not otherwise
8 appropriated from the proceeds of the sale of bonds deposited in the
9 Oklahoma Building Bonds of 1992 Fund B in the State Treasury, the
10 sum of Seventy-one Dollars (\$71.00) or so much thereof as may be
11 necessary for allocation by the Oklahoma State Regents for Higher
12 Education pursuant to the provisions of Article XIII-A of the
13 Oklahoma Constitution for the education and general operating
14 budgets of the institutions and for other programs, construction,
15 renovations or repairs administered by the Oklahoma State Regents
16 for Higher Education.

17 SECTION 26. There is hereby appropriated to the Oklahoma State
18 Regents for Higher Education from any monies not otherwise
19 appropriated from the General Revenue Fund of the State Treasury for
20 the fiscal year ending June 30, 2012, the sum of One Million Two
21 Hundred Thirty-four Thousand One Hundred Seventy-four Dollars
22 (\$1,234,174.00) or so much thereof as may be necessary for
23 expenditures for concurrent enrollment pursuant to Section 628.13 of
24 Title 70 of the Oklahoma Statutes.

1 SECTION 27. There is hereby appropriated to the Oklahoma State
2 Regents for Higher Education from any monies not otherwise
3 appropriated from the Oklahoma Education Lottery Trust Fund of the
4 State Treasury for the fiscal year ending June 30, 2012, the sum of
5 Twenty-two Million Seven Hundred Thirty-five Thousand Three Hundred
6 Nine Dollars (\$22,735,309.00) pursuant to paragraph 2 of subsection
7 C of Section 713 of Title 3A of the Oklahoma Statutes for allocation
8 by the Oklahoma State Regents for Higher Education pursuant to the
9 provisions of Article XIII-A of the Oklahoma Constitution for
10 construction, renovations or repairs administered by the Oklahoma
11 State Regents for Higher Education or for any other purpose
12 authorized by paragraph 2 of subsection C of Section 713 of Title 3A
13 of the Oklahoma Statutes.

14 SECTION 28. There is hereby appropriated to the Oklahoma State
15 Regents for Higher Education from any monies not otherwise
16 appropriated from the Oklahoma Education Lottery Trust Fund of the
17 State Treasury for the fiscal year ending June 30, 2010, the sum of
18 Two Million Six Hundred Six Thousand Eight Hundred Twenty-eight
19 Dollars (\$2,606,828.00) pursuant to paragraph 2 of subsection C of
20 Section 713 of Title 3A of the Oklahoma Statutes for allocation by
21 the Oklahoma State Regents for Higher Education pursuant to the
22 provisions of Article XIII-A of the Oklahoma Constitution for
23 construction, renovations or repairs administered by the Oklahoma
24 State Regents for Higher Education or for any other purpose

1 authorized by paragraph 2 of subsection C of Section 713 of Title 3A
2 of the Oklahoma Statutes.

3 SECTION 29. There is hereby appropriated to the Oklahoma State
4 Regents for Higher Education from any monies not otherwise
5 appropriated from the General Revenue Fund of the State Treasury for
6 the fiscal year ending June 30, 2012, the sum of Four Million Nine
7 Hundred Two Thousand Five Hundred Fifty Dollars (\$4,902,550.00) or
8 so much thereof as may be necessary for the general operating budget
9 of the Administrative Offices of the Oklahoma State Regents for
10 Higher Education.

11 SECTION 30. There is hereby appropriated to the Oklahoma State
12 Regents for Higher Education from any monies not otherwise
13 appropriated from the General Revenue Fund of the State Treasury for
14 the fiscal year ending June 30, 2012, the sum of Six Hundred Sixty-
15 one Thousand Two Hundred Seventy-one Dollars (\$661,271.00) or so
16 much thereof as may be necessary for the Office of Accountability to
17 perform the duties imposed upon the Office of Accountability by law.

18 SECTION 31. There is hereby appropriated to the Oklahoma
19 Department of Libraries from any monies not otherwise appropriated
20 from the General Revenue Fund of the State Treasury for the fiscal
21 year ending June 30, 2012, the sum of Five Million Eight Hundred
22 Ninety-eight Thousand Six Hundred Thirty-three Dollars
23 (\$5,898,633.00) or so much thereof as may be necessary to perform
24 the duties imposed upon the Oklahoma Department of Libraries by law.

1 SECTION 32. There is hereby appropriated to the Physician
2 Manpower Training Commission from any monies not otherwise
3 appropriated from the General Revenue Fund of the State Treasury for
4 the fiscal year ending June 30, 2012, the sum of Three Million Nine
5 Hundred Seventy-nine Thousand Two Hundred Fifty-four Dollars
6 (\$3,979,254.00) or so much thereof as may be necessary to perform
7 the duties imposed upon the Physician Manpower Training Commission
8 by law.

9 SECTION 33. There is hereby appropriated to the Physician
10 Manpower Training Commission from any monies not otherwise
11 appropriated from the General Revenue Fund of the State Treasury for
12 the fiscal year ending June 30, 2011, the sum of Four Hundred
13 Thousand Dollars (\$400,000.00) or so much thereof as may be
14 necessary to perform the duties imposed upon the Physician Manpower
15 Training Commission by law.

16 SECTION 34. The Oklahoma Board of Private Vocational Schools is
17 hereby authorized to expend during the fiscal year ending June 30,
18 2012, from the Oklahoma Board of Private Vocational Schools
19 Revolving Fund of the State Treasury, the sum of One Hundred Sixty-
20 seven Thousand One Hundred Ninety-four Dollars (\$167,194.00) or so
21 much thereof as may be necessary to perform the duties imposed upon
22 the Oklahoma Board of Private Vocational Schools by law.

23 SECTION 35. There is hereby appropriated to the Board of
24 Trustees of the Oklahoma School of Science and Mathematics from any

1 monies not otherwise appropriated from the General Revenue Fund of
2 the State Treasury for the fiscal year ending June 30, 2012, the sum
3 of Six Million Eighty-two Thousand Two Hundred Seventy-four Dollars
4 (\$6,082,274.00) or so much thereof as may be necessary to perform
5 the duties imposed upon the Board of Trustees of the Oklahoma School
6 of Science and Mathematics by law.

7 SECTION 36. There is hereby appropriated to the Oklahoma Center
8 for the Advancement of Science and Technology from any monies not
9 otherwise appropriated from the General Revenue Fund of the State
10 Treasury for the fiscal year ending June 30, 2012, the sum of
11 Seventeen Million Eight Hundred Eleven Thousand Four Hundred Forty-
12 nine Dollars (\$17,811,449.00) or so much thereof as may be necessary
13 to perform the duties imposed upon the Oklahoma Center for the
14 Advancement of Science and Technology by law. Of those funds
15 appropriated, the sum of Seventeen Million One Hundred Twenty-four
16 Thousand One Hundred Nine Dollars (\$17,124,109.00) shall be
17 deposited in the Research Support Revolving Fund created pursuant to
18 Section 5060.11 of Title 74 of the Oklahoma Statutes.

19 SECTION 37. There is hereby appropriated to the Oklahoma
20 Commission for Teacher Preparation from any monies not otherwise
21 appropriated from the General Revenue Fund of the State Treasury for
22 the fiscal year ending June 30, 2012, the sum of One Million Five
23 Hundred Twenty-six Thousand One Hundred Seventy-nine Dollars
24 (\$1,526,179.00) or so much thereof as may be necessary to perform

1 the duties imposed upon the Oklahoma Commission for Teacher
2 Preparation by law.

3 GENERAL GOVERNMENT AND TRANSPORTATION

4 SECTION 38. There is hereby appropriated to the Office of the
5 State Auditor and Inspector from any monies not otherwise
6 appropriated from the General Revenue Fund of the State Treasury for
7 the fiscal year ending June 30, 2012, the sum of Four Million Three

15 the sum of Seventeen Million Three Hundred Thousand Dollars
16 (\$17,300,000.00) or so much thereof as may be necessary to perform
17 the duties imposed upon the Supreme Court or Court of Civil Appeals
18 by law.

19 SECTION 144. For the fiscal year ending June 30, 2012, the
20 Office of State Finance shall, at the request of the Administrative
21 Director of the Courts, transfer from the Law Library Revolving Fund
22 to the Supreme Court Administrative Revolving Fund an amount not to
23 exceed Five Hundred Thousand Dollars (\$500,000.00) that the
24 Administrative Director of the Courts, with the approval of the

1 Chief Justice of the Supreme Court in his or her sole discretion,
2 shall deem appropriate or necessary including, but not limited to,
3 appellate and district court expenditures.

4 SECTION 145. For the fiscal year ending June 30, 2012, the
5 Office of State Finance shall, at the request of the Administrative
6 Director of the Courts, transfer from the Lengthy Trial Fund to the
7 Supreme Court Administrative Revolving Fund an amount not to exceed
8 Two Million Dollars (\$2,000,000.00) that the Administrative Director
9 of the Courts, with the approval of the Chief Justice of the Supreme
10 Court in his or her sole discretion, shall deem appropriate or
11 necessary including, but not limited to, appellate and district
12 court expenditures.

13 SECTION 146. There is hereby appropriated to the Workers'
14 Compensation Court from any monies not otherwise appropriated from
15 the General Revenue Fund of the State Treasury for the fiscal year
16 ending June 30, 2012, the sum of Four Million One Hundred Ninety-
17 seven Thousand One Hundred Sixty-six Dollars (\$4,197,166.00) or so
18 much thereof as may be necessary to perform the duties imposed upon
19 the Workers' Compensation Court by law.

20 SECTION 147. There is hereby appropriated to the Oklahoma State
21 University Medical Authority Disbursing Fund from any monies not
22 otherwise appropriated from the Special Cash Fund of the State
23 Treasury, the sum of Five Million Dollars (\$5,000,000.00) or so much
24

1 thereof as may be necessary to perform the duties imposed upon the
2 Oklahoma State University Medical Authority by law.

3 SECTION 148. There is hereby appropriated to the Oklahoma House
4 of Representatives from any monies not otherwise appropriated from
5 the General Revenue Fund of the State Treasury for the fiscal year
6 ending June 30, 2010, the sum of One Million Two Hundred Thousand
7 Dollars (\$1,200,000.00) or so much thereof as may be necessary for
8 the purchase of Oklahoma Statutes and Session Laws pursuant to the
9 provisions of Sections 13 and 14 of Title 75 of the Oklahoma
10 Statutes.

11 SECTION 149. There is hereby appropriated to the State Board of
12 Education from any monies not otherwise appropriated from the
13 Special Cash Fund of the State Treasury, the sum of One Million Four
14 Hundred Sixty-three Thousand One Hundred Twenty-seven Dollars
15 (\$1,463,127.00) or so much thereof as may be necessary for the
16 financial support of public schools.

17 SECTION 150. There is hereby appropriated to the Office of the
18 State Treasurer from any monies not otherwise appropriated from the
19 Special Cash Fund of the State Treasury, the sum of Three Million
20 Five Hundred Thirty-six Thousand Eight Hundred Seventy-three Dollars
21 (\$3,536,873.00) or so much thereof as may be necessary to perform
22 the duties imposed upon the Office of the State Treasurer by law.

23 SECTION 151. There is hereby appropriated to the Office of the
24 State Treasurer from any monies not otherwise appropriated from the

1 Special Cash Fund of the State Treasury, the sum of Ninety-three
2 Thousand Dollars (\$93,000.00) or so much thereof as may be necessary
3 to pay for state land reimbursements.

4 SECTION 152. This act shall become effective July 1, 2011.
