8 AS INTRODUCED

9
10 An Act relating to the Oklahoma Water Resources
11 Board; amending 82 O.S. 2001, Section 1085.7, which
12 relates to the Water Resources Board Revolving Fund;
13 modifying name of fund; creating the OWRB Revolving
14 Fund; providing for certain transfers; providing for
15 codification; providing an effective date; and
16 declaring an emergency.

17 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

18 SECTION 1. AMENDATORY 82 O.S. 2001, Section 1085.7, is
19 amended to read as follows:

20 Section 1085.7 All monies derived from fees shall be deposited
21 with the State Treasurer and credited, apportioned and appropriated
22 to a separate and distinct fund to be known as the Water Resources
23 Board Fee Revolving Fund to be used to enforce and administer the
24 water duties of the Oklahoma Water Resources Board, but no monies
shall be paid out of said Water Resources Board Fee Revolving Fund
until the claim therefor has been itemized and verified by claimant

1 and approved by the Oklahoma Water Resources Board and the Director
2 of the Office of State Finance as provided by law. When so
3 approved, the State Treasurer shall draw his warrant therefor upon
4 the State Treasurer and the same shall be paid out of the Water
5 Resources Board Fee Revolving Fund hereby created.

6 SECTION 2. NEW LAW A new section of law to be codified
7 in the Oklahoma Statutes as Section 1085.7B of Title 82, unless
8 there is created a duplication in numbering, reads as follows:

9 There is hereby created in the State Treasury a revolving fund
10 for the Oklahoma Water Resources Board to be designated the "OWRB
11 Revolving Fund". The fund shall be a continuing fund, not subject
12 to fiscal year limitations and shall consist of all monies collected
13 by the Oklahoma Water Resources Board which are not otherwise
14 designated. All monies accruing to the credit of the fund are
15 hereby appropriated and may be budgeted and expended by the Oklahoma
16 Water Resources Board for the purpose of duties imposed upon the
17 Oklahoma Water Resources Board by law.

18 SECTION 3. TRANSFER There is hereby transferred the
19 balance of the Statewide Water Development Revolving Fund created
20 pursuant to Section 1085.40 of the Oklahoma Statutes, the balance of
21 the Oklahoma Weather Modification Revolving Fund created pursuant to
22 Section 1087.6 of Title 82 of the Oklahoma Statutes and the balance
23 allowed in the Interagency Reimbursement Fund (443 Fund) pursuant to
24

1 Section 581 of Title 74 of the Oklahoma Statutes to the OWRB
2 Revolving Fund created in Section 2 of this act.

3 SECTION 4. This act shall become effective July 1, 2011.

4 SECTION 5. It being immediately necessary for the preservation
5 of the public peace, health and safety, an emergency is hereby
6 declared to exist, by reason whereof this act shall take effect and
7 be in full force from and after its passage and approval.
