9 AS INTRODUCED

10 An Act relating to the Corporation Commission;  
11 setting certain budget limits; providing an effective  
12 date; and declaring an emergency.

13  
14 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

15 SECTION 1. For the fiscal year ending June 30, 2013, the budget  
16 limit for the Public Utility Division of the Corporation Commission  
17 shall be set at Five Million Seven Hundred Eighty-five Thousand Four  
18 Hundred Eighty Dollars (\$5,785,480.00).

19 SECTION 2. For the fiscal year ending June 30, 2013, the budget  
20 limit for the Corporation Commission to fulfill the duties assigned  
21 by the Nonconsensual Towing Act of 2011 shall be set at One Hundred  
22 Thousand Dollars (\$100,000.00).

23 SECTION 3. This act shall become effective July 1, 2012.

1 SECTION 4. It being immediately necessary for the preservation  
2 of the public peace, health and safety, an emergency is hereby  
3 declared to exist, by reason whereof this act shall take effect and  
4 be in full force from and after its passage and approval.
