10 An Act relating to the University Hospitals
11 Authority; requiring transfers of certain funds;
12 requiring certain funds be used for certain programs;
13 providing an effective date; and declaring an
14 emergency.

15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. TRANSFER The University Hospitals Authority
17 shall transfer the sum of Five Hundred Thousand Dollars
18 (\$500,000.00) from the funds appropriated in Section 81 of Enrolled
19 House Bill No. 2170 of the 1st Session of the 53rd Oklahoma
20 Legislature to the University Hospitals Authority Disbursing Fund
21 created by Section 3221 of Title 63 of the Oklahoma Statutes, to be
22 expended in accordance with law.

23 SECTION 2. TRANSFER The University Hospitals Authority
24 shall transfer the sum of Two Million Dollars (\$2,000,000.00) from
the funds appropriated in Section 81 of Enrolled House Bill No. 2170

1 of the 1st Session of the 53rd Oklahoma Legislature to the Oklahoma
2 Institute for Disaster and Emergency Medicine Revolving Fund
3 established pursuant to Section 1-2523 of Title 63 of the Oklahoma
4 Statutes, to be expended in accordance with law.

5 SECTION 3. TRANSFER The University Hospitals Authority
6 shall transfer the sum of Three Hundred Seventy-five Thousand
7 Dollars (\$375,000.00) from the funds appropriated in Section 81 of
8 Enrolled House Bill No. 2170 of the 1st Session of the 53rd Oklahoma
9 Legislature to the Dental Loan Repayment Revolving Fund established
10 pursuant to Section 1-2714 of Title 63 of the Oklahoma Statutes, to
11 be expended in accordance with law.

12 SECTION 4. From the funds appropriated to the University
13 Hospitals Authority in Section 81 of Enrolled House Bill No. 2170 of
14 the 1st Session of the 53rd Oklahoma Legislature, One Hundred
15 Seventy-eight Thousand Dollars (\$178,000.00) shall be used for
16 providing hearing services for deaf and/or hard of hearing children
17 statewide.

18 SECTION 5. This act shall become effective July 1, 2011.

19 SECTION 6. It being immediately necessary for the preservation
20 of the public peace, health and safety, an emergency is hereby
21 declared to exist, by reason whereof this act shall take effect and
22 be in full force from and after its passage and approval.
