**SB 1969** – By Jolley, Justice and Mazzei of the Senate and Sears and Martin (Scott) of the House.

An Act relating to public finance; amending 62 O.S. 2011, Section 47, which relates to the Economic Development Generating Excellence Fund; abolishing Board of Investors of EDGE Fund and transferring powers and duties thereof to the State Treasurer; limiting time period during which certain cost considered administrative expense of Fund; specifying certain duties and authority of State Treasurer; requiring transfer of certain funds; repealing 62 O.S. 2011, Section 52, which relates to the EDGE Fund Policy Board; providing an effective date; and declaring an emergency.

**SB 1971** – By Jolley and Justice of the Senate and Sears and Martin (Scott) of the House.

An Act relating to apportionment of tobacco settlement monies; amending 62 O.S. 2011, Section 50, which relates to the Tobacco Settlement Fund; amending 74 O.S. 2011, Section 19, which relates to funds of the Office of the Attorney General; modifying apportionment of certain monies; providing an effective date; and declaring an emergency.

**SB 1991** – By Jolley and Justice of the Senate and Sears and Martin (Scott) of the House.

An Act relating to children; amending 10 O.S. 2011, Section 601.3, which relates to the Oklahoma Commission on Children and Youth; modifying powers and duties of Commission; repealing 10 O.S. 2011, Sections 630.1, 630.2 and 630.3, which relate to the Coordinated Database System for Children Act; providing an effective date; and declaring an emergency.

### **PENDING CONSIDERATION OF CCR**

Representative Renegar raised a point of order as to whether the **CCR** on **HB 3053** was in violation of the single subject requirement.

The Presiding Officer stated that the Chair does not rule on the constitutionality of a measure.

Representative Morrissette raised a point of inquiry as to where in the House Precedents this is stated, to which the Chair responded House Precedent 14.2-1 (2007).

Representative Renegar asked a ruling of the Presiding Officer whether the **CCR** is germane to **HB 3053**.

The Presiding Officer ruled the point not well taken and the **CCR** germane.

Representative Morrissette raised a point of order requesting that the Presiding Officer restate the previous ruling of the Chair made on the basis of House Precedent.

The Presiding Officer restated that the Chair would not weigh on the constitutionality of a measure as established by House Precedent 14.2-1 (2007).

Representative Morrissette appealed the ruling of the Presiding Officer receiving the required 15 seconds.
