“A purchaser or sales agent takes free of any owner’s lien otherwise applicable to the livestock so purchased and shall be relieved of any obligations created by subsection A of Section 4 of this act if the purchaser or sales agent has paid the full amount of required consideration for the livestock pursuant to a good faith, noncollusive agreement to purchase such livestock. If a purchaser or sales agent has paid the full amount of consideration as set forth in this section, the owner’s lien shall transfer to the proceeds paid by the purchaser or sales agent. Except as specifically provided by this section, an owner’s lien has priority over the rights of any purchaser or sales agent.”, which motion was declared adopted.

- A. Any boat rental business operating in a state park:
 - 1. Shall have a current valid written contract with the Oklahoma Tourism and Recreation Department or the agency which owns the lake;
 - 2. Is prohibited from operating within a fifteen-mile radius of an existing authorized Department boat rental operation;
 - 3. Shall have a visible, commercially accessible public location;
 - 4. Shall be properly licensed with a tax permit and any other required local permits;
 - 5. Shall carry a valid commercial liability insurance policy with a minimum limit of One Million Dollars (\$1,000,000.00) which provides bodily injury and property damage coverage for customers or other individuals, naming the Department as an additional insured with a waiver of subrogation in favor of the Department;
 - 6. Must have a valid commercial automobile policy with minimum limits of One Million Dollars (\$1,000,000.00) combined single limit, naming the Department as an additional insured with a waiver of subrogation in favor of the Department;

7. Shall be subject to a minimum of ten percent (10%) commission payable to the Department;

8. Shall be subject to annual audits with fine, suspension, or termination for violating or not properly reporting and paying established commissions; and

9. Shall be subject to a fine of Five Hundred Dollars (\$500.00) or imprisonment in the county jail for not more than thirty (30) days or both such fine and imprisonment if found guilty of operating illegally in a state park.

B. As used in this section, "boat rental business" means a short term lease or rental of any boat, including the completion of paperwork or documents, and the loading and delivery of the boat.", and by renumbering subsequent section, which amendment was declared adopted.
