HB 1485 – By Roberts (Dustin), Blackwell, Cannaday, Walker, Hickman, McDaniel (Curtis) and Hoskin of the House and Schulz of the Senate.

An Act relating to motor vehicles; authorizing the Commissioner of Public Safety to negotiate certain compacts and agreements; establishing presumption that certain actions shall be within discretion of Commissioner; authorizing certain disapproval by the Legislature or Governor; establishing procedure; establishing presumption that certain agreements shall be approved; authorizing Commissioner to promulgate certain rules; amending 47 O.S. 2011, Section 14-118, which relates to permits for motor carriers; authorizing issuance of annual permit for transporting certain equipment; providing for codification; and providing an effective date.
