14 AMENDMENT NO. 1. Strike the title, enacting clause and entire bill
15 and insert

16 "An Act relating to memorial highway designations;
17 designating the Bill Swisher Memorial Highway;
18 requiring certain markers; designating the
19 Specialist Dylan Johnson Memorial Bridge; requiring
20 certain markers; designating the SGT First Class
21 David Clinton Fisher Memorial Highway; requiring
22 certain markers; designating the Private First Class
23 John Bennie Laskey Memorial Bridge; requiring
24 certain markers; designating the Wayne Crusoe
Memorial Highway; requiring certain markers;
designating the Wayman Tisdale Memorial Highway;
requiring certain markers; designating the Sergeant
Bret Isenhower Memorial Highway; requiring certain
markers; designating the Pikey's Crossing Memorial
Highway; requiring certain markers; designating the
Petty Officer Tony Randolph Memorial Highway;
requiring certain markers; designating the

1 Specialist Howard Lee Jones Memorial Bridge;
2 requiring certain markers; designating the OHP
3 Captain Pete Norwood Memorial Highway; requiring
4 certain markers; providing for codification; and
5 providing an effective date.

6 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

7 SECTION 1. NEW LAW A new section of law to be codified
8 in the Oklahoma Statutes as Section 1698.159 of Title 69, unless
9 there is created a duplication in numbering, reads as follows:

10 The section of Interstate 40 beginning at Morgan Road and
11 extending east to the Oklahoma County line shall be designated as
12 the "Bill Swisher Memorial Highway". The Department of
13 Transportation shall cause suitable permanent markers bearing that
14 name to be placed on the highway.

15 SECTION 2. NEW LAW A new section of law to be codified
16 in the Oklahoma Statutes as Section 1698.160 of Title 69, unless
17 there is created a duplication in numbering, reads as follows:

18 The bridge over Polecat Creek on U.S. Highway 75 within the
19 municipal limits of Jenks shall be designated as the "Specialist
20 Dylan Johnson Memorial Bridge". The Department of Transportation
21 shall cause suitable permanent markers bearing that name to be
22 placed on the bridge.

1 SECTION 3. NEW LAW A new section of law to be codified
2 in the Oklahoma Statutes as Section 1698.161 of Title 69, unless
3 there is created a duplication in numbering, reads as follows:

4 The portion of State Highway 16 from the intersection of State
5 Highway 18 and West 221st Street extending to the intersection of
6 State Highway 16 and South 401st West Avenue in Creek County shall
7 be designated as the "SGT First Class David Clinton Fisher Memorial
8 Highway". The Department of Transportation shall cause suitable
9 permanent markers bearing that name to be placed upon the highway.

10 SECTION 4. NEW LAW A new section of law to be codified
11 in the Oklahoma Statutes as Section 1698.162 of Title 69, unless
12 there is created a duplication in numbering, reads as follows:

13 The southernmost bridge on State Highway 66 crossing Sand Creek
14 north of Bristow shall be designated as the "Private First Class
15 John Bennie Laskey Memorial Bridge". The Department of
16 Transportation shall cause suitable permanent markers bearing that
17 name to be placed upon the bridge.

18 SECTION 5. NEW LAW A new section of law to be codified
19 in the Oklahoma Statutes as Section 1698.163 of Title 69, unless
20 there is created a duplication in numbering, reads as follows:

21 The section of U.S. Highway 70 beginning at the municipal limits
22 of Garvin and extending southeast to the municipal limits of Idabel
23 shall be designated as the "Wayne Crusoe Memorial Highway". The

1 Department of Transportation shall cause suitable permanent markers
2 bearing that name to be placed on the highway.

3 SECTION 6. NEW LAW A new section of law to be codified
4 in the Oklahoma Statutes as Section 1698.164 of Title 69, unless
5 there is created a duplication in numbering, reads as follows:

6 The section of State Highway 11 beginning at the Gilcrease
7 Expressway and extending north to the municipal limits of Tulsa
8 shall be designated as the "Wayman Tisdale Memorial Highway". The
9 Department of Transportation shall cause suitable permanent markers
10 bearing that name to be placed on the highway.

11 SECTION 7. NEW LAW A new section of law to be codified
12 in the Oklahoma Statutes as Section 1698.165 of Title 69, unless
13 there is created a duplication in numbering, reads as follows:

14 The section of State Highway 59 beginning at US 177 and
15 extending east to the municipal limits of St. Louis shall be
16 designated as the "Sergeant Bret Isenhower Memorial Highway". The
17 Department of Transportation shall cause suitable permanent markers
18 bearing that name to be placed on the highway.

19 SECTION 8. NEW LAW A new section of law to be codified
20 in the Oklahoma Statutes as Section 1698.166 of Title 69, unless
21 there is created a duplication in numbering, reads as follows:

22 The section of State Highway 4 beginning at State Highway 37 and
23 extending north to the South Canadian River shall be designated as
24 the "Pikey's Crossing Memorial Highway". The Department of

1 Transportation shall cause suitable permanent markers bearing that
2 name to be placed on the highway.

3 SECTION 9. NEW LAW A new section of law to be codified
4 in the Oklahoma Statutes as Section 1698.167 of Title 69, unless
5 there is created a duplication in numbering, reads as follows:

6 The section of US Highway 75 beginning just east of Dewey
7 Bartlett Road and extending east one mile within the Henryetta
8 municipal limits shall be designated as "Petty Officer Tony Randolph
9 Memorial Highway". The Department of Transportation shall cause
10 suitable permanent markers to be placed on the highway bearing that
11 name.

12 SECTION 10. NEW LAW A new section of law to be codified
13 in the Oklahoma Statutes as Section 1698.168 of Title 69, unless
14 there is created a duplication in numbering, reads as follows:

15 The bridge over Clear Boggy Creek on State Highway 48 south of
16 the municipal limits of Tupelo shall be designated as the
17 "Specialist Howard Lee Jones Memorial Bridge". The Department of
18 Transportation shall cause suitable permanent markers bearing that
19 name to be placed on the bridge.

20 SECTION 11. NEW LAW A new section of law to be codified
21 in the Oklahoma Statutes as Section 1698.169 of Title 69, unless
22 there is created a duplication in numbering, reads as follows:

23 The section of US Highway 62 between the municipal limits of
24 Anadarko and the municipal limits of Verden shall be designated as

11 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

12 SECTION 13. NEW LAW A new section of law to be codified
13 in the Oklahoma Statutes as Section 1698.159 of Title 69, unless
14 there is created a duplication in numbering, reads as follows:

15 The section of I-40 beginning at Morgan Road and extending east
16 to the Oklahoma County line shall be designated as the "Bill Swisher
17 Memorial Highway". The Department of Transportation shall cause
18 suitable permanent markers bearing that name to be placed on the
19 highway.

20 SECTION 14. This act shall become effective November 1, 2013.
