Section 305. There is hereby re-created until July 1, ~~2013~~  
2017, in accordance with the Oklahoma Sunset Law, the Archives and  
Records Commission, hereinafter referred to as the Commission, to be  
composed of one (1) member to be appointed by the Governor who shall  
serve as Chairman, the State Librarian as Vice Chairman and

1 Secretary, the Lieutenant Governor, the State Auditor and Inspector  
2 and the State Treasurer as members. Any member may appoint and  
3 designate a subofficer or employee as his proxy for purposes of  
4 carrying on the duties of the Commission. The Commission shall have  
5 sole, entire and exclusive authority of the disposition for all  
6 public records and archives of state officers, departments, boards,  
7 commissions, agencies and institutions of this state. The authority  
8 herein granted shall not apply to records and archives of political  
9 subdivisions of the state; provided, however, this act shall not  
10 apply to the confidential records and files of the Oklahoma Tax  
11 Commission which are exempt from all provisions of this act."
