24 AMENDMENT NO. 1. Page 4, line 17 and 1/2, by adding a new Section 9  
to read

"SECTION 9. NEW LAW A new section of law to be codified  
in the Oklahoma Statutes as Section 1698.202 of Title 69, unless  
there is created a duplication in numbering, reads as follows:

1 The portion of State Highway 9 East starting at the junction of  
2 U.S. Highway 69 and State Highway 9 East in Eufala and extending  
3 eastward four miles shall be designated as the "Veterans Memorial  
4 Highway." The Department of Transportation shall cause suitable  
5 permanent markers bearing that name to be placed on the highway."

6 AMENDMENT NO. 2. Page 4, line 18 and 1/2, by adding a new Section  
7 11 to read

8 "SECTION 11. NEW LAW A new section of law to be codified  
9 in the Oklahoma Statutes as Section 1698.203 of Title 69, unless  
10 there is created a duplication in numbering, reads as follows:

11 The portion of State Highway 9 beginning at the southern  
12 municipal boundary of Eufala and extending one mile south shall be  
13 designated as the "Ethel Hedgement Lyle Memorial Highway." The  
14 Department of Transportation shall cause suitable permanent markers  
15 bearing that name to be placed on the highway."

16 AMENDMENT NO. 3. Page 4, line 19 and 1/2, by adding a new  
17 Section 12 to read

18 "SECTION 12. NEW LAW A new section of law to be codified  
19 in the Oklahoma Statutes as Section 1698.204 of Title 69, unless  
20 there is created a duplication in numbering, reads as follows:

21 "The bridge over Buggy Creek on State Highway 37 south of the  
22 municipal limits of Minco shall be designated as the "J.C. Malcom  
23 Memorial Bridge". The Department of Transportation shall cause

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. NEW LAW A new section of law to be codified  
in the Oklahoma Statutes as Section 1698.194 of Title 69, unless  
there is created a duplication in numbering, reads as follows:

The portion of U.S. Highway 81 from the junction of U.S. Highway  
81 and Starlite Drive extending north to the junction of U.S.  
Highway 81 and County Road E780 shall be designated as the  
"President Ronald Reagan Memorial Highway". The Department of

1 Transportation shall cause suitable permanent markers bearing that  
2 name to be placed on the highway.

3 SECTION 2. NEW LAW A new section of law to be codified  
4 in the Oklahoma Statutes as Section 1698.195 of Title 69, unless  
5 there is created a duplication in numbering, reads as follows:

6 The portion of U.S. Highway 60 from the junction of U.S. Highway  
7 60 and County Road N2090 extending west to the junction of U.S.  
8 Highway 60 and County Road N2070 shall be designated as the "Charles  
9 "Chub" Shaw Memorial Highway". The Department of Transportation  
10 shall cause suitable permanent markers bearing that name to be  
11 placed on the highway.

12 SECTION 3. NEW LAW A new section of law to be codified  
13 in the Oklahoma Statutes as Section 1698.196 of Title 69, unless  
14 there is created a duplication in numbering, reads as follows:

15 The section of State Highway 70B from the southern municipal  
16 limits of Kingston extending southerly to the junction of State  
17 Highway 70B and Apple Street shall be designated as the "2nd Lt. Joe  
18 Lee Cunningham Memorial Highway". The Department of Transportation  
19 shall cause suitable permanent markers to be placed upon the highway  
20 bearing that name.

21 SECTION 4. NEW LAW A new section of law to be codified  
22 in the Oklahoma Statutes as Section 1698.197 of Title 69, unless  
23 there is created a duplication in numbering, reads as follows:

1       The portion of State Highway 58 between the junction of State  
2 Highway 58 and Interstate 40 extending north to the junction of  
3 State Highway 58 and County Road E980 shall be designated "Fire  
4 Chief Nolan Schmidt Highway". The Department of Transportation  
5 shall cause suitable permanent markers to be placed upon the highway  
6 bearing that name.

7       SECTION 5.       NEW LAW       A new section of law to be codified  
8 in the Oklahoma Statutes as Section 1698.198 of Title 69, unless  
9 there is created a duplication in numbering, reads as follows:

10       The bridge located on State Highway 18 crossing the Cimarron  
11 River north of Cushing shall be designated as the "Sheriff Frank  
12 Phillips Memorial Bridge". The Department of Transportation shall  
13 cause suitable permanent markers to be placed upon the bridge  
14 bearing that name.

15       SECTION 6.       NEW LAW       A new section of law to be codified  
16 in the Oklahoma Statutes as Section 1698.199 of Title 69, unless  
17 there is created a duplication in numbering, reads as follows:

18       The bridge located on Interstate 35 over NW/NE 27th Street in  
19 Cleveland County shall be designated as the "Airman Kamenski D.  
20 Watson Memorial Bridge". The Department of Transportation shall  
21 cause suitable permanent markers to be placed upon the bridge  
22 bearing that name.

1 SECTION 7. NEW LAW A new section of law to be codified  
2 in the Oklahoma Statutes as Section 1698.200 of Title 69, unless  
3 there is created a duplication in numbering, reads as follows:

4 The bridge located on Interstate 35 over NE 50th Street in  
5 Oklahoma County shall be designated as the "Wayne Chandler, Sr.,  
6 Memorial Bridge". The Department of Transportation shall cause  
7 suitable permanent markers to be placed upon the bridge bearing that  
8 name.

9 SECTION 8. NEW LAW A new section of law to be codified  
10 in the Oklahoma Statutes as Section 1698.201 of Title 69, unless  
11 there is created a duplication in numbering, reads as follows:

12 The portion of State Highway 113 from Coal Creek Bridge on State  
13 Highway 113 extending to approximately five-tenths (0.5) of a mile  
14 east of the junction of State Highway 113 and County Road N4090  
15 shall be designated "Warrior Highway". The Department of  
16 Transportation shall cause suitable permanent markers bearing that  
17 name to be placed on the highway.

18 SECTION 9. This act shall become effective November 1, 2014.
