12 AMENDMENT NO. 1. Strike the stricken title, enacting clause and  
13 entire bill and insert

15 "An Act relating to the W.V.C. Revolving Fund;  
16 amending 72 O.S. 2011, Section 67.13, as amended by  
17 Section 650, Chapter 304, O.S.L. 2012 (72 O.S. Supp.  
18 2013, Section 67.13), which relates to expenditures  
and loans from fund; updating language; and  
declaring an emergency.

20 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

21 SECTION 1. AMENDATORY 72 O.S. 2011, Section 67.13, as  
22 amended by Section 650, Chapter 304, O.S.L. 2012 (72 O.S. Supp.  
23 2013, Section 67.13), is amended to read as follows:

1           Section 67.13   The War Veterans Commission of Oklahoma shall  
2 have authority to make expenditures or loans from the W.V.C.  
3 Revolving Fund for emergency financial aid in the maintenance or  
4 support of honorably discharged ~~war~~ veterans or their spouses or  
5 surviving spouses who have been legal residents of this state for a  
6 period of one (1) year next preceding application for these  
7 benefits.   Payments may be made from this fund by the War Veterans  
8 Commission upon warrants drawn by the State Treasurer on claims  
9 approved by the Director of the Oklahoma Department of Veterans  
10 Affairs pursuant to the guidelines of the Office of Management and  
11 Enterprise Services.   At the time of approval of claims, the  
12 Director shall certify that such payments meet criteria established  
13 by regulations promulgated by the War Veterans Commission of  
14 Oklahoma.

15           SECTION 2.   It being immediately necessary for the preservation  
16 of the public peace, health and safety, an emergency is hereby  
17 declared to exist, by reason whereof this act shall take effect and  
18 be in full force from and after its passage and approval."

11 SECTION 3. AMENDATORY 72 O.S. 2011, Section 67.13, as  
12 amended by Section 650, Chapter 304, O.S.L. 2012 (72 O.S. Supp.  
13 2013, Section 67.13), is amended to read as follows:

14 Section 67.13. The War Veterans Commission of Oklahoma shall  
15 have authority to make expenditures or loans from the W.V.C.  
16 Revolving Fund for emergency financial aid in the maintenance or  
17 support of honorably discharged ~~war~~ veterans or their spouses or  
18 surviving spouses who have been legal residents of this state for a  
19 period of one (1) year next preceding application for these  
20 benefits. Payments may be made from this fund by the War Veterans  
21 Commission upon warrants drawn by the State Treasurer on claims  
22 approved by the Director of the Oklahoma Department of Veterans
