8 SECTION 1. The Department of Human Services shall use any
9 potential savings from the closure of the Southern Oklahoma Resource
10 Center and the Northern Oklahoma Resource Center to provide services
11 and programs for persons with developmental disabilities, including
12 but not limited to persons on the Developmental Disabilities
13 Services Division waiting list and persons with developmental
14 disabilities and their families who are currently receiving services
15 provided by the Division.

16 SECTION 2. The Department of Human Services shall make a report
17 to the President Pro Tempore of the Senate, the Speaker of the House
18 of Representatives and the Governor by June 30, 2017, describing the
19 savings from the closure of the Southern Oklahoma Resource Center
20 and Northern Oklahoma Resource Center.

21 SECTION 3. The Secretary of State is hereby directed to
22 distribute a copy of this resolution to the Director of Human
23 Services."

SECTION 4. The Department of Human Services shall use any potential savings from the closure of the Southern Oklahoma Resource

1 Center and the Northern Oklahoma Resource Center to provide
2 additional services and programs for persons with developmental
3 disabilities to reduce the size of the Developmental Disabilities
4 Services Division waiting list and shall be used to supplement
5 rather than replace existing resources and programs for
6 developmental disabilities.

7 SECTION 5. The Department of Human Services shall make a report
8 to the President Pro Tempore of the Senate, the Speaker of the House
9 of Representatives and the Governor by June 30, 2017, describing the
10 savings from the closure of the Southern Oklahoma Resource Center
11 and Northern Oklahoma Resource Center.

12 SECTION 6. The Secretary of State is hereby directed to
13 distribute a copy of this resolution to the Director of Human
14 Services.
