9 An Act relating to memorial bridge dedications;  
10 designating the Maestro Kenneth Kilgore Memorial  
11 Bridge; designating the LCpl Hatak-Yuka-Keyu Martin  
12 Yearby USMC Memorial Bridge; designating the Wayne  
13 Crusoe Memorial Highway; designating the Director  
14 Steven Stokes Memorial Highway; designating the  
15 Milton Irwin Memorial Bridge; designating the Senator  
16 Ed Berrong Memorial Highway; designating the Great  
17 Western Cattle Trail; designating the Sergeant Bret  
18 Daniel Isenhower Memorial Highway; providing for  
19 codification; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. NEW LAW A new section of law to be codified  
in the Oklahoma Statutes as Section 1698.159 of Title 69, unless  
there is created a duplication in numbering, reads as follows:

The bridge located on Interstate 44 near the junction of  
Interstate 44 and N. Kelley Avenue in Oklahoma City shall be  
designated as the "Maestro Kenneth Kilgore Memorial Bridge".

Pursuant to the provisions of Title 69 of the Oklahoma Statutes, the

1 Department of Transportation shall cause suitable permanent markers  
2 to be placed upon the bridge bearing that name.

3 SECTION 2. NEW LAW A new section of law to be codified  
4 in the Oklahoma Statutes as Section 1698.160 of Title 69, unless  
5 there is created a duplication in numbering, reads as follows:

6 The bridge over Hickory Creek on U.S. Highway 77 between Oswalt  
7 Road and Campbell Road in Love County shall be designated the "LCpl  
8 Hatak-Yuka-Keyu Martin Yearby USMC Memorial Bridge". Pursuant to  
9 the provisions of Title 69 of the Oklahoma Statutes, the Department  
10 of Transportation shall cause suitable permanent markers to be  
11 placed upon the bridge bearing that name.

12 SECTION 3. NEW LAW A new section of law to be codified  
13 in the Oklahoma Statutes as Section 1698.161 of Title 69, unless  
14 there is created a duplication in numbering, reads as follows:

15 The portion of U.S. Highway 70 from the municipal limits of  
16 Idabel to the municipal limits of Garvin shall be designated as the  
17 "Wayne Crusoe Memorial Highway". Pursuant to the provisions of  
18 Title 69 of the Oklahoma Statutes, the Department of Transportation  
19 shall cause suitable permanent markers to be placed upon the highway  
20 bearing that name.

21 SECTION 4. NEW LAW A new section of law to be codified  
22 in the Oklahoma Statutes as Section 1698.162 of Title 69, unless  
23 there is created a duplication in numbering, reads as follows:

1       The portion of Interstate 35 beginning approximately two (2)  
2 miles north of the intersection of Interstate 35 and State Highway  
3 19 extending approximately two (2) miles to the south of the  
4 intersection of Interstate 35 and State Highway 29 shall be  
5 designated as the "Director Steven Stokes Memorial Highway".  
6 Pursuant to the provisions of Title 69 of the Oklahoma Statutes, the  
7 Department of Transportation shall cause suitable permanent markers  
8 to be placed upon the highway bearing that name.

9       SECTION 5.       NEW LAW       A new section of law to be codified  
10 in the Oklahoma Statutes as Section 1698.163 of Title 69, unless  
11 there is created a duplication in numbering, reads as follows:

12       The bridge over Big Creek on State Highway 1 between Calvin and  
13 Atwood in Hughes County shall be designated as the "Milton Irwin  
14 Memorial Bridge". Pursuant to the provisions of Title 69 of the  
15 Oklahoma Statutes, the Department of Transportation shall cause  
16 suitable permanent markers to be placed upon the bridge bearing that  
17 name.

18       SECTION 6.       NEW LAW       A new section of law to be codified  
19 in the Oklahoma Statutes as Section 1698.164 of Title 69, unless  
20 there is created a duplication in numbering, reads as follows:

21       The portion of Interstate 40 between exit number 79 and exit  
22 number 82 shall be designated as the "Senator Ed Berrong Memorial  
23 Highway". Pursuant to the provisions of Title 69 of the Oklahoma  
24

1 Statutes, the Department of Transportation shall cause suitable  
2 permanent markers to be placed upon the highway bearing that name.

3 SECTION 7. NEW LAW A new section of law to be codified  
4 in the Oklahoma Statutes as Section 1698.165 of Title 69, unless  
5 there is created a duplication in numbering, reads as follows:

6 The portion of Interstate 40 between mile marker 45 and mile  
7 marker 55 shall be designated as the "Great Western Cattle Trail".

8 Pursuant to the provisions of Title 69 of the Oklahoma Statutes, the  
9 Department of Transportation shall cause suitable permanent markers  
10 to be placed upon the highway bearing that name.

11 SECTION 8. NEW LAW A new section of law to be codified  
12 in the Oklahoma Statutes as Section 1698.166 of Title 69, unless  
13 there is created a duplication in numbering, reads as follows:

14 The portion of State Highway 59 from the intersection of State  
15 Highway 59 and State Highway 177 extending to the municipal limits  
16 of St. Louis as the "Sergeant Bret Daniel Eisenhower Memorial  
17 Highway". Pursuant to the provisions of Title 69 of the Oklahoma  
18 Statutes, the Department of Transportation shall cause suitable  
19 permanent markers to be placed upon the highway bearing that name.

20 SECTION 9. This act shall become effective November 1, 2013.
