11 COMMITTEE SUBSTITUTE

12 An Act relating to appropriations; amending Sections
13 25, 28, 80 and 67 of Enrolled House Bill No. 2301 of
14 the 1st Session of the 54th Oklahoma Legislature,
15 which relate to the Oklahoma State Regents for Higher
16 Education and the Oklahoma Department of Commerce;
17 modifying sources of certain appropriated funds;
18 making appropriations; providing an effective date;
19 and declaring an emergency.

20 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

21 SECTION 1. AMENDATORY Section 25 of Enrolled House Bill
22 No. 2301 of the 1st Session of the 54th Oklahoma Legislature is
23 amended to read as follows:

24 Section 25. There is hereby appropriated to the Oklahoma State
Regents for Higher Education from any monies not otherwise
appropriated from the General Revenue Fund of the State Treasury for
the fiscal year ending June 30, 2014, the sum of ~~Eight Hundred Ten
Million Six Hundred Seventy-three Thousand Eight Hundred Fifty-two~~

1 ~~Dollars (\$810,673,852.00)~~ Eight Hundred Thirty-three Million Six
2 Hundred Seventy-three Thousand Eight Hundred Fifty-two Dollars
3 (\$833,673,852.00) or so much thereof as may be necessary for
4 allocation by the Oklahoma State Regents for Higher Education
5 pursuant to the provisions of Article XIII-A of the Oklahoma
6 Constitution for the education and general operating budgets of the
7 institutions and for other programs, construction, renovations or
8 repairs administered by the Oklahoma State Regents for Higher
9 Education. Of those funds appropriated, the sum of Three Million
10 Eight Hundred Thirty Thousand Thirty-eight Dollars (\$3,830,038.00)
11 shall be transferred to the Oklahoma Tuition Equalization Grant
12 Trust Fund to implement the provisions of the Oklahoma Tuition
13 Equalization Grant Act.

14 SECTION 2. AMENDATORY Section 28 of Enrolled House Bill
15 No. 2301 of the 1st Session of the 54th Oklahoma Legislature is
16 amended to read as follows:

17 Section 28. There is hereby appropriated to the Oklahoma State
18 Regents for Higher Education from any monies not otherwise
19 appropriated from the Special Cash Fund of the State Treasury the
20 sum of ~~Fifty Million Dollars (\$50,000,000.00)~~ Twenty-seven Million
21 Dollars (\$27,000,000.00) for allocation by the Oklahoma State
22 Regents for Higher Education pursuant to the provisions of Article
23 XIII-A of the Oklahoma Constitution for the education and general
24 operating budgets of the institutions and for other programs,

1 construction, renovations or repairs administered by the Oklahoma
2 State Regents for Higher Education.

3 SECTION 3. AMENDATORY Section 80 of Enrolled House Bill
4 No. 2301 of the 1st Session of the 54th Oklahoma Legislature is
5 amended to read as follows:

6 Section 80. There is hereby appropriated to the Oklahoma
7 Department of Commerce from any monies not otherwise appropriated
8 from the General Revenue Fund of the State Treasury for the fiscal
9 year ending June 30, 2014, the sum of ~~Twenty-five Million Seven~~
10 ~~Hundred Eighty-eight Thousand Eight Hundred Fifty-eight Dollars~~
11 ~~(\$25,788,858.00)~~ Twenty-two Million Seven Hundred Eighty-eight
12 Thousand Eight Hundred Fifty-eight Dollars (\$22,788,858.00) or so
13 much thereof as may be necessary to perform the duties imposed upon
14 the Oklahoma Department of Commerce by law.

15 SECTION 4. There is hereby appropriated to the Oklahoma Quick
16 Action Closing Fund of the Oklahoma Department of Commerce from any
17 monies not otherwise appropriated from the Special Cash Fund of the
18 State Treasury for the fiscal year ending June 30, 2014, the sum of
19 Three Million Dollars (\$3,000,000.00) or so much thereof as may be
20 necessary to perform the duties imposed upon the Oklahoma Department
21 of Commerce by law.

22 SECTION 5. AMENDATORY Section 67 of Enrolled House Bill
23 No. 2301 of the 1st Session of the 54th Oklahoma Legislature is
24 amended to read as follows:

1 Section 67. There is hereby appropriated to the Department of
2 Mental Health and Substance Abuse Services from any monies not
3 otherwise appropriated from the General Revenue Fund of the State
4 Treasury for the fiscal year ending June 30, 2014, the sum of ~~Three~~
5 ~~Hundred Thirty-Six Million Eight Hundred Twenty-one Thousand Four~~
6 ~~Hundred Fifty-eight Dollars (\$336,821,458.00)~~ Three Hundred Sixteen
7 Million Eight Hundred Twenty-one Thousand Four Hundred Fifty-eight
8 Dollars (\$316,821,458.00) or so much thereof as may be necessary to
9 perform the duties imposed upon the Department of Mental Health and
10 Substance Abuse Services by law.

11 SECTION 6. There is hereby appropriated to the Department of
12 Mental Health and Substance Abuse Services from any monies not
13 otherwise appropriated from the Special Cash Fund of the State
14 Treasury for the fiscal year ending June 30, 2014, the sum of Twenty
15 Million Dollars (\$20,000,000.00) or so much thereof as may be
16 necessary to perform the duties imposed upon the Department of
17 Mental Health and Substance Abuse Services by law.

18 SECTION 7. This act shall become effective July 1, 2013.

19 SECTION 8. It being immediately necessary for the preservation
20 of the public peace, health and safety, an emergency is hereby
21 declared to exist, by reason whereof this act shall take effect and
22 be in full force from and after its passage and approval.
