15 No municipal fire department located wholly or partially in a
16 county that has levied a sales tax pursuant to Section 1370 of Title
17 68 of the Oklahoma Statutes for the purpose of providing funds for a
18 county fire department shall modify the existing service area within
19 which municipal fire protection services are provided unless the
20 modification is approved by the board of county commissioners of the
21 applicable county or counties.
