9 CONFERENCE COMMITTEE SUBSTITUTE

10 An Act relating to the Constitutional Reserve Fund;  
11 making an appropriation to the State Emergency Fund;  
12 stating purpose; making appropriation nonfiscal; and  
13 declaring an emergency.

14 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

15 SECTION 1. There is hereby appropriated to The State Emergency  
16 Fund created pursuant to Section 139.42 of Title 62 of the Oklahoma  
17 Statutes from any monies not otherwise appropriated from the  
18 Constitutional Reserve Fund of the State Treasury the sum of Forty-  
19 five Million Dollars (\$45,000,000.00) or so much thereof as may be  
20 necessary for matching federal disaster funds and for other  
21 disaster-related assistance.

22 SECTION 2. The appropriations made by this act shall not be  
23 subject to fiscal year limitations and shall be available for  
24

1 encumbrance and expenditure purposes for a period of thirty (30)  
2 months from the date this act is approved.

3 SECTION 3. It being immediately necessary for the preservation  
4 of the public peace, health and safety, an emergency is hereby  
5 declared to exist, by reason whereof this act shall take effect and  
6 be in full force from and after its passage and approval.
