COMMITTEE SUBSTITUTE

An Act relating to fees; amending 28 O.S. 2011,
Section 31, which relates to fees of court clerks;
prohibiting court clerk from charging fee to entity
that provides information to the public; and
providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 28 O.S. 2011, Section 31, is
amended to read as follows:

Section 31. A. Notwithstanding any other provision of law, but
subject to subsection B of this section, the clerk of the district
court, or the clerk of any other court of record, shall charge and
collect the following fees for services by them respectively
rendered and none others, except as otherwise provided by law:

Approving bond or undertaking, including

certificate and seal.....\$3.00

Making copy of an instrument of record or

on file, first page.....\$1.00

1	subsequent pages (each).....	\$0.50
2	Certifying to any instrument (each).....	\$0.50
3	Authentication of court records.....	\$5.00
4	Receiving and paying out money in	
5	pursuance of law or order of court.....	1%
6	provided, however, that such charge	
7	shall not exceed \$300.00.	
8	Application, issuing, entering return and	
9	recording marriage license if the	
10	applicants submit a certificate that	
11	states the applicants have completed the	
12	premarital counseling program pursuant	
13	to Section 5.1 of Title 43 of the	
14	Oklahoma Statutes.....	\$5.00
15	Application, issuing, entering return and	
16	recording marriage license if the	
17	applicants do not submit a certificate	
18	that states the applicants have	
19	completed the premarital counseling	
20	program pursuant to Section 5.1 of Title	
21	43 of the Oklahoma Statutes.....	\$50.00
22	Conveyance of full-blood Indian heirs to	
23	interest in inherited lands, same to be	
24	accounted for as other fees.....	\$5.00

1 Posting notice outside the courthouse.....\$10.00
2 Mailing, by any type of mail, writs,
3 warrants, orders, process, command or
4 notice for each person.....\$10.00, or
5 actual expense, whichever is greater,
6 except ordinary mailing of first-class
7 mail in probate cases, for each case.....\$10.00, or
8 actual expense, whichever is greater.

9 For the actual cost of all postage in each
10 case in excess of.....\$10.00, or
11 actual expense, whichever is greater.

12 For filing and indexing of disclaimers
13 other than in pending probate or civil
14 cases pursuant to the provisions of
15 Section 751 et seq. of Title 60 of the
16 Oklahoma Statutes.....\$5.00

17 B. The clerk of the district court, or the clerk of any other
18 court of record, shall not charge a fee or prevent a person from
19 taking photographs or making digital images of court instruments or
20 records that are available for public inspection.

21 SECTION 2. This act shall become effective November 1, 2014.
