7 COMMITTEE SUBSTITUTE

8 An Act relating to public finance; amending 74 O.S.  
9 2011, Section 3106.4, which relates to posting of  
10 information by public bodies; modifying required  
11 content; amending 74 O.S. 2011, Section 212B, which  
relates to information acquired during audits;  
12 modifying required content of website; and providing  
13 an effective date.

14 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

15 SECTION 1. AMENDATORY 74 O.S. 2011, Section 3106.4, is  
16 amended to read as follows:

17 Section 3106.4 A. On or before January 1, 2011, public bodies  
18 shall make available on their Internet website or on a general  
19 website if a public body uses a general website, the following:

20 1. Any administrative rules adopted pursuant to the  
21 Administrative Procedures Act, which the public body uses to  
22 operate;

23 2. Any proposed administrative rules submitted by the public  
24 body pursuant to the Administrative Procedures Act;

1 3. Any statutes effecting the public body and its operations;  
2 and

3 4. Any statutes the public may find useful in interacting with  
4 the public body;

5 5. The gross salary of each employee. This data shall be made  
6 available in an open-structured format that may be downloaded by the  
7 public;

8 6. The budget and audited financial statements of the public  
9 entity as provided to the State Auditor and Inspector; and

10 7. If applicable, a data set containing each payment warrant  
11 and associated data as provided to the State Auditor and Inspector  
12 in compliance with a state audit.

13 B. For purposes of this section, "public body" is defined as  
14 provided by paragraph 1 of Section 304 of Title 25 of the Oklahoma  
15 Statutes.

16 SECTION 2. AMENDATORY 74 O.S. 2011, Section 212B, is  
17 amended to read as follows:

18 Section 212B. Copies of any audit, performance audit, agreed-  
19 upon procedure report, or other attestation engagement report  
20 produced by a person other than the State Auditor and Inspector that  
21 is required to be filed with the State Auditor and Inspector  
22 pursuant to Section 212A of ~~Title 74 of the Oklahoma Statutes~~, this  
23 title shall be submitted in electronic, read-only format. The State  
24 Auditor and Inspector shall make such reports available to the

1 public at no charge on the State Auditor and Inspector's website.  
2 On this website, the State Auditor and Inspector shall also make  
3 publicly available raw data sets collected from county government  
4 during the county audit process.

5 SECTION 3. This act shall become effective November 1, 2014.
