9 SUBCOMMITTEE RECOMMENDATION

10 An Act relating to memorial bridge designations;
11 designating the Specialist Dylan Johnson Memorial
12 Bridge; requiring certain markers; designating the
13 SGT First Class David Clinton Fisher Memorial
14 Highway; requiring certain markers; designating the
15 Private First Class John Bennie Laskey Memorial
16 Bridge; requiring certain markers; providing for
17 codification; and providing an effective date.

18 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

19 SECTION 1. NEW LAW A new section of law to be codified
20 in the Oklahoma Statutes as Section 1698.159 of Title 69, unless
21 there is created a duplication in numbering, reads as follows:

22 The bridge over Polecat Creek on U.S. Highway 75 within the
23 municipal limits of Jenks shall be designated as the "Specialist
24 Dylan Johnson Memorial Bridge". The Department of Transportation
shall cause suitable permanent markers bearing that name to be
placed on the bridge.

1 SECTION 2. NEW LAW A new section of law to be codified
2 in the Oklahoma Statutes as Section 1698.160 of Title 69, unless
3 there is created a duplication in numbering, reads as follows:

4 The portion of State Highway 16 from the intersection of State
5 Highway 18 and West 221st Street extending to the intersection of
6 State Highway 16 and South 401st West Avenue in Creek County shall
7 be designated as the "SGT First Class David Clinton Fisher Memorial
8 Highway". Pursuant to the provisions of Title 69 of the Oklahoma
9 Statutes, the Department of Transportation shall cause suitable
10 permanent markers to be placed upon the highway bearing that name.

11 SECTION 3. NEW LAW A new section of law to be codified
12 in the Oklahoma Statutes as Section 1698.161 of Title 69, unless
13 there is created a duplication in numbering, reads as follows:

14 The southernmost bridge on State Highway 66 crossing Sand Creek
15 North of Bristow shall be designated as the "Private First Class
16 John Bennie Laskey Memorial Bridge". Pursuant to the provisions of
17 Title 69 of the Oklahoma Statutes, the Department of Transportation
18 shall cause suitable permanent markers to be placed upon the bridge
19 bearing that name.

20 SECTION 4. This act shall become effective November 1, 2013.
