COMMITTEE SUBSTITUTE

An Act relating to road and bridge dedications;
designating the Maestro Kenneth Kilgore Memorial
Bridge; designating the LCpl Hatak-Yuka-Keyu Martin
Yearby USMC Memorial Bridge; designating the Wayne
Crusoe Memorial Highway; designating the Director
Steven Stokes Memorial Highway; designating the
Milton Irwin Memorial Bridge; designating the Senator
Ed Berrong Memorial Highway; designating the Great
Western Cattle Trail; designating the Sergeant Bret
Daniel Isenhower Memorial Highway; designating the
Larry Tomlinson Memorial Bridge; designating the Phil
Tomlinson Bridge; designating the WWI Choctaw Code
Talkers Highway; designating the Specialist Joshua M.
"Bubba" Seals Memorial Bridge; designating the PFC
Albert E. Schwab, Medal of Honor Memorial Highway;
designating the Rev. W.T. "Tommy" Roberts Memorial
Bridge; designating the Mayor Jon Gumerson Memorial
Bridge; designating the Bobby D. "Dirt Dobber" Smith
Memorial Bridge; designating the Ret. Air Force Major
General Albert Lee Logan Highway; designating the
Veteran's Memorial Highway; providing for
codification; repealing 69 O.S. 2011, Section 1673,
which relates to memorial highway designations; and
providing an effective date.

1 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

2 SECTION 1. NEW LAW A new section of law to be codified
3 in the Oklahoma Statutes as Section 1698.159 of Title 69, unless
4 there is created a duplication in numbering, reads as follows:

5 The bridge located on Interstate 44 near the junction of
6 Interstate 44 and N. Kelley Avenue in Oklahoma City shall be
7 designated as the "Maestro Kenneth Kilgore Memorial Bridge".

8 Pursuant to the provisions of Title 69 of the Oklahoma Statutes, the
9 Department of Transportation shall cause suitable permanent markers
10 to be placed upon the bridge bearing that name.

11 SECTION 2. NEW LAW A new section of law to be codified
12 in the Oklahoma Statutes as Section 1698.160 of Title 69, unless
13 there is created a duplication in numbering, reads as follows:

14 The bridge over Hickory Creek on U.S. Highway 77 between Oswalt
15 Road and Campbell Road in Love County shall be designated the "LCpl
16 Hatak-Yuka-Keyu Martin Yearby USMC Memorial Bridge". Pursuant to
17 the provisions of Title 69 of the Oklahoma Statutes, the Department
18 of Transportation shall cause suitable permanent markers to be
19 placed upon the bridge bearing that name.

20 SECTION 3. NEW LAW A new section of law to be codified
21 in the Oklahoma Statutes as Section 1698.161 of Title 69, unless
22 there is created a duplication in numbering, reads as follows:

23 The portion of U.S. Highway 70 from the municipal limits of
24 Idabel to the municipal limits of Garvin shall be designated as the

1 "Wayne Crusoe Memorial Highway". Pursuant to the provisions of
2 Title 69 of the Oklahoma Statutes, the Department of Transportation
3 shall cause suitable permanent markers to be placed upon the highway
4 bearing that name.

5 SECTION 4. NEW LAW A new section of law to be codified
6 in the Oklahoma Statutes as Section 1698.162 of Title 69, unless
7 there is created a duplication in numbering, reads as follows:

8 The portion of Interstate 35 beginning approximately two (2)
9 miles north of the intersection of Interstate 35 and State Highway
10 19 extending approximately two (2) miles to the south of the
11 intersection of Interstate 35 and State Highway 29 shall be
12 designated as the "Director Steven Stokes Memorial Highway".
13 Pursuant to the provisions of Title 69 of the Oklahoma Statutes, the
14 Department of Transportation shall cause suitable permanent markers
15 to be placed upon the highway bearing that name.

16 SECTION 5. NEW LAW A new section of law to be codified
17 in the Oklahoma Statutes as Section 1698.163 of Title 69, unless
18 there is created a duplication in numbering, reads as follows:

19 The bridge over Big Creek on State Highway 1 between Calvin and
20 Atwood in Hughes County shall be designated as the "Milton Irwin
21 Memorial Bridge". Pursuant to the provisions of Title 69 of the
22 Oklahoma Statutes, the Department of Transportation shall cause
23 suitable permanent markers to be placed upon the bridge bearing that
24 name.

1 SECTION 6. NEW LAW A new section of law to be codified
2 in the Oklahoma Statutes as Section 1698.164 of Title 69, unless
3 there is created a duplication in numbering, reads as follows:

4 The portion of Interstate 40 between exit number 79 and exit
5 number 82 shall be designated as the "Senator Ed Berrong Memorial
6 Highway". Pursuant to the provisions of Title 69 of the Oklahoma
7 Statutes, the Department of Transportation shall cause suitable
8 permanent markers to be placed upon the highway bearing that name.

9 SECTION 7. NEW LAW A new section of law to be codified
10 in the Oklahoma Statutes as Section 1698.165 of Title 69, unless
11 there is created a duplication in numbering, reads as follows:

12 The portion of Interstate 40 between mile marker 45 and mile
13 marker 55 shall be designated as the "Great Western Cattle Trail".
14 Pursuant to the provisions of Title 69 of the Oklahoma Statutes, the
15 Department of Transportation shall cause suitable permanent markers
16 to be placed upon the highway bearing that name.

17 SECTION 8. NEW LAW A new section of law to be codified
18 in the Oklahoma Statutes as Section 1698.166 of Title 69, unless
19 there is created a duplication in numbering, reads as follows:

20 The portion of State Highway 59 from the intersection of State
21 Highway 59 and State Highway 177 extending to the municipal limits
22 of St. Louis as the "Sergeant Bret Daniel Eisenhower Memorial
23 Highway". Pursuant to the provisions of Title 69 of the Oklahoma
24

1 Statutes, the Department of Transportation shall cause suitable
2 permanent markers to be placed upon the highway bearing that name.

3 SECTION 9. NEW LAW A new section of law to be codified
4 in the Oklahoma Statutes as Section 1698.167 of Title 69, unless
5 there is created a duplication in numbering, reads as follows:

6 The new bridge where U.S. Highway 177 crosses Dugout Creek
7 approximately one mile south of Perkins shall be designated as the
8 "Larry Tomlinson Memorial Bridge". Pursuant to the provisions of
9 Title 69 of the Oklahoma Statutes, the Department of Transportation
10 shall cause suitable permanent markers to be placed upon the bridge
11 bearing that name.

12 SECTION 10. NEW LAW A new section of law to be codified
13 in the Oklahoma Statutes as Section 1698.168 of Title 69, unless
14 there is created a duplication in numbering, reads as follows:

15 The new bridge where U.S. Highway 177 crosses the Cimarron River
16 approximately one-half mile south of Perkins shall be designated as
17 the "Phil Tomlinson Bridge". Pursuant to the provisions of Title 69
18 of the Oklahoma Statutes, the Department of Transportation shall
19 cause suitable permanent markers to be placed upon the bridge
20 bearing that name.

21 SECTION 11. NEW LAW A new section of law to be codified
22 in the Oklahoma Statutes as Section 1698.169 of Title 69, unless
23 there is created a duplication in numbering, reads as follows:

1 The portion of State Highway 3 between Antlers and Broken Bow
2 shall be designated as the "WWI Choctaw Code Talkers Highway".
3 Pursuant to the provisions of Title 69 of the Oklahoma Statutes, the
4 Department of Transportation shall cause suitable permanent markers
5 to be placed upon the highway bearing that name.

6 SECTION 12. NEW LAW A new section of law to be codified
7 in the Oklahoma Statutes as Section 1698.170 of Title 69, unless
8 there is created a duplication in numbering, reads as follows:

9 The bridge where U.S. Highway 69 crosses the Arkansas River at
10 the Wagoner and Muskogee county line shall be designated as the
11 "Specialist Joshua M. "Bubba" Seals Memorial Bridge". Pursuant to
12 the provisions of Title 69 of the Oklahoma Statutes, the Department
13 of Transportation shall cause suitable permanent markers to be
14 placed upon the bridge bearing that name.

15 SECTION 13. NEW LAW A new section of law to be codified
16 in the Oklahoma Statutes as Section 1698.171 of Title 69, unless
17 there is created a duplication in numbering, reads as follows:

18 The portion of State Highway 11 between the intersection of
19 State Highway 11 and Interstate 244 and the intersection of State
20 Highway 11 and U.S. Highway 75 shall be designated as the "PFC
21 Albert E. Schwab, Medal of Honor Memorial Highway". Pursuant to the
22 provisions of Title 69 of the Oklahoma Statutes, the Department of
23 Transportation shall cause suitable permanent markers to be placed
24 upon the highway bearing that name.

1 SECTION 14. NEW LAW A new section of law to be codified
2 in the Oklahoma Statutes as Section 1698.172 of Title 69, unless
3 there is created a duplication in numbering, reads as follows:

4 The bridge where U.S. Highway 169 crosses Bird Creek between
5 56th and 66th Streets North shall be designated as the "Rev. W.T.
6 "Tommy" Roberts Memorial Bridge". Pursuant to the provisions of
7 Title 69 of the Oklahoma Statutes, the Department of Transportation
8 shall cause suitable permanent markers to be placed upon the bridge
9 bearing that name.

10 SECTION 15. NEW LAW A new section of law to be codified
11 in the Oklahoma Statutes as Section 1698.173 of Title 69, unless
12 there is created a duplication in numbering, reads as follows:

13 The bridge over Cottonwood Creek on State Highway 33 in the City
14 of Guthrie, Logan County shall be designated the "Mayor Jon Gumerson
15 Memorial Bridge". Pursuant to the provisions of Title 69 of the
16 Oklahoma Statutes, the Department of Transportation shall cause
17 suitable permanent markers to be placed upon the bridge bearing that
18 name.

19 SECTION 16. NEW LAW A new section of law to be codified
20 in the Oklahoma Statutes as Section 1698.174 of Title 69, unless
21 there is created a duplication in numbering, reads as follows:

22 The bridge where State Highway 113 crosses Rock Creek
23 approximately three and one-half miles south of the intersection of
24 State Highway 113 and County Road 1280 in Pittsburg County shall be

1 designated as the "Bobby D. "Dirt Dobber" Smith Memorial Bridge".
2 Pursuant to the provisions of Title 69 of the Oklahoma Statutes, the
3 Department Of Transportation shall cause suitable permanent markers
4 to be placed upon the bridge bearing that name.

5 SECTION 17. NEW LAW A new section of law to be codified
6 in the Oklahoma Statutes as Section 1698.175 of Title 69, unless
7 there is created a duplication in numbering, reads as follows:

8 The portion of State Highway 1 from the municipal limits of
9 Ravia to the municipal limits of Mannsville shall be designated as
10 the "Ret. Air Force Major General Albert Lee Logan Highway".
11 Pursuant to the provisions of Title 69 of the Oklahoma Statutes, the
12 Department Of Transportation shall cause suitable permanent markers
13 to be placed upon the highway bearing that name.

14 SECTION 18. NEW LAW A new section of law to be codified
15 in the Oklahoma Statutes as Section 1698.176 of Title 69, unless
16 there is created a duplication in numbering, reads as follows:

17 The portion of U.S. Highway 62 from Willey Road to the western
18 municipal limits of Fort Gibson, Oklahoma, shall be designated as
19 the "Veteran's Memorial Highway". The Department of Transportation
20 shall cause suitable permanent markers to be placed on the highway
21 bearing that name.

1 SECTION 19. REPEALER 69 O.S. 2011, Section 1673, is
2 hereby repealed.

3 SECTION 20. This act shall become effective November 1, 2013.
