8 An Act relating to courts; amending 20 O.S. 2011,
9 Sections 92.22 and 92.23, which relate to judges of
10 the district courts; modifying number of district
11 court judges for certain districts; and providing an
12 effective date.

13 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

14 SECTION 1. AMENDATORY 20 O.S. 2011, Section 92.22, is
15 amended to read as follows:

16 Section 92.22 District No. 21. The counties of Garvin, McClain
17 and Cleveland. ~~Said~~ Until January 12, 2015, said district to have
18 four (4) district judges nominated as follows: Candidates for
19 office Nos. 1, 3 and 4 shall be nominated and elected at large and
20 legal residents of Cleveland County, and a candidate for office No.
21 2 shall be nominated and elected at large and a legal resident of
22 Garvin or McClain ~~county~~ County. Beginning January 12, 2015, said
23 district to have five (5) district judges nominated as follows:
24 Candidates for office Nos. 1, 3, 4 and 5 shall be nominated and

1 electd at large and legal residents of Cleveland County, and a
2 candidate for office No. 2 shall be nominated and elected at large
3 and a legal resident of Garvin or McClain County.

4 SECTION 2. AMENDATORY 20 O.S. 2011, Section 92.23, is
5 amended to read as follows:

6 Section 92.23 District No. 22. The counties of Seminole,
7 Hughes and Pontotoc. ~~Said~~ Until January 12, 2015, said district to
8 have three (3) district judges to be nominated and elected as
9 follows: One candidate to be nominated and elected at large and a
10 legal resident of Pontotoc County; one candidate to be nominated and
11 elected at large and a legal resident of Seminole or Hughes County;
12 and one candidate to be nominated and elected at large and a legal
13 resident of Seminole County. Beginning January 12, 2015, said
14 district to have two (2) district judges to be nominated and elected
15 as follows: One candidate to be nominated and elected at large and
16 a legal resident of Pontotoc County and one candidate to be
17 nominated and elected at large and a legal resident of Seminole or
18 Hughes County.

19 SECTION 3. This act shall become effective November 1, 2013.
