8 A Joint Resolution approving permanent rules of the  
State Board of Licensure for Professional Engineers  
9 and Land Surveyors; and directing distribution.

12 WHEREAS, pursuant to Section 308 of Title 75 of the Oklahoma  
13 Statutes, any rule which establishes or increases fees or any rule  
14 by an agency, board, or commission created by or that receives its  
15 authority from Title 59 of the Oklahoma Statutes shall require  
16 approval by the Legislature by joint resolution. If the Legislature  
17 fails to approve the rule on or before the last day of the  
18 legislative session, the rule shall be deemed disapproved; and

19 WHEREAS, the permanent rules adopted by the State Board of  
20 Licensure for Professional Engineers and Land Surveyors on March 29,  
21 2013, reflect the intent of the Oklahoma Legislature.

22 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES  
23 AND THE SENATE OF THE 1ST SESSION OF THE 54TH OKLAHOMA LEGISLATURE:

1           SECTION 1. The Legislature hereby approves the following
