8 An Act relating to state employee compensation;
9 providing for salary increases for certain state
10 employees; defining terms; providing for employees on
11 leave without pay on certain date; providing for
12 certain reinstated or reemployed employees; providing
13 limitations; providing for classified employees to
14 receive increase if pay band maximum exceeded;
15 prohibiting expenditure of funds appropriated for
16 purpose of implementing pay increase for certain
17 purpose; providing for construction of certain
18 provisions; providing for noncodification; providing
19 an effective date; and declaring an emergency.

20 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

21 SECTION 1. NEW LAW A new section of law not to be
22 codified in the Oklahoma Statutes reads as follows:

23 A. Effective July 1, 2014, full-time employees specified in
24 subsection B of this section, including temporary and other limited-
term employees of the state, who were employed by the state on the
last working day of June 2014, shall be awarded an annualized salary
increase equal to six and one-quarter percent (6.25%) of the
officer's or employee's annualized salary as of June 30, 2014.

1 Effective July 1, 2014, full-time employees specified in subsection
2 C of this section, including temporary and other limited-term
3 employees of the state, who were employed by the state on the last
4 working day of June 2014, shall be awarded an annualized salary
5 increase equal to eight percent (8%) of the officer's or employee's
6 annualized salary as of June 30, 2014.

7 B. The provisions of this section shall apply to the following:

8 1. Employees of the Alcoholic Beverage Laws Enforcement

9 Commission with the job titles of:

10 a. Law Enforcement ABLE Commission Agent, and

12 2. Employees of the Office of the Attorney General with the job

18 3. Employees of the Oklahoma State Bureau of Investigation with
19 the job titles of:

22 c. Crime Reporting Field Representative,

23 d. Law Enforcement Communications Specialist,

24 e. Physical Evidence Technician,

1 f. Criminal Intelligence Analyst,

4 4. Employees of the Oklahoma Corporation Commission with the
5 job title of Motor Vehicle Enforcement Officer;

12 Developmental Disabilities with the job titles of:

- 14 b. Licensed Practical Nurse,
- 15 c. Registered Nurse,
- 16 d. Direct Care Specialist, and
- 17 e. Volunteer Services Specialist;

18 14. Employees of the Oklahoma Office of Management and
19 Enterprise Services with the job title of Health Care Management
20 Nurse;

21 15. Employees of the Oklahoma Military Department with the job
22 titles of:

- 23 a. Firefighter,
- 24 b. Case Manager,

- c. Police Officer, and
- d. Airfield Firefighter;

16. Employees of the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control with the job titles of:

- a. Narcotic Agent V,
- b. Law Enforcement Communications Specialist,
- c. Physical Evidence Technician,
- d. Criminal Intelligence Analyst, and
- e. Law Enforcement Narcotics Agent;

17. Employees of the Office of Juvenile Affairs with the job titles of:

- a. Licensed Practical Nurse,
- b. Licensed Practical Nurse II,
- c. Juvenile Security Officer,
- d. Juvenile Justice Specialist,
- e. Registered Nurse,
- f. Registered Nurse II,

- b. Licensed Practical Nurse I, II and III,
- c. Registered Nurse I, II and III,
- d. Social Services Specialist,
- e. Patient Care Assistant,
- f. Licensed Practical Nurse, and
- g. Registered Nurse.

1 C. The provisions of this section shall apply to employees of
2 the State Department of Corrections with the job titles of:

- 3 1. Correctional Security Officer I, II, III and IV;
- 4 2. Correctional Security Manager I and II; and
- 5 3. Chief of Security I, II and III.

6 D. As used in this section, "temporary and other limited-term
7 employees" are those persons who:

- 8 1. Are not permanent employees;
- 9 2. Are not otherwise excluded by this section; and
- 10 3. Are compensated by an agency, board, commission, department
11 or other employing entity for a limited duration and without any
12 subjective expectation by either the employer or the employee that
13 the employment will become permanent.

14 E. Employees eligible for the increase provided for in
15 subsection A of this section who are on leave without pay on July 1,
16 2014, shall receive an annualized increase, effective upon their
17 return to work, but shall not receive any increase for a period of
18 time prior to their return to work.

19 F. Employees who leave the state service before July 1, 2014,
20 and who are reinstated or reemployed in the state service during
21 July 2014, without a break in service, who are otherwise eligible
22 for the pay increase provided for in this section, shall be granted
23 such raise effective immediately upon such reinstatement or
24 reemployment. As used in this subsection, "break in service" is

1 defined as a period of time in excess of thirty (30) calendar days
2 between two periods of state employment.

3 G. No salary increase pursuant to this section shall be made
4 that exceeds a salary limitation provided in an agency's annual
5 appropriation bill or that exceeds the recommendations of the 2013
6 State Employee Total Remuneration Study. Classified employees
7 eligible for the salary increase provided for in this section shall
8 receive such increase even if it causes the employee's salary to
9 exceed the maximum for the employee's pay band.

10 SECTION 2. NEW LAW A new section of law not to be
11 codified in the Oklahoma Statutes reads as follows:

12 No funds appropriated for the purpose of implementing the pay
13 increase provided in Section 1 of this act shall be expended by any
14 employing public agency, board, commission or other public employing
15 entity in order to increase compensation for persons employed by a
16 private business entity that has entered into a contract with the
17 public employing entity to provide personnel services or temporary
18 services to the public employing entity in order for the public
19 employing entity to perform duties imposed upon it by law or
20 functions which the public employing entity is authorized to perform
21 by law. The provisions of this section shall not be construed to
22 prohibit increases in compensation to a vendor performing other
23 types of services pursuant to a sole source contract or contract
24 awarded pursuant to The Oklahoma Central Purchasing Act.

1 SECTION 3. This act shall become effective July 1, 2014.

2 SECTION 4. It being immediately necessary for the preservation
3 of the public peace, health and safety, an emergency is hereby
4 declared to exist, by reason whereof this act shall take effect and
5 be in full force from and after its passage and approval.
