A Joint Resolution approving permanent rules of the Board of Chiropractic Examiners; and directing distribution.

SUBJECT: Permanent rules of the Board of Chiropractic Examiners

WHEREAS, pursuant to Section 308 of Title 75 of the Oklahoma Statutes, any rule which establishes or increases fees or any rule by an agency, board, or commission created by or that receives its authority from Title 59 of the Oklahoma Statutes shall require approval by the Legislature by joint resolution. If the Legislature fails to approve the rule on or before the last day of the legislative session, the rule shall be deemed disapproved; and

WHEREAS, except for OAC 140:10-1-1, 140:10-1-2, 140:10-3-10, 140:10-5-3, and 140:10-8-1(O), (Q), (R) and (S), the permanent rules adopted by the Board of Chiropractic Examiners on March 7 and March 13, 2013, reflect the intent of the Oklahoma Legislature.

NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES AND THE SENATE OF THE 1ST SESSION OF THE 54TH OKLAHOMA LEGISLATURE:

SECTION 1. The Legislature hereby approves the following permanent rules, which were adopted by the Board of Chiropractic Examiners on March 7 and March 13, 2013: OAC 140:1-1-2, 140:3-3-2, 140:3-3-9, 140:10-5-1, 140:10-8-1 except (O), (Q), (R) and (S), 140:15-5-1, 140:15-5-4, 140:15-8-3, 140:30-1-1, 140:30-1-2, 140:30-3-1, 140:30-3-2, 140:30-3-3, 140:30-3-4, 140:30-3-5, 140:30-3-6 and 140:30-3-7.

SECTION 2. The Secretary of State is directed to distribute copies of this resolution to the Governor, the Board of Chiropractic Examiners, and the editor of "The Oklahoma Register".
