A Concurrent Resolution commending Ron D. Burton of  
Norman, 2013-2014 President of Rotary International;  
and directing distribution.

WHEREAS, Ron D. Burton of Norman, Oklahoma, a member of the  
Norman Rotary Club, was elected as 2013-2014 President of Rotary  
International, an international service organization with more than  
34,282 clubs and 1.2 million members worldwide; and

WHEREAS, Burton has been a Rotarian since 1979 and has served  
Rotary International as a director, representative of the Rotary  
International President, zone trainer, International Assembly group

discussion leader and moderator, Council on Legislation representative, and district governor. He also chaired the 2011 New Orleans Convention Committee; and

WHEREAS, Burton has served The Rotary Foundation as vice chair and member of the Foundation Trustees and as a regional Rotary Foundation coordinator and moderator of the regional Rotary Foundation coordinator training program; and

WHEREAS, Burton's extensive service stretches far beyond Rotary International. In 2007, Burton retired as president of the University of Oklahoma Foundation. He is also a member of the U.S. Supreme Court Bar, the Oklahoma Bar Association, the ABA Section of Taxation Exempt Organizations Committee, and the ABA Section of Real Property, Probate, and Trust Committee on Charitable Organizations; and

WHEREAS, Burton and his wife, Jetta, are Paul Harris Fellows, Benefactors, Major Donors, and members of the Paul Harris, Bequest, and Arch C. Klumph Societies; and

WHEREAS, as the President of Rotary International, Ron Burton has brought credit to his organization and state as he has met with Presidents of countries, visited with the Pope and traveled the world spreading Rotary's message of neighbors, community leaders and global citizens working, uniting for the common good; and

WHEREAS, in developing the theme for his Presidential year, Ron Burton selected the official light blue of Rotary International, the sky blue of the Oklahoma State Flag and the Crimson of his former employer, THE University of Oklahoma, bringing a touch of Oklahoma symbolism to the Rotary Theme.
