1 "SECTION 17. AMENDATORY Section 3, Chapter 367, O.S.L.  
2 2012, as amended by Section 4, Chapter 212, O.S.L. 2013 (70 O.S.  
3 Supp. 2013, Section 3-145.1), is amended to read as follows:

4 Section 3-145.1 A. There is hereby created the ~~Statewide~~  
5 ~~Virtual Public~~ Charter School ~~Board~~ Commission. ~~The Board Beginning~~  
6 July 1, 2014, the Commission shall have the sole authority to  
7 authorize ~~and sponsor~~ statewide virtual public charter schools in  
8 any school district in this state and beginning November 1, 2014,  
9 shall have authority to authorize public charter schools in any  
10 school district in this state. The ~~Board~~ Commission shall be  
11 composed of five (5) voting members as follows:

12 1. One member appointed by the Governor, who shall be a  
13 resident and elector of the Fifth Congressional District;

14 2. Two members appointed by the President Pro Tempore of the  
15 Senate, one of whom shall be a resident and elector of the First  
16 Congressional District and one of whom shall be a resident and  
17 elector of the Third Congressional District; and

18 3. Two members appointed by the Speaker of the House of  
19 Representatives, one of whom shall be a resident and elector of the  
20 Second Congressional District and one of whom shall be a resident  
21 and elector of the Fourth Congressional District; ~~and.~~

22 4. B. The State Superintendent of Public Instruction and the  
23 Secretary of Education or their designees shall serve as ex officio  
24 nonvoting members, and shall not be counted toward a quorum.

1        ~~B.~~ C. Initial appointments shall be made by August 1, 2012.  
2 The President Pro Tempore of the Senate and the Speaker of the House  
3 of Representatives shall each appoint one member for one (1) year  
4 and one member for three (3) years. The Governor shall appoint one  
5 member for two (2) years. Members shall serve until their  
6 successors are duly appointed for a term of three (3) years.  
7 Appointments shall be made by and take effect on November 1 of the  
8 year in which the appointment is made. Any member serving on the  
9 Statewide Virtual Charter School Board prior to the effective date  
10 of this act shall continue to serve on the Public Charter School  
11 Commission. Annually by December 30 the ~~Board~~ Commission shall  
12 elect from its membership a chair and vice-chair.

13        ~~C.~~ D. A member may be removed from the ~~Board~~ Commission by the  
14 appointing authority for cause which shall include, but not be  
15 limited to:

16            1. Being found guilty by a court of competent jurisdiction of a  
17 felony or any offense involving moral turpitude;

18            2. Being found guilty of malfeasance, misfeasance or  
19 nonfeasance in relation to ~~Board~~ Commission duties;

20            3. Being found mentally incompetent by a court of competent  
21 jurisdiction; or

22            4. Failing to attend three successive meetings of the ~~Board~~  
23 Commission without just cause, as determined by the ~~Board~~  
24 Commission.

1       ~~D.~~ E. Vacancies shall be filled by the appointing authority.

2       ~~E.~~ F. No member of the Senate or House of Representatives may  
3 be appointed to the ~~Board~~ Commission while serving as a member of  
4 the Legislature, or for two (2) full years following the expiration  
5 of the term of office.

6       ~~F.~~ G. The ~~State Department of Education~~ Commission shall  
7 ~~provide staff support to the Board until December 31, 2014, and~~  
8 ~~thereafter the Department shall provide office space for the~~  
9 ~~operation of the Board~~ promulgate rules as may be necessary to  
10 implement the provisions of the Public Charter School Accountability  
11 and Authorization Act in accordance with Article I of the  
12 Administrative Procedures Act."
