1 "SECTION 1. AMENDATORY 74 O.S. 2011, Section 85.22, is
2 amended to read as follows:

3 Section 85.22 Any competitive bid submitted to the State of
4 Oklahoma or contract executed by the state for goods or services in
5 excess of Five Thousand Dollars (\$5,000.00) shall contain a
6 certification, which shall be in substantially the following form:

7 A. For purposes of competitive bids, I certify:

8 1. I am the duly authorized agent of _____, the bidder
9 submitting the competitive bid which is attached to this statement,
10 for the purpose of certifying the facts pertaining to the existence
11 of collusion among bidders and between bidders and state officials
12 or employees, as well as facts pertaining to the giving or offering
13 of things of value to government personnel in return for special
14 consideration in the letting of any contract pursuant to the bid to
15 which this statement is attached;

16 2. I am fully aware of the facts and circumstances surrounding
17 the making of the bid to which this statement is attached and have
18 been personally and directly involved in the proceedings leading to
19 the submission of such bid; and

20 3. Neither the bidder nor anyone subject to the bidder's
21 direction or control has been a party:

22 a. to any collusion among bidders in restraint of freedom
23 of competition by agreement to bid at a fixed price or
24 to refrain from bidding,

- 1 b. to any collusion with any state official or employee
2 as to quantity, quality or price in the prospective
3 contract, or as to any other terms of such prospective
4 contract, ~~nor~~
- 5 c. in any discussions between bidders and any state
6 official concerning exchange of money or other thing
7 of value for special consideration in the letting of a
8 contract, nor
- 9 d. to any efforts or offers with state agency or
10 political subdivision officials or others to create a
11 sole brand acquisition or a sole source acquisition in
12 contradiction to Section 2 of this act.

13 B. I certify, if awarded the contract, whether competitively
14 bid or not, neither the contractor nor anyone subject to the
15 contractor's direction or control has paid, given or donated or
16 agreed to pay, give or donate to any officer or employee of the
17 State of Oklahoma any money or other thing of value, either directly
18 or indirectly, in procuring the contract to which this statement is
19 attached.
