9 | pursuant to Section 903(d) of the Social Security Act, 42 U.S.C.,  
10 | Section 1103(d), as amended, the sum of Eleven Million Two Hundred  
11 | Thirty-six Thousand Seven Hundred Seventy-five Dollars and seventy-  
12 | six cents (\$11,236,775.76) to be used by the Oklahoma Employment  
13 | Security Commission for the purpose of paying the administrative  
14 | expenses of the following programs in the following amounts:

15 | 1. Employer Service Program in the amount of Six Million Three  
16 | Hundred Thirty-five Thousand Eight Hundred Sixty-nine Dollars and  
17 | sixty-four cents (\$6,335,869.64); and

18 | 2. Unemployment Insurance Program in the amount of Four Million  
19 | Nine Hundred Thousand Nine Hundred Six Dollars and twelve cents  
20 | (\$4,900,906.12).

21 | The funds appropriated by this section shall be expended before  
22 | December 15, 2015. Expenditures from this appropriation shall be  
23 | accounted for in accordance with standards established by the United  
24 | States Secretary of Labor. The Oklahoma Employment Security

1 Commission shall utilize the appropriation made by this section in  
2 accordance with the provisions and requirements contained in the  
3 Social Security Act, Title 42 of the United States Code.

4 SECTION 3. There is hereby appropriated to the Employment  
5 Security Administration Fund, out of funds made available to this  
6 state by the federal Unemployment Compensation Modernization  
7 Transfer made on June 25, 2009, pursuant to Section 903(f) of the  
8 Social Security Act, 42 U.S.C., Section 1103(f), as amended, the sum  
9 of Five Hundred Ninety-nine Thousand Ninety-three Dollars and  
10 eighty-eight cents (\$599,093.88) to be used by the Oklahoma  
11 Employment Security Commission for the purpose of paying the  
12 administrative expenses of the Unemployment Insurance Program.

13 The funds appropriated by this section shall be expended before  
14 December 15, 2015. Expenditures from this appropriation shall be  
15 accounted for in accordance with standards established by the United  
16 States Secretary of Labor. The Oklahoma Employment Security  
17 Commission shall utilize the appropriation made by this section in  
18 accordance with the provisions and requirements contained in the  
19 Social Security Act, Title 42 of the United States Code.

20 SECTION 4. This act shall become effective November 1, 2014.
