10 COMMITTEE SUBSTITUTE

11 An Act relating to extramural athletic competition;
12 amending 70 O.S. 2011, Section 8-103.2, which relates
13 to rules governing eligibility for extramural
14 athletic competition for transfer students; updating
15 statutory references; authorizing the Oklahoma
16 Secondary School Activities Association to utilize an
17 administrative law judge for determining eligibility;
18 and declaring an emergency.

19 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

20 SECTION 1. AMENDATORY 70 O.S. 2011, Section 8-103.2, is
21 amended to read as follows:

22 Section 8-103.2 A. Except as otherwise provided, a student who
23 enrolls, pursuant to the Education Open Transfer Act or pursuant to
24 Section ~~2~~ 8-113 of this ~~act~~ title, in a school district in which the
student is not a resident shall not be eligible to participate in

1 school-related extramural athletic competition governed by the
2 Oklahoma Secondary School Activities Association for a period of one
3 (1) year from the first day of attendance at the receiving school
4 unless the transfer is from a school district which does not offer
5 the grade the student is entitled to pursue.

6 B. If the student is granted an emergency transfer pursuant to
7 Section 8-104 of this title, was granted a transfer for any reason
8 prior to January 1, 2000, or enrolls pursuant to the Education Open
9 Transfer Act and qualifies for a hardship waiver pursuant to the
10 rules of the Oklahoma Secondary School Activities Association,
11 ~~eligibility to participate in school-related extramural athletic~~
12 ~~competition shall be determined by~~ the Oklahoma Secondary School
13 Activities Association may utilize an administrative law judge to
14 conduct hearings regarding student eligibility to participate in
15 school-related extramural athletic competition.

16 SECTION 2. It being immediately necessary for the preservation
17 of the public peace, health and safety, an emergency is hereby
18 declared to exist, by reason whereof this act shall take effect and
19 be in full force from and after its passage and approval.
