

1 SECTION 2. AMENDATORY 75 O.S. 2011, Section 14, is
2 amended to read as follows:

3 Section 14. A. The following officers shall be entitled to
4 receive as soon as available from the state without cost copies of
5 the printed volumes of the statutes and session laws of the state
6 ~~published or purchased by the Legislature~~ Secretary of State, or
7 under ~~its~~ the authority of the Secretary of State, for distribution:

8 1. Each state officer, including the Governor and Lieutenant
9 Governor, the chief administrative officers and assistants of state
10 departments, boards, and commissions, upon written application and
11 request submitted to the ~~Chief Clerk Administrator of the Oklahoma~~
12 ~~House of Representatives~~ Secretary of State, within sixty (60) days
13 of January 1 of each year, and said volumes shall be distributed at
14 the discretion of the ~~Chief Clerk Administrator of the Oklahoma~~
15 ~~House of Representatives~~ Secretary of State; and

16 2. Each member of the Legislature; and

17 3. The Justices of the Supreme Court and the Judges of the
18 Court of Criminal Appeals, and the clerk of said Courts; and

19 4. The chief administrative officers of the state educational,
20 benevolent, and penal institutions; and

21 5. The judges of the district courts and district court clerks;
22 and

23 6. County clerks; and

24 7. County treasurers; and

- 1 8. County assessors; and
- 2 9. District attorneys and one assistant district attorney in
- 3 each county; and
- 4 10. Sheriffs; and
- 5 11. All members of the Oklahoma Congressional Delegation; and
- 6 12. Each library association organized in any county, city, or
- 7 town in this state for the benefit of the public.

8 B. Fifty-five (55) copies of the statutes and session laws

9 shall be furnished to the law library of the College of Law of the

10 University of Oklahoma, five copies to be kept for use therein and

11 fifty copies for purposes of exchange.

12 C. Five (5) copies of the statutes and session laws shall be

13 placed in the library of Oklahoma State University at Stillwater,

14 Oklahoma, for use therein.

15 D. One hundred ten (110) copies of the statutes and session

16 laws shall be furnished to the Oklahoma Department of Libraries for

17 its use and exchange purposes.

18 E. The ~~Chief Clerk-Administrator~~ Secretary of State may, in his

19 or her discretion, furnish from any copies of such laws on hand to

20 state officers other than those specified in this section for the

21 use of their offices.

22 SECTION 3. AMENDATORY 75 O.S. 2011, Section 17, is

23 amended to read as follows:

1 Section 17. The county clerks of the several counties of this
2 state, by the first Monday of February next succeeding the time when
3 any regular session of the Legislature shall be held, shall make a
4 requisition upon the ~~Chief Clerk-Administrator of the House of~~
5 ~~Representatives~~ Secretary of State for as many copies of the laws of
6 said session as may be required to supply one copy to each county or
7 township officer entitled to the same pursuant to the provisions of
8 Section 14 of this title. The ~~Chief Clerk-Administrator~~ Secretary
9 of State shall forward the number of copies called for by said
10 requisition, to said clerk, either by express, or in any other
11 secure manner. The county clerk, upon receiving the laws, shall
12 distribute them to the several officers entitled by law to the same,
13 obtaining a receipt describing the volumes and the date delivered,
14 which shall be filed in the office of the county clerk.

15 SECTION 4. This act shall become effective July 1, 2014.

16 SECTION 5. It being immediately necessary for the preservation
17 of the public peace, health and safety, an emergency is hereby
18 declared to exist, by reason whereof this act shall take effect and
19 be in full force from and after its passage and approval.
