9 A Joint Resolution disapproving permanent rules of
10 the State Board of Education; and directing
11 distribution.

13 WHEREAS, pursuant to Sections 250.2 and 308 of Title 75 of the
14 Oklahoma Statutes, the Legislature reserves the right to designate
15 the method for rule promulgation, establish policy, determine that a
16 rule is not consistent with legislative intent and disapprove any
17 rule or portion thereof at any time; and

18 WHEREAS, the permanent rules of the State Board of Education
19 which were adopted on March 28, 2013, do not reflect the intent of
20 the Oklahoma Legislature.

21 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES
22 AND THE SENATE OF THE 1ST SESSION OF THE 54TH OKLAHOMA LEGISLATURE:
