7 AS INTRODUCED

8 A Resolution stating legislative intent not to
9 approve further adoption of Common Core State
10 Standards until certain costs are ascertained;
11 directing the State Board of Education to prepare and
12 submit a report on the implementation of the Common
13 Core State Standards; specifying contents of the
14 report; and directing distribution.

15 WHEREAS, the economy of the United States has been in an
16 economic downturn for the past five years and continues to
17 underperform and is in a state of flux and uncertainty; and

18 WHEREAS, the state of this economic uncertainty has affected the
19 economic condition of the State of Oklahoma, causing it to also
20 underperform; and

21 WHEREAS, the state revenues of Oklahoma have suffered with at
22 least three years of reduced funding for most agencies, including
23 common education, over the past two legislative sessions; and

24 WHEREAS, it is incumbent upon legislators to prudently assess
the cost, outcomes and advisability of expenditures in every area of

1 government, but most especially those expenditures in the largest
2 area of state government, which is common education; and

3 WHEREAS, it is incumbent upon legislators to assess the cost to
4 the state of adopting the Common Core State Standards, in their
5 entirety, along with the concomitant changes to Oklahoma education,
6 including but not limited to vast changes in testing, textbooks,
7 teacher evaluation, and school performance.

8 NOW, THEREFORE, BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES
9 OF THE 1ST SESSION OF THE 54TH OKLAHOMA LEGISLATURE:

10 THAT it is the intent of the Oklahoma Legislature that no
11 further approval of adoption of Common Core State Standards shall be
12 made until a fiscal analysis of the totality of the cost,
13 precipitated by the Common Core State Standards changes, can be
14 ascertained with a high degree of certainty and the true extent of
15 the expenditures, necessitated by these changes, is made known.

16 THAT the Oklahoma House of Representative hereby directs the
17 State Board of Education to prepare and submit by December 1, 2013,
18 a report to the Speaker of the Oklahoma House of Representatives
19 containing the following information concerning the implementation
20 of the Common Core State Standards or Oklahoma C3 Standards:

21 1. The total amount of funds expended by the State Department
22 of Education and by school districts from the fiscal year ending
23 June 30, 2011, through the fiscal year ending June 30, 2013, on
24 adopting the Common Core State Standards, developing and

1 implementing the Oklahoma C3 Standards, providing assistance to
2 school districts through resource development and professional
3 development opportunities and in participating in the development of
4 a Common Core assessment system through the Partnership for
5 Assessment of Readiness for College and Careers (PARCC);

6 2. The total amount of funds the State Department of Education
7 and school districts have budgeted or expects to expend in the
8 upcoming fiscal years on developing and implementing the Oklahoma C3
9 Standards, providing assistance to school districts through resource
10 development and professional development opportunities and in
11 participating in the development of a Common Core assessment system
12 through the Partnership for Assessment of Readiness for College and
13 Careers (PARCC);

14 3. A side-by-side comparison in each subject area of the
15 Priority Academic Students Skills prior to adoption of the Common
16 Core State Standards to the Oklahoma C3 Standards, with a
17 description of the changes;

18 4. The total amount of funds the State Department of Education
19 has expended, has budgeted or expects to expend in the upcoming
20 fiscal years on transitioning the current state criterion-referenced
21 assessments to the Common Core assessment system being developed by
22 the Partnership for Assessment of Readiness for College and Careers
23 (PARCC);

1 5. A summary of changes in the current criterion-referenced
2 assessment or the development and adoption of new assessments that
3 will be needed to transition to the Common Core assessment system
4 being developed by the Partnership for Assessment of Readiness for
5 College and Careers (PARCC). In addition the summary shall include
6 an assessment of the current technology capacity of the State
7 Department of Education and school districts and the amount and cost
8 of additional technology that the Department and school districts
9 will need in order to administer the new online assessments; and

10 6. A summary of the impact of implementing the Oklahoma C3
11 Standards on textbooks, the state textbook adoption process, and
12 teacher evaluations.

13 THAT a copy of this resolution be distributed to the State Board
14 of Education and the State Superintendent of Public Instruction.
