8 **[motor vehicle registration and titling - deleting**
9 **authorization for certain plate - effective date]**

11 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

12 SECTION 1. AMENDATORY 47 O.S. 2011, Section 1135.2, as
13 amended by Section 1, Chapter 204, O.S.L. 2012 (47 O.S. Supp. 2012,
14 Section 1135.2), is amended to read as follows:

15 Section 1135.2. A. The Oklahoma Tax Commission is hereby
16 authorized to design and issue appropriate official special license
17 plates to persons in recognition of their service or awards as
18 provided by this section.

19 Special license plates shall not be transferred to any other
20 person but shall be removed from the vehicle upon transfer of
21 ownership and retained. The special license plate may then be used
22 on another vehicle but only after such other vehicle has been
23 registered for the current year.

1 Special license plates shall be renewed each year by the Tax
2 Commission or a motor license agent. The Tax Commission shall
3 annually notify by mail all persons issued special license plates.
4 The notice shall contain all necessary information and shall contain
5 instructions for the renewal procedure upon presentation to a motor
6 license agent or the Tax Commission. The license plates shall be
7 issued on a staggered system except for legislative plates and
8 amateur radio operator license plates.

9 The Tax Commission is hereby directed to develop and implement a
10 system whereby motor license agents are permitted to accept
11 applications for special license plates authorized under this
12 section. The motor license agent shall confirm the applicant's
13 eligibility, if applicable, collect and deposit any amount
14 specifically authorized by law, accept and process the necessary
15 information directly into such system and generate a receipt
16 accordingly. For performance of these duties, motor license agents
17 shall retain the fee provided in Section 1141.1 of this title for
18 registration of a motor vehicle. The motor license agent fees for
19 acceptance of applications and renewals shall be paid out of the
20 Oklahoma Tax Commission Reimbursement Fund.

21 B. The special license plates provided by this section are as
22 follows:

23 1. Prisoner of War License Plates - such plates shall be
24 designed for honorably discharged or present members of the United

1 States Armed Forces and civilians who were former prisoners of war
2 held by a foreign country and who can provide proper certification
3 of that status. Such persons may apply for a prisoner of war
4 license plate for no more than two vehicles with each vehicle having
5 a rated carrying capacity of one (1) ton or less. The surviving
6 spouse of any deceased former prisoner of war, if the spouse has not
7 since remarried, or if remarried, the remarriage is terminated by
8 death, divorce, or annulment, may apply for a prisoner of war
9 license plate for one vehicle with a rated carrying capacity of one
10 (1) ton or less. The fee provided by this section for the special
11 license plate authorized by this paragraph shall be in addition to
12 all other registration fees provided by law, except the registration
13 fees levied by Section 1132 of this title;

14 2. National Guard License Plates - such plates shall be
15 designed for active or retired members of the Oklahoma National
16 Guard. Retirees who are eligible for such plates shall provide
17 proof of eligibility upon initial application, but shall not be
18 required to provide proof of eligibility annually;

19 3. Air National Guard License Plates - such plates shall be
20 designed for active or retired members of the Oklahoma Air National
21 Guard. Retirees who are eligible for such plates shall provide
22 proof of eligibility upon initial application, but shall not be
23 required to provide proof of eligibility annually;

24

1 4. United States Armed Forces - such plates shall be designed
2 for active, retired, former or reserve members of the United States
3 Armed Forces, and shall identify which branch of service, and carry
4 the emblem and name of either the Army, Navy, Air Force, Marines or
5 Coast Guard, according to the branch of service to which the member
6 belongs or did belong. Former members who have been dishonorably
7 discharged shall not be eligible for such plates. Persons applying
8 for such license plate must show proof of present or past military
9 service by presenting a valid Uniformed Services Identity Card or
10 the United States Department of Defense Form (DD)214. Retired or
11 former members who are eligible for such plates shall provide proof
12 of eligibility upon initial application, but shall not be required
13 to provide proof of eligibility annually;

14 5. Congressional Medal of Honor Recipient License Plates - such
15 plates shall be designed for any resident of this state who has been
16 awarded the Congressional Medal of Honor. Such persons may apply
17 for a Congressional Medal of Honor recipient license plate for each
18 vehicle with a rated carrying capacity of one (1) ton or less.
19 There shall be no registration fee for the issuance of this plate;

20 6. Missing In Action License Plates - such plates shall be
21 designed to honor members of the United States Armed Forces who are
22 missing in action. The spouse of such missing person, if the spouse
23 has not since remarried, or if remarried, the remarriage is
24 terminated by death, divorce, or annulment, and each parent of the

1 missing person may apply for a missing in action license plate upon
2 presenting proper certification that the person is missing in action
3 and that the person making the application is the qualifying spouse
4 or the parent of the missing person. The qualifying spouse and each
5 parent of the missing person may each apply for the missing in
6 action license plate for each vehicle with a rated carrying capacity
7 of one (1) ton or less;

8 7. Purple Heart Recipient License Plates - such plates shall be
9 designed for any resident of this state presenting proper
10 certification from the United States Department of Veterans Affairs
11 or the Armed Forces of the United States certifying that such
12 resident has been awarded the Purple Heart military decoration.
13 Such persons may apply for a Purple Heart recipient license plate
14 for vehicles having a rated carrying capacity of one (1) ton or
15 less. The surviving spouse of any deceased veteran who has been
16 awarded the Purple Heart military decoration, if such spouse has not
17 since remarried, or if remarried, the remarriage has been terminated
18 by death, divorce or annulment, may apply for such plate for one
19 vehicle with a rated carrying capacity of one (1) ton or less;

20 8. Pearl Harbor Survivor License Plates - such plates shall be
21 designed for any resident of this state who can be verified by the
22 United States Department of Veterans Affairs or the Armed Forces of
23 the United States as being:

24

- 1 a. a member of the United States Armed Forces on December
2 7, 1941,
3 b. stationed on December 7, 1941, during the hours of
4 7:55 a.m. to 9:45 a.m. Hawaii time at Pearl Harbor,
5 the island of Oahu, or offshore at a distance not to
6 exceed three (3) miles, and
7 c. a recipient of an honorable discharge from the United
8 States Armed Forces.

9 Such person may apply for a Pearl Harbor Survivor license plate
10 for each vehicle with a rated carrying capacity of one (1) ton or
11 less;

12 9. Iwo Jima License Plates - such plates shall be designed for
13 any resident of this state who can be verified by the United States
14 Department of Veterans Affairs or the Armed Forces of the United
15 States as being:

- 16 a. a member of the United States Armed Forces in February
17 of 1945,
18 b. stationed in February of 1945 on or in the immediate
19 vicinity of the island of Iwo Jima, and
20 c. a recipient of an honorable discharge from the United
21 States Armed Forces.

22 Such person may apply for an Iwo Jima license plate for each
23 vehicle with a rated carrying capacity of one (1) ton or less.
24

1 Such license plate shall have the legend "Oklahoma OK" and shall
2 contain three letters and three numbers. Between the letters and
3 numbers shall be a logo of the flag-raising at Iwo Jima. Below the
4 letters, logo and numbers, the plate shall contain the words "FEB."
5 at the left, "Iwo Jima" in the center and "1945" at the right. Such
6 plates shall not be subject to the design requirements of any other
7 license plates prescribed by law other than the space for the
8 placement of the yearly decals for each succeeding year of
9 registration after the initial issue;

10 10. D-Day Survivor License Plates - such plates shall be
11 designed for any resident of this state who can be verified by the
12 United States Department of Veterans Affairs or the Armed Forces of
13 the United States as being:

- 14 a. a member of the United States Armed Forces on June 6,
15 1944,
- 16 b. a participant in the Allied invasion of the coast of
17 Normandy on June 6, 1944; provided, if such
18 participation cannot be verified by the United States
19 Department of Veterans Affairs or the Armed Forces of
20 the United States, the Tax Commission may, in its
21 discretion, accept evidence of such participation from
22 the person applying for the license plate, and
- 23 c. a recipient of an honorable discharge from the United
24 States Armed Forces.

1 Such person may apply for a D-Day Survivor license plate for
2 each vehicle with a rated carrying capacity of one (1) ton or less;

3 11. Killed in Action License Plates - such plates shall be
4 designed to honor members of the United States Armed Forces who were
5 killed in action. The spouse of the deceased person, if the spouse
6 has not remarried, or if remarried, the remarriage is terminated by
7 death, divorce, or annulment, may apply for a killed in action
8 license plate upon presenting proper certification that the person
9 was killed in action and that the person making the application is
10 the qualifying spouse of the deceased person. The qualifying spouse
11 may apply for a killed in action license plate for no more than two
12 vehicles with each vehicle with a rated carrying capacity of one (1)
13 ton or less. The fee provided by this section for the special
14 license plate authorized by this paragraph shall be in addition to
15 all other registration fees provided by law, except the registration
16 fees levied by Section 1132 of this title;

17 12. Gold Star Parents License Plates - such plates shall be
18 designed to honor members of the United States Armed Forces who were
19 killed during a war. The parents of the deceased person may apply
20 for a gold star license plate upon presenting proper certification
21 that the person was killed during a war and that the person making
22 the application is the parent of the deceased person. The parent
23 may apply for a gold star parent license plate for no more than two
24 vehicles with each vehicle having a rated carrying capacity of one

1 (1) ton or less. The fee provided by this section for the special
2 license plate authorized by this paragraph shall be in addition to
3 all other registration fees provided by law, except the registration
4 fees levied by Section 1132 of this title;

5 13. Military Decoration License Plates - such plates shall be
6 designed for any resident of this state who has been awarded the
7 Distinguished Service Medal, the Distinguished Service Cross, the
8 Distinguished Flying Cross, the Bronze Star military decoration or
9 the Silver Star military decoration. Such persons may apply for a
10 military decoration license plate for each vehicle with a rated
11 carrying capacity of one (1) ton or less;

12 14. Vietnam Veteran License Plates - such plates shall be
13 designed for honorably discharged or present members of the United
14 States Armed Forces who served in the Vietnam Conflict. Such
15 persons may apply for a Vietnam veteran license plate for each
16 vehicle with a rated carrying capacity of one (1) ton or less;

17 15. Police Officer License Plates - such plates shall be
18 designed for any currently employed, reserve or retired municipal
19 police officer or full-time, reserve or retired university police
20 officer certified by the Council on Law Enforcement Education and
21 Training or common education police officer certified by the Council
22 on Law Enforcement Education and Training. Police officers may
23 apply for police officer license plates for vehicles with a rated
24 capacity of one (1) ton or less or for a motorcycle upon proof of

1 employment by or retirement from a municipal, university or common
2 education police department by either an identification card or
3 letter from the chief of the police department or the Oklahoma
4 Police Pension and Retirement Board. Retirees who are eligible for
5 such plates shall provide proof of eligibility upon initial
6 application, but shall not be required to provide proof of
7 eligibility annually. The license plates shall be designed in
8 consultation with municipal police departments of this state;
9 provided, the license plate for motorcycles may be of similar design
10 to the license plate for motor vehicles or may be a new design in
11 order to meet space requirements for a motorcycle license plate;

12 16. World War II Veteran License Plates - such plates shall be
13 designed to honor honorably discharged former members of the United
14 States Armed Forces who are residents of this state and who can be
15 verified by the Oklahoma Military Department, the Department of
16 Veterans Affairs or the Armed Forces of the United States as having
17 served on federal active duty anytime during the period from
18 September 16, 1940, to December 7, 1945. The former members may
19 apply for a World War II Veteran license plate for vehicles with a
20 rated carrying capacity of one (1) ton or less.

21 The license plate shall have the legend "Oklahoma" and shall
22 contain, in the center of the plate, either the Thunderbird Insignia
23 of the 45th Infantry Division in the prescribed red and gold
24 coloring or the emblem of the Army, Navy, Air Force, Marines or

1 Coast Guard according to the branch of service to which the member
2 belonged. For the purpose of license plate identification, the
3 plate shall contain four digits, two digits at the left and two
4 digits at the right of the insignia or emblem. Centered on the
5 bottom of the license plate shall be the words "WORLD WAR II";

6 17. Korean War Veteran License Plates - such plates shall be
7 designed to honor honorably discharged former members of the United
8 States Armed Forces who are residents of this state and who can be
9 verified by the Oklahoma Military Department, the Department of
10 Veterans Affairs or the Armed Forces of the United States as having
11 served on federal active duty anytime during the period from June
12 27, 1950, to January 31, 1955, both dates inclusive. The former
13 members may apply for a Korean War Veteran license plate for
14 vehicles with a rated carrying capacity of one (1) ton or less.

15 The license plate shall have the legend "OKLAHOMA" and shall
16 contain, in the center of the plate, either the Thunderbird Insignia
17 of the 45th Infantry Division in the prescribed red and gold
18 coloring or the emblem of the Army, Navy, Air Force, Marines or
19 Coast Guard according to the branch of service to which the member
20 belonged. For the purpose of license plate identification, the
21 plate shall contain four digits, two digits at the left and two
22 digits at the right of the insignia or emblem. Centered on the
23 bottom of the license plate shall be the word "KOREA";

24

1 18. Municipal Official License Plates - such plates shall be
2 designed for persons elected to a municipal office in this state and
3 shall designate the name of the municipality and the district or
4 ward in which the municipal official serves. The plates shall only
5 be produced upon application;

6 19. Red Cross Volunteer License Plates - such plates shall be
7 designed to honor American Red Cross volunteers and staff who are
8 residents of this state. Such persons must present an
9 identification card issued by the American Red Cross and bearing a
10 photograph of the person. The license plate shall be designed with
11 the assistance of the American Red Cross and shall have the legend
12 "Oklahoma OK!" in the color Pantone 186C Red. Below the legend the
13 symbol of the American Red Cross and no more than three letters and
14 three numbers shall be in the color Pantone 186C Red. Below the
15 symbol and letters and numbers shall be the words "American Red
16 Cross" in black. The plates shall not be subject to the design
17 requirements of any other license plates prescribed by law other
18 than the space for the placement of the yearly decals for each
19 succeeding year of registration after the initial issue;

20 20. Veterans of Foreign Wars License Plates - such plates shall
21 be designed to honor the veterans of foreign wars and issued to any
22 resident of this state who is a member of a Veterans of Foreign Wars
23 organization in this state. Such persons may apply for Veterans of
24 Foreign Wars license plates upon proof of membership in a Veterans

1 of Foreign Wars organization. The license plate shall be designed
2 in consultation with the Veterans of Foreign Wars organization;

3 21. Desert Storm License Plates - such plates shall be designed
4 and issued to any honorably discharged or present member of the
5 United States Armed Forces who served in the Persian Gulf Crisis and
6 the Desert Storm operation. Such persons may apply for a Desert
7 Storm license plate for each vehicle with a rated carrying capacity
8 of one (1) ton or less;

9 22. Military Reserve Unit License Plates - such plates shall be
10 designed and issued to any honorably discharged or present member of
11 a reserve unit of the United States Armed Forces. Such persons may
12 apply for a Military Reserve Unit license plate for each vehicle
13 with a rated carrying capacity of one (1) ton or less;

14 23. Oklahoma City Bombing Victims and Survivors License Plates
15 - such plates shall be designed and issued to any victim or survivor
16 of the bombing attack on the Alfred P. Murrah Federal Building in
17 downtown Oklahoma City on April 19, 1995;

18 24. Civil Air Patrol License Plates - such plates shall be
19 designed and issued to any person who is a member of the Civil Air
20 Patrol. Such persons may apply for a Civil Air Patrol license plate
21 for each vehicle with a rated carrying capacity of one (1) ton or
22 less upon proof of membership in the Civil Air Patrol. The license
23 plate shall be designed in consultation with the Civil Air Patrol;

24

1 25. Ninety-Nines License Plates - such plates shall be designed
2 and issued to members of the Ninety-Nines. Persons applying for
3 such license plate must show proof of membership in the Ninety-
4 Nines. The license plates shall be designed in consultation with
5 the Ninety-Nines;

6 26. Combat Infantryman Badge License Plates - such plates shall
7 be designed to honor recipients of the Combat Infantryman Badge.
8 The plate shall have the legend "Oklahoma OK". Below the legend
9 shall be the Combat Infantryman Badge and three numbers. Below the
10 badge and the numbers shall be the words "Combat Infantryman Badge".
11 Such persons may apply for a Combat Infantryman Badge license plate
12 for each vehicle with a rated carrying capacity of one (1) ton or
13 less;

14 27. Somalia Combat Veterans License Plates - such plates shall
15 be designed and issued to any honorably discharged or present member
16 of the United States Armed Forces who saw combat in the United
17 Nations relief effort. Such persons may apply for a Somalia Combat
18 Veteran license plate for each vehicle with a rated carrying
19 capacity of one (1) ton or less;

20 28. Police Chaplain License Plates - such plates shall be
21 designed and issued to members of the International Conference of
22 Police Chaplains (ICPC) who have completed the ICPC requirements for
23 basic certification as a police chaplain. The license plates shall
24 be designed in consultation with the ICPC;

1 29. Joint Service Commendation Medal License Plates - such
2 plates shall be designed and issued to any resident of this state
3 who has been awarded the Joint Service Commendation Medal by the
4 United States Secretary of Defense;

5 30. Merchant Marine License Plates - such plates shall be
6 designed, subject to criteria to be presented to the Tax Commission
7 by the Oklahoma Department of Veterans Affairs, and issued to any
8 person who during combat was a member of the Merchant Marines as
9 certified by the Oklahoma Department of Veterans Affairs. Such
10 license plate may be issued for each vehicle with a rated carrying
11 capacity of one (1) ton or less;

12 31. Legislative License Plates - such plates shall be designed
13 for persons elected to the Oklahoma Legislature and shall designate
14 the house of the Legislature in which the legislator serves and the
15 district number;

16 32. Disabled Veterans License Plates - such plates shall be
17 designed for persons presenting proper certification from the United
18 States Department of Veterans Affairs or the Armed Forces of the
19 United States certifying such veteran has a service-connected
20 disability rating of fifty percent (50%) or more, regardless which
21 agency pays the disability benefits, or that such veteran has been
22 awarded a vehicle by the United States government or receives a
23 grant from the United States Department of Veterans Affairs for the
24 purchase of an automobile due to a service-connected disability

1 rating or due to the loss of use of a limb or an eye. Such persons
2 may apply to the Tax Commission for a disabled veterans license
3 plate or to a motor license agent for a regular license plate for no
4 more than two vehicles with each vehicle having a rated carrying
5 capacity of one (1) ton or less. The surviving spouse of any
6 deceased disabled veteran, if the spouse has not since remarried, or
7 if remarried, the remarriage is terminated by death, divorce, or
8 annulment, may apply for a disabled veterans license plate for one
9 vehicle with a rated carrying capacity of one (1) ton or less. The
10 fee provided by this section for the special license plate
11 authorized by this paragraph shall be in addition to all other
12 registration fees provided by law, except the registration fees
13 levied by Section 1132 of this title. The total expense of this
14 license plate shall not exceed Five Dollars (\$5.00).

15 If the person qualifies for a disabled veterans license plate
16 and is also eligible for a physically disabled placard under the
17 provisions of Section 15-112 of this title, the person shall be
18 eligible to receive a disabled veterans license plate that also
19 displays the international accessibility symbol, which is a stylized
20 human figure in a wheelchair. Upon the death of the disabled
21 veteran with a disabled veterans license plate with the
22 international accessibility symbol, the plate shall be returned to
23 the Tax Commission;

24

1 33. United States Air Force Association License Plates - such
2 plates shall be designed for members of the United States Air Force
3 Association. Persons applying for such license plate must show
4 proof of membership in the Association. The license plates shall be
5 designed in consultation with the Association;

6 34. Oklahoma Military Academy Alumni License Plates - such
7 plates shall be designed and issued to any resident of this state
8 who is an alumnus of the Oklahoma Military Academy. Such persons
9 may apply for an Oklahoma Military Academy Alumnus license plate for
10 each vehicle with a rated carrying capacity of one (1) ton or less.
11 The license plates shall be designed in consultation with the
12 Oklahoma Military Academy and shall contain the shield of the
13 Academy;

14 35. Amateur Radio Operator License Plates - such plates shall
15 be designed and issued to any person, holding a valid operator's
16 license, technician class or better, issued by the Federal
17 Communications Commission, and who is also the owner of a motor
18 vehicle currently registered in Oklahoma, in which has been
19 installed amateur mobile transmitting and receiving equipment.
20 Eligible persons shall be entitled to two special vehicle
21 identification plates as herein provided. Application for such
22 identification plates shall be on a form prescribed by the Tax
23 Commission and the plates issued to such applicant shall have
24 stamped thereon the word "Oklahoma" and bear the official call

1 letters of the radio station assigned by the Federal Communications
2 Commission to the individual amateur operator thereof. All
3 applications for such plates must be made to the Tax Commission on
4 or before the first day of October of any year for such plates for
5 the following calendar year and must be accompanied by the fee
6 required in this section together with a certificate, or such other
7 evidence as the Tax Commission may require, of proof that applicant
8 has a valid technician class or better amateur operator's license
9 and proof of applicant's ownership of a vehicle in which radio
10 receiving and transmitting equipment is installed. Applicants shall
11 only be entitled to one set of special identification plates in any
12 one (1) year, and such calendar year shall be stamped thereon. The
13 right to such special identification plates herein provided for
14 shall continue until the amateur radio operator's license of the
15 person to whom such plates are issued expires or is revoked;

16 36. American Legion License Plates - such plates shall be
17 designed for members of the American Legion. Persons applying for
18 such license plate must show proof of membership. The license
19 plates shall be designed in consultation with the American Legion of
20 Oklahoma;

21 37. Deputy Sheriff License Plates - such plates shall be
22 designed for any currently employed or retired county sheriff or
23 deputy sheriff. County sheriffs or deputy sheriffs may apply for
24 such plates for vehicles with a rated capacity of one (1) ton or

1 less upon proof of employment by or retirement from a county
2 sheriff's office by either an identification card or letter from the
3 county sheriff or a government-sponsored retirement board from which
4 the county sheriff or deputy sheriff may be receiving a pension.
5 Retirees who are eligible for such plates shall provide proof of
6 eligibility upon initial application, but shall not be required to
7 provide proof of eligibility annually. The license plates shall be
8 designed in consultation with the county sheriff offices of this
9 state;

10 ~~38. Surviving Spouse License Plates - such plates shall be~~
11 ~~designed for any resident of this state who is the surviving spouse~~
12 ~~of an honorably discharged veteran who died due to or as a~~
13 ~~consequence of a service-connected disability. Such surviving~~
14 ~~spouse may, if not since remarried, or if remarried, the remarriage~~
15 ~~is terminated by death, divorce or annulment, apply for a Surviving~~
16 ~~Spouse license plate for one vehicle with a rated carrying capacity~~
17 ~~of one (1) ton or less;~~

18 ~~39. Gold Star Survivor~~/Surviving Spouse License Plates - such
19 plates shall be designed to honor the surviving spouses of qualified
20 veterans. As used in this paragraph, "qualified veteran" shall
21 mean:

22 a. any person honorably discharged from any branch of the
23 United States Armed Forces or as a member of the
24 Oklahoma National Guard, who died as a direct result

1 of the performance of duties for any branch of the
2 United States Armed Forces or Oklahoma National Guard
3 while on active military duty, or

- 4 b. any person honorably discharged from any branch of the
5 United States Armed Forces or as a member of the
6 Oklahoma National Guard, who died as a result of
7 injury, illness or disease caused by the performance
8 of such duties while on active duty, whether the death
9 occurred while on active duty or after the honorable
10 discharge of such person.

11 The fee provided by this section for the special license plate
12 authorized by this paragraph shall be in addition to all other
13 registration fees provided by law, except the registration fees
14 levied by Section 1132 of this title;

15 ~~40.~~ 39. Korea Defense Service Medal License Plates - such
16 plates shall be designed and issued to any resident of this state
17 who has been awarded the Korea Defense Service Medal by the United
18 States Secretary of Defense. Such persons may apply for a Korea
19 Defense Service Medal license plate for each vehicle with a rated
20 carrying capacity of one (1) ton or less;

21 ~~41.~~ 40. 180th Infantry License Plates - such plates shall be
22 designed for members and prior members of the 180th Infantry.
23 Persons applying for such license plate must obtain and provide
24 proof of their membership from the 180th Infantry Association. The

1 license plates shall be designed in consultation with the 180th
2 Infantry;

3 ~~42.~~ 41. Operation Iraqi Freedom Veteran License Plates - such
4 plates shall be designed and issued to any honorably discharged or
5 present member of the United States Armed Forces who served in
6 Operation Iraqi Freedom. Such person may apply for an Operation

12 Such persons may apply for a United States Air Force Academy Alumnus
13 license plate for each vehicle with a rated carrying capacity of one
14 (1) ton or less;

15 ~~44.~~ 43. Operation Enduring Freedom Veteran License Plate - such
16 plates shall be designed and issued to any honorably discharged or
17 present member of the United States Armed Forces who served in
18 Operation Enduring Freedom on or after September 11, 2001. The
19 license plate shall be designed in consultation with the Military
20 Department of the State of Oklahoma. Such person may apply for an
21 Operation Enduring Freedom Veteran license plate for each vehicle
22 with a rated carrying capacity of one (1) ton or less;

23 ~~45.~~ 44. Military Multi-Decoration License Plate - such plates
24 shall be designed and issued to any honorably discharged or present

1 member of the United States Armed Forces who qualifies for more than
2 one military decoration license plate pursuant to the provisions of
3 this section. The Tax Commission shall develop and implement a
4 system whereby the designs of the eligible license plates can be
5 included together on a single license plate. Such person may apply
6 for a Military Multi-Decoration license plate for each vehicle with
7 a rated carrying capacity of one (1) ton or less; and

8 ~~46.~~ 45. Global War on Terror Expeditionary License Plate - such
9 plates shall be designed and issued to any honorably discharged or
10 present member of the United States Armed Forces who has earned a
11 Global War on Terror Expeditionary decoration. The license plate
12 shall be designed in consultation with the United States Institute
13 of Heraldry and the Military Department of the State of Oklahoma.
14 Such person may apply for a Global War on Terror Expeditionary
15 license plate for each vehicle with a rated carrying capacity of one
16 (1) ton or less.

17 C. Unless otherwise provided by this section, the fee for such
18 plates shall be Eight Dollars (\$8.00) and shall be in addition to
19 all other registration fees provided by the Oklahoma Vehicle License
20 and Registration Act. Such fees shall be deposited in the Oklahoma
21 Tax Commission Reimbursement Fund to be used for the administration
22 of the Oklahoma Vehicle License and Registration Act.

23 SECTION 2. AMENDATORY 74 O.S. 2011, Section 150.9, is
24 amended to read as follows:

1 Section 150.9. A. The Oklahoma State Bureau of Investigation
2 shall procure, file and maintain criminal history records for each
3 person subject to mandatory reporting as provided by law, including
4 photographs, descriptions, fingerprints, measurements and other
5 pertinent information relating to such persons. It shall be the
6 duty of law enforcement officers and agencies, sheriffs, police,
7 courts, judicial officials, district attorneys, and the persons in
8 charge of any state correctional facility or institution to furnish
9 criminal history records to the Bureau as required by Section 150.1
10 et seq. of this title. The Oklahoma State Bureau of Investigation
11 shall cooperate with and assist the sheriffs, chiefs of police and
12 other law enforcement officers of the state by maintaining a
13 complete criminal history record on each person subject to mandatory
14 reporting as provided by law, and shall have on file the fingerprint
15 impressions of all such persons together with other pertinent
16 information as may from time to time be received from the law
17 enforcement officers of this and other states or as may be required
18 by law.

19 B. 1. The Oklahoma Department of Consumer Credit, the
20 Insurance Department, the Oklahoma Horse Racing Commission, the
21 Oklahoma Tax Commission, or any other state agency, board,
22 department or commission or any other person or entity authorized to
23 request a criminal history record or an analysis of fingerprints for
24 commercial, licensing or other purposes, except law enforcement

1 purposes, shall conduct a national criminal history records check on
2 all persons of the entity authorized to access or review national
3 criminal history records checks information by July 1, 2009, and
4 within sixty (60) days thereafter.

5 2. Each agency, person or entity authorized to request a
6 criminal history record or an analysis of fingerprints shall pay a
7 fee to the Bureau for each criminal history record or fingerprint
8 analysis as follows:

9 Oklahoma criminal history record only	\$15.00 each
10 Oklahoma criminal history record	
11 with fingerprint analysis	\$19.00 each
12 National criminal history record	
13 with fingerprint analysis	\$41.00 each

14 3. For purposes of this section, "a national criminal history
15 record check" means a check of criminal history records entailing
16 the fingerprinting of the individual and submission of the
17 fingerprints to the United States Federal Bureau of Investigation
18 (FBI) for the purpose of obtaining the national criminal history
19 record of the person from the FBI. A criminal history record check
20 may be obtained only when a check is authorized or required by state
21 or federal law.

22 4. Unless a national criminal history record is specifically
23 requested, a fingerprint analysis shall be limited to only those
24 records available at the Oklahoma State Bureau of Investigation.

1 Following receipt of the appropriate fee, the Bureau shall provide,
2 as soon as possible, the criminal history record requested;
3 provided, however, it shall be the duty and responsibility of the
4 requesting authority to evaluate the criminal history record as such
5 record may apply to a specific purpose or intent. An individual may
6 submit a certified court record showing that a charge was dismissed
7 or a certified copy of a gubernatorial pardon to the Oklahoma State
8 Bureau of Investigation, and upon verification of that record the
9 Bureau records shall reflect the dismissal of that charge.

10 C. The Oklahoma State Bureau of Investigation may maintain an
11 identification file, including fingerprint impressions, on any
12 person under eighteen (18) years of age who is arrested or subject
13 to criminal or juvenile delinquency proceedings, provided all such
14 information shall be confidential and shall only be made available
15 to the Bureau and other law enforcement agencies. Whenever a
16 fingerprint impression or other identification information is
17 submitted to the Bureau on a person under eighteen (18) years of
18 age, the Bureau may retain and file such fingerprint and
19 identification information for identification purposes only. The
20 Bureau shall ensure that the information received and maintained for
21 identification purposes on persons under eighteen (18) years of age
22 shall be handled and processed with great care to keep such
23 information confidential from the general public. The Bureau may
24 receive and maintain the fingerprints and other identification

1 information on any person under eighteen (18) years of age believed
2 to be the subject of a runaway, missing, or abduction investigation,
3 for identification purposes at the request of a parent, guardian or
4 legal custodian of the person.

5 D. Any person who knowingly procures, utters, or offers any
6 false, forged or materially altered criminal history record shall be
7 guilty of a felony and upon conviction shall be punished by
8 imprisonment in the custody of the Department of Corrections for a
9 period not to exceed five (5) years or by a fine not to exceed Five
10 Thousand Dollars (\$5,000.00), or by both such fine and imprisonment.

11 SECTION 3. This act shall become effective November 1, 2013.
