6 AS INTRODUCED

7 An Act relating to various Oklahoma Centennial  
8 Commissions; repealing 73 O.S. 2011, Sections 98,  
9 98.1, 98.2, 98.3, 98.4, 98.5, as amended by Section  
10 673, Chapter 304, O.S.L. 2012, 98.6 and 98.7 (73 O.S.  
11 Supp. 2013, Section 98.5), which relate to the  
12 Oklahoma Centennial Act; repealing 73 O.S. 2011,  
13 Sections 99.1, 99.2, 99.3, 99.4, 99.5 and 99.6, as  
14 amended by Section 674, Chapter 304, O.S.L. 2012 (73  
15 O.S. Supp. 2013, Section 99.6), which relate to the  
16 Oklahoma Centennial County Courthouses Preservation  
17 Act; repealing 73 O.S. 2011, Sections 99.10, 99.11,  
18 99.12, 99.13, 99.14 and 99.15, as amended by Section  
19 675, Chapter 304, O.S.L. 2012 (73 O.S. Supp. 2013,  
20 Section 99.15), which relate to the Oklahoma Historic  
21 Capitols Preservation Act; requiring certain  
22 Commissions to cease activities by certain date;  
23 terminating certain revolving funds; providing for  
24 distribution of certain remaining monies; providing  
for noncodification; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. REPEALER 73 O.S. 2011, Sections 98, 98.1,  
98.2, 98.3, 98.4, 98.5, as amended by Section 673, Chapter 304,  
O.S.L. 2012, 98.6 and 98.7 (73 O.S. Supp. 2013, Section 98.5), are  
hereby repealed.

1 SECTION 2. REPEALER 73 O.S. 2011, Sections 99.1, 99.2,  
2 99.3, 99.4, 99.5 and 99.6, as amended by Section 674, Chapter 304,  
3 O.S.L. 2012 (73 O.S. Supp. 2013, Section 99.6), are hereby repealed.

4 SECTION 3. REPEALER 73 O.S. 2011, Sections 99.10, 99.11,  
5 99.12, 99.13, 99.14 and 99.15, as amended by Section 675, Chapter  
6 304, O.S.L. 2012 (73 O.S. Supp. 2013, Section 99.15), are hereby  
7 repealed.

8 SECTION 4. NEW LAW A new section of law not to be  
9 codified in the Oklahoma Statutes reads as follows:

10 A. The Oklahoma Capitol Complex and Centennial Commemoration  
11 Commission and the Oklahoma Centennial County Courthouses  
12 Preservation Commission shall cease any ongoing operations,  
13 activities or contracts upon the effective date of this act.

14 B. The following revolving funds established pursuant to law  
15 shall be closed in the State Treasury:

16 1. The Oklahoma Capitol Complex and Centennial Commemoration  
17 Commission Revolving Fund;

18 2. The Oklahoma Historic Capitols Preservation Act Revolving  
19 Fund; and

20 3. The Oklahoma Centennial County Courthouses Preservation Act  
21 Revolving Fund.

22 C. Upon the effective date of this act, any funds remaining in  
23 the revolving funds listed herein shall be transferred to the  
24 General Revenue Fund.

1 SECTION 5. This act shall become effective November 1, 2014.
