6 AS INTRODUCED

7 An Act relating to the Fire Extinguisher Licensing  
8 Act; amending 59 O.S. 2011, Section 1820.3, as  
9 amended by Section 2, Chapter 111, O.S.L. 2013 (59  
10 O.S. Supp. 2013, Section 1820.3), which relates to  
11 definitions; adding definition; amending 74 O.S.  
12 2011, Section 324.2, as amended by Section 17,  
13 Chapter 111, O.S.L. 2013 (74 O.S. Supp. 2013, Section  
14 324.2), which relates to the State Fire Marshal  
15 Commission; modifying reference; and providing an  
16 effective date.

17 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

18 SECTION 1. AMENDATORY 59 O.S. 2011, Section 1820.3, as  
19 amended by Section 2, Chapter 111, O.S.L. 2013 (59 O.S. Supp. 2013,  
20 Section 1820.3), is amended to read as follows:

21 Section 1820.3. As used in the Fire Extinguisher Licensing Act:

22 1. "Committee" means the Fire Extinguisher Industry Committee;

23 2. "Fire extinguisher industry" means the sale, installation,  
24 maintenance, inspection, certification, alteration, repair,  
replacement, or service of portable fire extinguishers or fire  
suppression systems or any combination of the foregoing activities;

1 3. "Fire suppression systems" and "handheld portable fire  
2 extinguisher" means any listed or approved fire extinguisher systems  
3 installed in compliance with the installation manuals of the  
4 manufacturer or the applicable National Fire Protection Association  
5 Standard and its reference as outlined in the rules established by  
6 ~~the State Department of Health~~ thereto;

7 4. "Licensee" means any person licensed pursuant to the Fire  
8 Extinguisher Licensing Act; ~~and~~

9 5. "Person" means a sole proprietorship, fire partnership,  
10 association, corporation, or other similar entity; and

11 6. "Commission" means the State Fire Marshal Commission.

12 SECTION 2. AMENDATORY 74 O.S. 2011, Section 324.2, as  
13 amended by Section 17, Chapter 111, O.S.L. 2013 (74 O.S. Supp. 2013,  
14 Section 324.2), is amended to read as follows:

15 Section 324.2. The State Fire Marshal Commission shall select a  
16 chair. The Commission is hereby authorized to adopt rules necessary  
17 for the licensure, regulation and enforcement of the fire  
18 extinguishers pursuant to the Fire Extinguisher Licensing Act and  
19 for conducting its proceedings. Any four members shall constitute a  
20 quorum. The Commission shall meet monthly on such date as it may  
21 designate and may meet at such other times as it may deem necessary,  
22 or when called by the chairman or by any four members. Complete  
23 minutes of each meeting shall be kept and filed in the office of the  
24 State Fire Marshal and shall be available for public inspection

1 during reasonable office hours. The Commission shall report  
2 annually to the Governor and to the Speaker of the House of  
3 Representatives and the President Pro Tempore of the Senate of the  
4 affairs of the Commission and the office of the State Fire Marshal.

5 SECTION 3. This act shall become effective November 1, 2014.
