6 AS INTRODUCED

7 An Act relating to social work; amending 59 O.S.
8 2011, Section 1253, as amended by Section 1, Chapter
9 68, O.S.L. 2012 (59 O.S. Supp. 2012, Section 1253),
10 which relates to the State Board of Licensed Social
11 Workers; clarifying language; and providing an
12 effective date.

13 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

14 SECTION 1. AMENDATORY 59 O.S. 2011, Section 1253, as
15 amended by Section 1, Chapter 68, O.S.L. 2012 (59 O.S. Supp. 2012,
16 Section 1253), is amended to read as follows:

17 Section 1253. A. There is hereby re-created, to continue until
18 July 1, 2014, in accordance with the provisions of the Oklahoma
19 Sunset Law, the State Board of Licensed Social Workers, consisting
20 of seven (7) members.

21 B. Three of the members of the Board shall be licensed social
22 workers or licensed clinical social workers licensed pursuant to the
23 provisions of the Social Worker's Licensing Act. Two other members
24 shall be licensed as either social work associates or master's
social workers. One member shall be the president of the Oklahoma

1 Chapter of the National Association of Social Workers. The
2 remaining member of the Board shall be selected from and shall
3 represent the general public.

4 C. Responsibility for enforcement of the provisions of this act
5 is hereby vested in the State Board of Social Work. The Board shall
6 have all of the duties, powers and authority specifically granted
7 by, or necessary for, the enforcement of ~~this act~~ the Social
8 Worker's Licensing Act as well as other duties, powers and authority
9 it may be granted by applicable law.

10 D. 1. Each member of the Board appointed as a social worker
11 shall:

- 12 a. be a resident of this state,
- 13 b. be licensed in good standing to engage in the practice
14 of social work in this state,
- 15 c. at the time of appointment, have been actively engaged
16 in the practice of social work for at least one (1)
17 year out of the last five (5) years, and
- 18 d. have at least three (3) years of experience in the
19 practice of social work.

20 2. Each member of the Board appointed to represent the general
21 public shall be a resident of this state who has attained the age of
22 majority and shall not be, nor shall ever have been, a social work
23 licensee, or the spouse of a social work licensee, or a person who
24 has ever had any material financial interest in the provision of

1 social work services or has engaged in any activity directly related
2 to the practice of social work.

3 SECTION 2. This act shall become effective November 1, 2013.
