10 An Act relating to appropriations; amending Section
11 130 of Enrolled Senate Bill No. 2127 of the 2nd
12 Session of the 54th Oklahoma Legislature, which
relates to the Supreme Court; directing certain
13 transfer; stating purpose; providing an effective
14 date; and declaring an emergency.

15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. AMENDATORY Section 130 of Enrolled Senate Bill
17 No. 2127 of the 2nd Session of the 54th Oklahoma Legislature is
18 amended to read as follows:

19 Section 130. Notwithstanding any other provision of law, ~~the~~
20 ~~Supreme Court is hereby authorized to expend during~~ for the fiscal
21 year ending June 30, 2015, the Office of Management and Enterprise
22 Services shall, at the request of the Administrative Director of the
23 Courts, transfer from the Oklahoma Court Information System
24 Revolving Fund, (200 Fund), established pursuant to Section 1315 of

1 Title 20 of the Oklahoma Statutes, the sum of Ten Million Dollars
2 (\$10,000,000.00) ~~or so much thereof as may be necessary to perform~~
3 ~~the duties imposed upon the Supreme Court~~ to the Supreme Court
4 Administrative Revolving Fund for expenditures that the
5 Administrative Director of the Courts, with the approval of the
6 Chief Justice of the Supreme Court in his or her sole discretion,
7 shall deem appropriate or necessary including, but not limited to,
8 appellate and district court expenditures.

9 SECTION 2. This act shall become effective July 1, 2014.

10 SECTION 3. It being immediately necessary for the preservation
11 of the public peace, health and safety, an emergency is hereby
12 declared to exist, by reason whereof this act shall take effect and
13 be in full force from and after its passage and approval.
