## **RESOLUTION FOR CONSIDERATION**

**HR 1004** was called up for consideration.

Representative Sherrer raised a point of inquiry as to whether the Majority Floor Leader would recognize motions placing new business before the House.

The Presiding Officer stated that all motions placing new business before the House must be scheduled with the Majority Floor Leader and that motions applicable to the question under consideration at that time would be entertained by the Presiding Officer.

Representative Dorman raised a point of inquiry as to whether the Majority Floor Leader had the discretion to either schedule or not schedule motions requested by a member that would place new business before the House.

The Presiding Officer stated that the Majority Floor Leader has the authority to determine when a motion placing new business before the House is to be scheduled but does not have discretion over whether a motion would be taken up for consideration and that a motion requested by a member would be scheduled on the same day as requested by the member.

Upon motion of Representative Peterson, **HR 1004** was considered and adopted.

**HR 1004** was referred for enrollment.
