

# HOUSE JOURNAL

**Second Regular Session of the Fifty-fourth Legislature**

**of the State of Oklahoma**

**Sixth Legislative Day, Tuesday, February 11, 2014**

The House was called to order by Speaker Pro Tempore Jackson.

The roll was called with 95 Members present.

The following Members were excused: Dank, Enns, Hamilton, Schwartz, Virgin, Mr. Speaker.—6.

Speaker Pro Tempore declared a quorum present.

Prayer was offered by Pastor Ron Brunner, First Assembly of God Church, Kingfisher. Pastor Brunner was sponsored by Representative Sanders.

The Journal for the last legislative day was approved.

## **MEASURES REASSIGNED**

The following measure was reassigned:

**HB 3348** – Withdrawn from Utility and Environmental Regulation and referred to Energy and Aerospace.

## **GENERAL ORDER**

**HB 1887** by Cockroft et al of the House and Jolley of the Senate was read and considered.

Coauthored by Representative(s) Ritze

Representative Kouplén moved to amend **HB 1887**, Page 2, Section 1, Lines 8-12 by striking the entire paragraph and deleting any new language and inserting the following:

“If no candidate receives more than fifty percent (50%) of the votes cast in the election provided for in this subsection, a runoff election between the two candidates with the highest number of votes shall be conducted within thirty (30) days.”,

which amendment was withdrawn.

Representative Cockroft moved to amend **HB 1887**, Page 2, Section 1, Lines 6-7 by deleting “in odd-numbered years” after the word “April”; Lines 8-12 by striking the entire paragraph and deleting inserted language and inserting the following:

“If no candidate receives more than fifty percent (50%) of the votes cast in the election provided for in this subsection, an election between the two candidates with the highest number of votes shall be conducted on the second Tuesday of June in odd-numbered years and the fourth Tuesday of June in even-numbered years.”;

Page 4, Section 3, Lines 8-16 by restoring “3” and deleting “6”; by restoring “5” and deleting “6”; by restoring “4” and deleting “6”; Page 9, Lines 3-16 by restoring the stricken language and deleting “2015”, “2017”, “three” and “2019”; Page 10, Lines 12-14 by deleting the sentence “The terms of office for a five-member board of education shall be staggered, with two members being elected in 2015, two members being elected in 2017, and one member being elected in 2019.”; Lines 16-18 by restoring the language “on the first regular, special or emergency school board meeting after the date of the annual school election” and deleting the new language “at the beginning of the fall school semester”; Page 10, Lines 20-21 by deleting “whose term of office was shortened due to a change in election dates,”; Page 11, Line 1 by deleting the word “complete” and Line 6 by deleting the language “as an at-large member” and Page 10, Line 20 - Page 11, Line 6 by restoring the stricken language, which amendment was declared adopted.

Representative Cockroft moved that **HB 1887** be advanced from General Order, which motion was declared adopted.

### **THIRD READING**

**HB 1887** was read at length for the third time. On passage of the measure, the roll call was as follows:
