13 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

14 SECTION 1. AMENDATORY 19 O.S. 2011, Section 130.1, as
15 last amended by Section 1, Chapter 67, O.S.L. 2012 (19 O.S. Supp.
16 2014, Section 130.1), is amended to read as follows:

17 Section 130.1 There is hereby re-created, to continue until
18 July 1, ~~2015~~ 2022, in accordance with the provisions of the Oklahoma
19 Sunset Law, the Commission on County Government Personnel Education
20 and Training, hereinafter called the "Commission". The Commission
21 shall be composed of the following five (5) members: The President
22 of Oklahoma State University or designee; the State Auditor and
23 Inspector or designee; the Director of the Department of
24 Transportation or designee; the Chairman of the Oklahoma Tax

1 Commission or designee; and the President of the Oklahoma County
2 Officers Association or designee.
