12 AMENDMENT NO. 1. Page 1, line 18, Before the word "The" add the  
13 letter "A."

14 AMENDMENT NO. 2. Page 2, line 9 1/2, by adding the following:

15 "B. Any amendment of the groundwater use permit as authorized  
16 by subsection A of this act shall be obtained by the Oklahoma Water  
17 Resources Board and shall not exceed the proportionate part of the  
18 maximum annual yield of groundwater allocated to each acre of land  
19 overlying the fresh groundwater basin or subbasin as established by  
the Board."

20 AMENDMENT NO. 3. Page 1, line 20, after the word "district" and  
21 before the word "organized" add "in Cleveland  
County"

22 AMENDMENT NO. 4. Page 2, line 4, after the word "supply" and before  
23 the period (.) add "in Cleveland County"

24 AMENDMENT NO. 5. Page 2, line 10, restore the emergency clause

1 AMENDMENT NO. 6. Page 1, line 14, restore the enacting clause

2 AMENDMENT NO. 7. Page 1, line 7, restore the title to read:

3 "An act relating to prisons and reformatories;  
4 authorizing the Department of Corrections to enter  
5 certain water purchase agreement with rural water  
6 district for purpose of selling groundwater in  
7 certain area; stating requirements for purchase  
8 agreement; stating term of contract; requiring permit  
9 approval by the Oklahoma Water Resources Board;  
10 providing for codification; and declaring an  
11 emergency."

14 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

15 SECTION 1. NEW LAW A new section of law to be codified  
16 in the Oklahoma Statutes as Section 555.1 of Title 57, unless there  
17 is created a duplication in numbering, reads as follows:

18 The Department of Corrections is authorized to negotiate and  
19 enter into a water purchase agreement and execute necessary  
20 easements with a public nonprofit rural water district organized  
21 under the Rural Water, Sewer, Gas and Solid Waste Management  
22 Districts Act for purposes of selling at cost groundwater found  
23 beneath real property owned by the Department, on which the  
24 Lexington Assessment and Reception Center and the Joseph Harp

1 Correctional Center at Lexington, Oklahoma, are located, and for  
2 granting permission to the Department to amend the groundwater use  
3 permit the Department holds from the Oklahoma Water Resources Board  
4 to allow for use as a public water supply. The term of the water  
5 purchase agreement and easement shall be for not less than forty  
6 (40) years from the first date of delivery of water and as long as  
7 the groundwater is being put to a beneficial use. Any agreement  
8 entered into for the sale of water shall include a reserved right of  
9 usage by the Oklahoma Department of Corrections.

10 ~~SECTION 2. It being immediately necessary for the preservation~~  
11 ~~of the public peace, health and safety, an emergency is hereby~~  
12 ~~declared to exist, by reason whereof this act shall take effect and~~  
13 ~~be in full force from and after its passage and approval.~~
