19 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

20 SECTION 1. NEW LAW A new section of law to be codified
21 in the Oklahoma Statutes as Section 405.4 of Title 10, unless there
22 is created a duplication in numbering, reads as follows:

23 Beginning November 1, 2016, all directors of full-time child
24 care centers shall have either:

1 1. A bachelor's degree; or

2 2. An associate's degree including either three (3) credit
3 hours in early childhood education, child development or school-age
4 development or three (3) credit hours toward a Child Development
5 Associate (CDA) or Certified Childcare Professional (CCP) credential
6 or three (3) credit hours in administration and management or
7 Directors' Leadership Academy I and II and at least six (6) months
8 of experience working with children from newborn to twelve (12)
9 years of age; or

10 3. A high school diploma or General Education Development (GED)
11 diploma, six (6) credit hours in early childhood education, child
12 development or school-age development or six (6) credit hours toward
13 a CDA or CCP credential or English Competency Certificate in the
14 English Competency Exam, three (3) credit hours in administration or
15 management and at least one (1) year of experience working with
16 children from newborn to twelve (12) years of age.
