8 PROPOSED COMMITTEE SUBSTITUTE

9 An Act relating to schools; amending 70 O.S. 2011,  
10 Section 11-103.6, as last amended by Section 33 of  
11 Chapter 54, O.S.L 2015 (20 O.S. Supp. 2015, Section  
12 11-103.6), which relates to curricular standards for  
13 instruction of public school students; requiring  
14 certain courses to meet certain requirements;  
15 amending 70 O.S. 2011, Sections 1210.507, as last  
16 amended by Section 7, Chapter 430, O.S.L. 2014 and  
17 1210.508, as last amended by Section 8, Chapter 430,  
18 O.S.L. 2014 (70 O.S. Supp. 2015, Sections 1210.507  
19 and 1210.508), which relate to the Oklahoma School  
20 Testing Program Act; making implementation of an  
21 electronic delivery system for certain tests  
22 optional; directing the Board to continue  
23 administration of certain tests by other means;  
24 granting school the authority to select the means of  
administration of certain tests; authorizing the  
Board to not administer certain tests until after a  
certain time or upon certain conditions; deleting  
certain online test administration requirements;  
directing the Board to administer certain end-of-  
instruction criterion-referenced tests; deleting  
certain test completion requirement; deleting  
obsolete language; modifying testing window criteria  
for certain criterion-referenced tests; clarifying  
statutory language; amending 70 O.S. 2011, Section  
1210.523, as last amended by Section 26, Chapter 4,  
O.S.L. 2014 (70 O.S. Supp. 2015, Section 1210.523),  
which relates to mastery of state academic content  
standards in designated subjects; deleting obsolete  
language; deleting list of subject areas; modifying

1 criteria and testing requirements for demonstrating  
2 mastery; exempting students from taking certain end-  
3 of-instruction criterion-referenced tests under  
4 certain conditions; clarifying certain remediation  
5 and mastery requirements; deleting exemptions from  
6 taking certain end-of-instruction criterion-  
7 referenced tests; modifying statutory citations;  
8 directing the Board to study certain testing issues  
9 and make recommendations; requiring report to be  
10 issued to certain persons by certain date; providing  
11 for noncodification; providing an effective date; and  
12 declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 70 O.S. 2011, Section 11-103.6, as  
last amended by Section 33, Chapter 54, O.S.L. 2015 (70 O.S. Supp.  
2015, Section 11-103.6), is amended to read as follows:

Section 11-103.6 A. 1. The State Board of Education shall  
adopt subject matter standards for instruction of students in the  
public schools of this state that are necessary to ensure there is  
attainment of desired levels of competencies in a variety of areas  
to include language, mathematics, science, social studies and  
communication.

2. School districts shall develop and implement curriculum,  
courses and instruction in order to ensure that students meet the  
skills and competencies as set forth in this section and in the  
subject matter standards adopted by the State Board of Education.

1           3. All students shall gain literacy at the elementary and  
2 secondary levels. Students shall develop skills in reading,  
3 writing, speaking, computing and critical thinking. For purposes of  
4 this section, critical thinking means a manner of analytical  
5 thinking which is logical and uses linear factual analysis to reach  
6 a conclusion. They also shall learn about cultures and environments  
7 - their own and those of others with whom they share the earth.  
8 Students, therefore, shall study social studies, literature,  
9 languages, the arts, mathematics and science. Such curricula shall  
10 provide for the teaching of a hands-on career exploration program in  
11 cooperation with technology center schools.

12           4. The subject matter standards shall be designed to teach the  
13 competencies for which students shall be tested as provided in  
14 Section 1210.508 of this title, and shall be designed to prepare all  
15 students for active citizenship, employment and/or successful  
16 completion of postsecondary education without the need for remedial  
17 coursework at the postsecondary level.

18           5. The subject matter standards shall be designed with rigor as  
19 defined in paragraph 3 of subsection F of this section.

20           6. The subject matter standards for English Language Arts shall  
21 give Classic Literature and nonfiction literature equal  
22 consideration to other literature. In addition, emphasis shall be  
23 given to the study of complete works of literature.

24

1       7. At a minimum, the subject matter standards for mathematics  
2 shall require mastery of the standard algorithms in mathematics,  
3 which is the most logical, efficient way of solving a problem that  
4 consistently works, and for students to attain fluency in Euclidian  
5 geometry.

6       B. Subject to the provisions of subsection C of this section,  
7 in order to graduate from a public high school accredited by the  
8 State Board of Education with a standard diploma, students shall  
9 complete the following college preparatory/work ready curriculum  
10 units or sets of competencies at the secondary level:

11       1. Four units or sets of competencies of English to include  
12 Grammar, Composition, Literature, or any English course approved for  
13 college admission requirements;

14       2. Three units or sets of competencies of mathematics, limited  
15 to Algebra I, Algebra II, Geometry, Trigonometry, Math Analysis,  
16 Calculus, Advanced Placement Statistics, or any mathematics course  
17 with content and/or rigor above Algebra I and approved for college  
18 admission requirements;

19       3. Three units or sets of competencies of laboratory science,  
20 limited to Biology, Chemistry, Physics, or any laboratory science  
21 course with content and/or rigor equal to or above Biology and  
22 approved for college admission requirements;

23       4. Three units or sets of competencies of history and  
24 citizenship skills, including one unit of American History, 1/2 unit

1 of Oklahoma History, 1/2 unit of United States Government and one  
2 unit from the subjects of History, Government, Geography, Economics,  
3 Civics, or non-Western culture and approved for college admission  
4 requirements;

5 5. Two units or sets of competencies of the same foreign or  
6 non-English language or two units of computer technology approved  
7 for college admission requirements, whether taught at a high school  
8 or a technology center school, including computer programming,  
9 hardware, and business computer applications, such as word  
10 processing, databases, spreadsheets, and graphics, excluding  
11 keyboarding or typing courses;

12 6. One additional unit or set of competencies selected from  
13 paragraphs 1 through 5 of this subsection or career and technology  
14 education courses approved for college admission requirements; and

15 7. One unit or set of competencies of fine arts, such as music,  
16 art, or drama, or one unit or set of competencies of speech.

17 C. In lieu of the requirements of subsection B of this section  
18 which requires a college preparatory/work ready curriculum, a  
19 student may enroll in the core curriculum as provided in subsection  
20 D of this section upon written approval of the parent or legal  
21 guardian of the student. School districts may require a parent or  
22 legal guardian of the student to meet with a designee of the school  
23 prior to enrollment in the core curriculum. The State Department of  
24 Education shall develop and distribute to school districts a form

1 suitable for this purpose, which shall include information on the  
2 benefits to students of completing the college preparatory/work  
3 ready curriculum as provided for in subsection B of this section.

4 D. For those students subject to the requirements of subsection  
5 C of this section, in order to graduate from a public high school  
6 accredited by the State Board of Education with a standard diploma,  
7 students shall complete the following core curriculum units or sets  
8 of competencies at the secondary level:

9 1. Language Arts - 4 units or sets of competencies, to consist  
10 of 1 unit or set of competencies of grammar and composition, and 3  
11 units or sets of competencies which may include, but are not limited  
12 to, the following courses:

- 13 a. American Literature,
- 14 b. English Literature,
- 15 c. World Literature,
- 16 d. Advanced English Courses, or
- 17 e. other English courses with content and/or rigor equal  
18 to or above grammar and composition;

19 2. Mathematics - 3 units or sets of competencies, to consist of  
20 1 unit or set of competencies of Algebra I or Algebra I taught in a  
21 contextual methodology, and 2 units or sets of competencies which  
22 may include, but are not limited to, the following courses:

- 23 a. Algebra II,

24

- 1           b.    Geometry or Geometry taught in a contextual  
2                    methodology,  
3           c.    Trigonometry,  
4           d.    Math Analysis or Precalculus,  
5           e.    Calculus,  
6           f.    Statistics and/or Probability,  
7           g.    Computer Science,  
8           h.    (1)   contextual mathematics courses which enhance  
9                    technology preparation, or  
10           (2)   a science, technology, engineering and math  
11                    (STEM) block course meeting the requirements for  
12                    course competencies listed in paragraph 2 of  
13                    subsection B of this section, whether taught at  
14                    a:  
15                    (a)   comprehensive high school, or  
16                    (b)   technology center school when taken in the  
17                    tenth, eleventh or twelfth grade, taught by  
18                    a certified teacher, and approved by the  
19                    State Board of Education and the independent  
20                    district board of education,  
21           i.    mathematics courses taught at a technology center  
22                    school by a teacher certified in the secondary subject  
23                    area when taken in the tenth, eleventh or twelfth  
24

1 grade upon approval of the State Board of Education  
2 and the independent district board of education, or

3 j. equal to or above Algebra I;

4 3. Science - 3 units or sets of competencies, to consist of 1  
5 unit or set of competencies of Biology I or Biology I taught in a  
6 contextual methodology, and 2 units or sets of competencies in the  
7 areas of life, physical, or earth science or technology which may  
8 include, but are not limited to, the following courses:

9 a. Chemistry I,

10 b. Physics,

11 c. Biology II,

12 d. Chemistry II,

13 e. Physical Science,

14 f. Earth Science,

15 g. Botany,

16 h. Zoology,

17 i. Physiology,

18 j. Astronomy,

19 k. Applied Biology/Chemistry,

20 l. Applied Physics,

21 m. Principles of Technology,

22 n. qualified agricultural education courses,

23 o. (1) contextual science courses which enhance  
24 technology preparation, or

1 (2) a science, technology, engineering and math  
2 (STEM) block course meeting the requirements for  
3 course competencies listed in paragraph 3 of  
4 subsection B of this section, whether taught at  
5 a:

6 (a) comprehensive high school, or

7 (b) technology center school when taken in the  
8 tenth, eleventh or twelfth grade, taught by  
9 a certified teacher, and approved by the  
10 State Board of Education and the independent  
11 district board of education,

12 p. science courses taught at a technology center school  
13 by a teacher certified in the secondary subject area  
14 when taken in the tenth, eleventh or twelfth grade  
15 upon approval of the State Board of Education and the  
16 independent district board of education, or

17 q. other science courses with content and/or rigor equal  
18 to or above Biology I;

19 4. Social Studies - 3 units or sets of competencies, to consist  
20 of 1 unit or set of competencies of United States History, 1/2 to 1  
21 unit or set of competencies of United States Government, 1/2 unit or  
22 set of competencies of Oklahoma History, and 1/2 to 1 unit or set of  
23 competencies which may include, but are not limited to, the  
24 following courses:

- a. World History,
- b. Geography,
- c. Economics,
- d. Anthropology, or
- e. other social studies courses with content and/or rigor equal to or above United States History, United States Government, and Oklahoma History; and

5. Arts - 2 units or sets of competencies which may include, but are not limited to, courses in Visual Arts and General Music.

E. 1. In addition to the curriculum requirements of either subsection B or D of this section, in order to graduate from a public high school accredited by the State Board of Education students shall complete the requirements for a personal financial literacy passport as set forth in the Passport to Financial Literacy Act and any additional course requirements or recommended elective courses as may be established by the State Board of Education and the district school board. School districts shall strongly encourage students to complete two units or sets of competencies of foreign languages and two units or sets of competencies of physical and health education.

2. No student shall receive credit for high school graduation more than once for completion of the same unit or set of competencies to satisfy the curriculum requirements of this section.

1           3. A school district shall not be required to offer every  
2 course listed in subsections B and D of this section, but shall  
3 offer sufficient courses to allow a student to meet the graduation  
4 requirements during the secondary grade years of the student.

5           F. For purposes of this section:

6           1. "Contextual methodology" means academic content and skills  
7 taught by utilizing real-world problems and projects in a way that  
8 helps students understand the application of that knowledge;

9           2. "Qualified agricultural education courses" means courses  
10 that have been determined by the State Board of Education to offer  
11 the sets of competencies for one or more science content areas and  
12 which correspond to academic science courses. Qualified  
13 agricultural education courses shall include, but are not limited  
14 to, Horticulture, Plant and Soil Science, Natural Resources and  
15 Environmental Science, and Animal Science. The courses shall be  
16 taught by teachers certified in agricultural education and comply  
17 with all rules of the Oklahoma Department of Career and Technology  
18 Education;

19           3. "Rigor" means a level of difficulty that is thorough,  
20 exhaustive and accurate and is appropriate for the grade level;

21           4. "Sets of competencies" means instruction in those skills and  
22 competencies that are specified in the subject matter standards  
23 adopted by the State Board of Education and other skills and  
24

1 competencies adopted by the Board, without regard to specified  
2 instructional time; and

3 5. "Unit" means a Carnegie Unit as defined by the North Central  
4 Association's Commission on Schools.

5 G. 1. The State Board of Education shall adopt a plan to  
6 ensure that rigor is maintained in the content, teaching  
7 methodology, level of expectations for student achievement, and  
8 application of learning in all the courses taught to meet the  
9 graduation requirements as specified in this section.

10 2. The State Board of Education shall allow as much flexibility  
11 at the district level as is possible without diminishing the rigor  
12 or undermining the intent of providing these courses. To accomplish  
13 this purpose, the State Department of Education shall work with  
14 school districts in reviewing and approving courses taught by  
15 districts that are not specifically listed in subsections B and D of  
16 this section. Options may include, but shall not be limited to,  
17 courses taken by concurrent enrollment, advanced placement, or  
18 correspondence, or courses bearing different titles. Any courses  
19 approved by the State Board of Education to meet the unit or  
20 competency requirements in subsections B and D of this section shall  
21 meet the sets of competencies requirements as defined in paragraph 4  
22 of subsection F of this section.

23 3. The State Board of Education shall approve an advanced  
24 placement computer science course to meet the requirements of course

1 competencies listed in paragraph 2 of subsection B of this section  
2 if the course is taken in a student's senior year and the student is  
3 concurrently enrolled in or has successfully completed Algebra II.

4 4. Technology center school districts may offer programs  
5 designed in cooperation with institutions of higher education which  
6 have an emphasis on a focused field of career study upon approval of  
7 the State Board of Education and the independent district board of  
8 education. Students in the tenth grade may be allowed to attend  
9 these programs for up to one-half (1/2) of a school day and credit  
10 for the units or sets of competencies required in paragraphs 2 and 3  
11 of subsection B or D of this section shall be given if the courses  
12 are taught by a teacher certified in the secondary subject area;  
13 provided, credit for units or sets of competencies pursuant to  
14 subsection B of this section shall be approved for college admission  
15 requirements.

16 5. If a student enrolls in a concurrent course, the school  
17 district shall not be responsible for any costs incurred for that  
18 course, unless the school district does not offer enough course  
19 selection during the student's secondary grade years to allow the  
20 student to receive the courses needed to meet the graduation  
21 requirements of this section. If the school district does not offer  
22 the necessary course selection during the student's secondary grade  
23 years, it shall be responsible for the cost of resident tuition at  
24 an institution in The Oklahoma State System of Higher Education,

1 fees, and books for the concurrent enrollment course, and providing  
2 for transportation to and from the institution to the school site.

3 It is the intent of the Legislature that for students enrolled  
4 in a concurrent enrollment course which is paid for by the school  
5 district pursuant to this paragraph, the institution charge only the  
6 supplementary and special service fees that are directly related to  
7 the concurrent enrollment course and enrollment procedures for that  
8 student. It is further the intent of the Legislature that fees for  
9 student activities and student service facilities, including the  
10 student health care and cultural and recreational service fees, not  
11 be charged to such students.

12 6. Credit for the units or sets of competencies required in  
13 subsection B or D of this section shall be given when such units or  
14 sets of competencies are taken prior to ninth grade if the teachers  
15 are certified or authorized to teach the subjects for high school  
16 credit and the required rigor is maintained.

17 7. The three units or sets of competencies in mathematics  
18 required in subsection B or D of this section shall be completed in  
19 the ninth through twelfth grades. If a student completes any  
20 required courses or sets of competencies in mathematics prior to  
21 ninth grade, the student may take any other mathematics courses or  
22 sets of competencies to fulfill the requirement to complete three  
23 units or sets of competencies in grades nine through twelve after  
24

1 the student has satisfied the requirements of subsection B or D of  
2 this section.

3 8. All units or sets of competencies required for graduation  
4 may be taken in any sequence recommended by the school district.

5 H. As a condition of receiving accreditation from the State  
6 Board of Education, all students in grades nine through twelve shall  
7 enroll in a minimum of six periods, or the equivalent in block  
8 scheduling or other scheduling structure that allows for instruction  
9 in sets of competencies, of rigorous academic and/or rigorous  
10 vocational courses each day, which may include arts, vocal and  
11 instrumental music, speech classes, and physical education classes.

12 I. 1. Academic and vocational-technical courses designed to  
13 offer sets of competencies integrated or embedded within the course  
14 that provide for the teaching and learning of the appropriate skills  
15 and knowledge in the subject matter standards, as adopted by the  
16 State Board of Education, may upon approval of the Board, in  
17 consultation with the Oklahoma Department of Career and Technology  
18 Education if the courses are offered at a technology center school  
19 district, be counted for academic credit and toward meeting the  
20 graduation requirements of this section.

21 2. Internet-based courses offered by a technology center school  
22 that are taught by a certified teacher and provide for the teaching  
23 and learning of the appropriate skills and knowledge in the subject  
24 matter standards may, upon approval of the State Board of Education

1 and the independent district board of education, be counted for  
2 academic credit and toward meeting the graduation requirements of  
3 this section.

4 3. Internet-based courses or vocational-technical courses  
5 utilizing integrated or embedded skills for which no subject matter  
6 standards have been adopted by the State Board of Education may be  
7 approved by the Board, in consultation with the Oklahoma Department  
8 of Career and Technology Education if the courses are offered at a  
9 technology center school district, if such courses incorporate  
10 standards of nationally recognized professional organizations and  
11 are taught by certified teachers.

12 4. Courses offered by a supplemental education organization  
13 that is accredited by a national accrediting body and that are  
14 taught by a certified teacher and provide for the teaching and  
15 learning of the appropriate skills and knowledge in the subject  
16 matter standards may, upon approval of the State Board of Education  
17 and the school district board of education, be counted for academic  
18 credit and toward meeting the graduation requirements of this  
19 section.

20 J. The State Board of Education shall provide an option for  
21 high school graduation based upon attainment of the desired levels  
22 of competencies as required in tests pursuant to the provisions of  
23 Section 1210.508 of this title. Such option shall be in lieu of the  
24 amount of course credits earned.

1 K. The State Board of Education shall prescribe, adopt and  
2 approve a promotion system based on the attainment by students of  
3 specified levels of competencies in each area of the core  
4 curriculum.

5 L. Children who have individualized education programs pursuant  
6 to the Individuals with Disabilities Education Act (IDEA), and who  
7 satisfy the graduation requirements through the individualized  
8 education program for that student shall be awarded a standard  
9 diploma.

10 M. Students who enter the ninth grade in or prior to the 2007-  
11 08 school year who are enrolled in an alternative education program  
12 and meet the requirements of their plans leading to high school  
13 graduation developed pursuant to Section 1210.568 of this title  
14 shall be awarded a standard diploma.

15 N. Any student who completes the curriculum requirements of the  
16 International Baccalaureate Diploma Program shall be awarded a  
17 standard diploma.

18 O. Any student who successfully completes an advanced  
19 mathematics or science course offered pursuant to Section 1210.404  
20 of this title shall be granted academic credit toward meeting the  
21 graduation requirements pursuant to paragraph 2 or 3, as  
22 appropriate, of subsection B or D of this section.

23

1       **P. For purposes of this section, the courses**  
2 **approved for college admission requirements shall**  
3 **be courses which are approved by the Oklahoma State**  
4 **Regents for Higher Education for admission to an**  
5 **institution within The Oklahoma State System of**  
6 **Higher Education.**  
7  
8

9       Q. The State Department of Education shall collect and report  
10 data by school site and district on the number of students who  
11 enroll in the core curriculum as provided in subsection D of this  
12 section.

13       SECTION 2.        AMENDATORY        70 O.S. 2011, Section 1210.507, as  
14 last amended by Section 7, Chapter 430, O.S.L. 2014 (70 O.S. Supp.  
15 2015, Section 1210.507), is amended to read as follows:

16       Section 1210.507 A. The State Board of Education shall  
17 promulgate rules necessary for the implementation and administration  
18 of the provisions of the Oklahoma School Testing Program Act.

19       B. The State Board of Education shall require school district  
20 boards of education to annually provide information to the  
21 district's students, parents of students, and the public at large  
22 about the proper meaning and use of tests administered pursuant to  
23 the provisions of the Oklahoma School Testing Program Act. The  
24

1 Department shall develop materials and make them available to school  
2 districts regarding the Oklahoma School Testing Program.

3 C. 1. Students enrolled in an online course or program that is  
4 offered by a school district or charter school that is not the  
5 district of residence or is not located in the district of residence  
6 of the student shall be provided the opportunity to take any test  
7 required pursuant to the Oklahoma School Testing Program Act or any  
8 other test generally required of students by the school district in  
9 which the student is enrolled at an alternative testing location  
10 approved by the State Board of Education. The alternative testing  
11 locations may be at sites that are not in the school district that  
12 is offering the online course or program or the district of  
13 residence. Alternative testing locations may include technology  
14 center school sites or any other testing location selected by the  
15 school district or charter school offering the online course or  
16 program. All alternative testing locations shall be subject to  
17 testing location rules promulgated by the State Board of Education.  
18 The school district or charter school offering the online course or  
19 program shall be responsible for any cost incurred in providing an  
20 alternative testing location and any additional cost of  
21 administering a test at an alternative testing location. In order  
22 to provide alternative testing locations at geographically dispersed  
23 sites, the school district or charter school offering the online  
24 course or program shall, at a minimum, provide not less than six

1 alternative testing locations, with at least one location in each  
2 quadrant of the state and in each of the two metropolitan areas in  
3 the state. Additional alternative testing locations may be provided  
4 by the school district or charter school offering the online course  
5 or program.

6 2. The performance of students on any test required pursuant to  
7 the Oklahoma School Testing Program Act or any other test generally  
8 required of students by the school district who are enrolled full-  
9 time in an online program that is offered by a school district or  
10 charter school that is not the district of residence or is not  
11 located in the district of residence of the student shall be  
12 reported separately by the school district or charter school and  
13 shall not be included when determining the performance levels of the  
14 school district or charter school in the Oklahoma School Testing  
15 Program as reported in the Oklahoma Educational Indicators Program.

16 D. The State Board of Education shall seek to establish and  
17 post on the Internet a sample test item bank that will be made  
18 available to teachers and will allow them to create and deliver  
19 classroom assessments throughout the school year to check for  
20 student mastery of key concepts assessed by the criterion-referenced  
21 tests administered to students pursuant to the Oklahoma School  
22 Testing Program Act. Subject to the availability of funds, the  
23 Board shall annually release end-of-instruction test items and make  
24 them available to the public.

1 E. The State Board of Education shall post on the Internet  
2 criterion-referenced sample tests for each grade level and subject  
3 matter test administered to students pursuant to the Oklahoma School  
4 Testing Program Act for the purpose of communicating expectation  
5 concerning test difficulty level and format to teacher, parents and  
6 students. The Board shall maintain the sample tests on the Internet  
7 throughout the year and, as changes are made in the state academic  
8 content standards, shall update the sample tests. The Board shall  
9 seek to expand the number of sample test items each year and to  
10 revise test items as needed. The sample tests shall reflect the  
11 actual test administered to students and may contain questions used  
12 on actual tests given in previous years.

13 F. The State Board of Education ~~shall seek to~~ may implement an  
14 electronic delivery system for all tests administered pursuant to  
15 the Oklahoma School Testing Program Act that will allow students to  
16 participate in computer-based assessments in order to expedite the  
17 delivery and use of the test results. ~~Notwithstanding the~~

- e. writing of English, provided that the Board may elect to not administer the writing of English test until the 2017-2018 school year or until the Board has developed the statewide student assessments for English Language Arts and Mathematics as provided for in paragraph 1 of subsection C of Section 11-103.6a of this title, whichever occurs first.

~~The Board shall administer the tests for grade eight in reading and mathematics online with raw score test results reported immediately and complete results reported in less than two (2) weeks beginning in the 2007-08 school year.~~

~~6. Except as otherwise provided for in Section 1210.523 of this title, each student who completes the instruction for The Board shall administer end-of-instruction criterion-referenced tests in:~~

- a. English II,
- b. English III,
- c. United States History,
- d. Biology I,
- e. Algebra I,

1           f. Geometry, and

2           g. Algebra II

3 ~~at the secondary level shall complete an end-of-instruction test,~~  
4 ~~when implemented, to measure for attainment in the appropriate~~  
5 ~~subject matter standards in order to graduate from a public high~~  
6 ~~school with a standard diploma.~~

7           All students shall ~~take the tests,~~ prior to graduation, take the  
8 end-of-instruction criterion-referenced tests as required in Section  
9 1210.523 of this title, unless otherwise exempt by law. ~~The State~~  
10 ~~Board of Education shall administer the criterion-referenced tests.~~  
11 ~~The Board shall develop and field test the end-of-instruction tests~~

8 reflect high standards, are specific, well-defined, measurable,

16 least a four proficient score scores on the end-of-instruction

19 5. The State Board of Education shall adopt rules providing for

23 of this subsection for the purposes of demonstrating mastery of

10 program (IEP) pursuant to the Individuals with Disabilities

13 Assessment Program (OAAP) may be eligible to graduate from a public  
14 high school with a standard diploma after failing to meet the

19 teacher of record in consultation with the teacher in  
20 each subject in which the student failed to meet the

10 d. maintains at least a C average or the equivalent in  
11 each subject in which the student failed to meet the  
12 requirements of ~~subsection A~~ of this section, and

13 e. meets all other graduation requirements of the school  
14 district in which the student is enrolled.

15 3. The Oklahoma School for the Blind and the Oklahoma School  
16 for the Deaf shall be considered local education agencies solely for  
17 the purposes of purchasing, administering and obtaining test results  
18 under this section for the students attending their schools.

19 4. Students identified as English language learners shall be  
20 assessed in a valid and reliable manner with the state academic  
21 assessments with acceptable accommodations as necessary or, to the  
22 extent practicable, with alternate assessments aligned to the state  
23 assessment provided by the school district in the language and form  
24

1 most likely to yield accurate data of the student's knowledge of the  
2 content areas.

3 G. Students who have been denied a standard diploma by the  
4 school district in which the student is or was enrolled for failing  
5 to meet the requirements of this section may re-enroll in the school  
6 district that denied the student a standard diploma following the  
7 denial of a standard diploma. The student shall be provided  
8 remediation or intervention and the opportunity to retake the test  
9 until at least a proficient score is attained on the test or tests  
10 necessary to obtain a standard diploma. Students who re-enroll in  
11 the school district to meet the graduation requirements of this  
12 section shall be exempt from the hourly instructional requirements

15 H. The State Board of Education shall be authorized to contract

19 SECTION 5. NEW LAW A new section of law not to be  
20 codified in the Oklahoma Statutes reads as follows:

21 A. The State Board of Education, in consultation with the  
22 Oklahoma State Regents for Higher Education, the Commission for  
23 Educational Quality and Accountability, the State Board of Career  
24

1 and Technology Education and the Oklahoma Department of Commerce,  
2 shall study and make recommendations on the following:

3 1. Implementing a multi-measures approach to high school  
4 graduation. For purposes of the study, multi-measures may include  
5 but are not limited to designated statewide assessments, alternative  
6 assessments, local performance assessments, grades and course  
7 records; and

8 2. Ways to the make the current school testing program for  
9 grades three through eight as set forth in the Oklahoma School  
10 Testing Program Act more efficient and effective while still  
11 achieving the objective of having assessments designed to indicate  
12 whether students have attained an understanding of the state subject  
13 matter standards. The study may consider combining different  
14 subject area assessments into one assessment or combining different  
15 grade-level assessments into one assessment, or both.

16 B. The State Board of Education shall issue a report of the  
17 recommendations to the Governor and to all members of the  
18 Legislature by December 1, 2016.

19 SECTION 6. This act shall become effective July 1, 2016.

20 SECTION 7. It being immediately necessary for the preservation  
21 of the public peace, health and safety, an emergency is hereby  
22 declared to exist, by reason whereof this act shall take effect and  
23 be in full force from and after its passage and approval.
