PROPOSED COMMITTEE SUBSTITUTE

An Act relating to roads and bridges; amending 69 O.S. 2011, Section 1698.25, which relates to the Kelly Downing Memorial Highway; modifying memorial highway name; requiring certain reference be made on certain permanent markers; amending 69 O.S. 2011, Section 1698.62, which relates to the Veterans Memorial Highway; modifying designation of certain highway; requiring placement of certain highway markers; designating the President Dwight D. Eisenhower Memorial Highway; designating the Cullison Memorial Highway; designating the Dr. Herbert Rowland Memorial Bridge; designating the 1st Lt Robert E. Trigalet, USMC Memorial Highway; providing for codification; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 69 O.S. 2011, Section 1698.25, is amended to read as follows:

Section 1698.25 The section of State Highway 251A in Wagoner County extending from the junction of State Highway 251A and State Highway 16 east to Cherokee County shall be designated as the "Cpl

1 Kelly Downing, USMC, Memorial Highway". The Department of
2 Transportation shall cause suitable permanent markers to be placed
3 on the highway bearing that name. The Department shall make
4 reference on the permanent markers that Cpl Kelly Downing, USMC, was
5 awarded the Silver Star Medal.

6 SECTION 2. AMENDATORY 69 O.S. 2011, Section 1698.62, is
7 amended to read as follows:

8 Section 1698.62 The A. Except as provided in subsection B of
9 this section, the portion of ~~State~~ U.S. Highway 62 beginning and
10 ending with the city limits of Blanchard shall be designated as the
11 "Veterans Memorial Highway". The Department of Transportation shall
12 cause suitable permanent markers to be placed upon the highway
13 bearing that name.

14 B. The portion of U.S. Highway 62 in Blanchard extending
15 northeast from the intersection with State Highway 76 to the
16 intersection with State Highway 9 shall be designated as the "SFC
17 Tony K. Burris Memorial Highway". The Department of Transportation
18 shall cause suitable permanent markers to be placed upon the highway
19 bearing that name.

20 SECTION 3. NEW LAW A new section of law to be codified
21 in the Oklahoma Statutes as Section 1698.231 of Title 69, unless
22 there is created a duplication in numbering, reads as follows:

23 The portion of U.S. Highway 81 beginning at the junction of U.S.
24 Highway 81 and 192nd Street NE in Canadian County extending south to

1 the junction of U.S. Highway 81 and Memorial Road in Canadian County
2 shall be designated as the "President Dwight D. Eisenhower Memorial
3 Highway". The Department of Transportation shall cause suitable
4 markers bearing that name to be placed on the highway.

5 SECTION 4. NEW LAW A new section of law to be codified
6 in the Oklahoma Statutes as Section 1698.232 of Title 69, unless
7 there is created a duplication in numbering, reads as follows:

8 The portion of State Highway 11 beginning at the junction of
9 State Highway 11 and East 36th Street North in Tulsa County
10 extending north to the junction of State Highway 11 and East 96th
11 Street North in Tulsa County shall be designated as the "Cullison
12 Memorial Highway". The Department of Transportation shall cause
13 suitable markers bearing that name to be placed on the highway.

14 SECTION 5. NEW LAW A new section of law to be codified
15 in the Oklahoma Statutes as Section 1698.233 of Title 69, unless
16 there is created a duplication in numbering, reads as follows:

17 The bridge crossing the Kiamichi River on State Highway 271
18 north of Antlers shall be designated as the "Dr. Herbert Rowland
19 Memorial Bridge". The Department of Transportation shall cause
20 suitable permanent markers to be placed upon the bridge bearing that
21 name.

22 SECTION 6. NEW LAW A new section of law to be codified
23 in the Oklahoma Statutes as Section 1698.234 of Title 69, unless
24 there is created a duplication in numbering, reads as follows:

The portion of State Highway 16 beginning at the junction of State Highway 16 and State Highway 48 in Creek County extending east to the junction of State Highway 16 and S 329th W Avenue in Creek County shall be designated as the "1st Lt Robert E. Trigalet, USMC Memorial Highway". The Department of Transportation shall cause suitable markers bearing that name to be placed on the highway.

SECTION 7. This act shall become effective November 1, 2016.
