PROPOSED COMMITTEE SUBSTITUTE

A Joint Resolution directing the Secretary of State to refer to the people for their approval or rejection a proposed amendment to the Constitution of the State of Oklahoma by repealing Sections 1, 2, 3, 4, 5, 6 and 7 of Article VII-B of the Constitution of the State of Oklahoma, repealing of Section 3 of Article VII of the Constitution of the State of Oklahoma and adding a new Section 3A to Article VII of the Constitution of the State of Oklahoma; changing selection process for appellate judges and justices; providing for nonpartisan elections; abolishing the Judicial Nomination Commission; providing ballot title; and directing filing.

BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES AND THE SENATE OF THE
2ND SESSION OF THE 55TH OKLAHOMA LEGISLATURE:

SECTION 1. The Secretary of State shall refer to the people for their approval or rejection, as and in the manner provided by law, the repeal of Sections 1, 2, 3, 4, 5, 6 and 7 of Article VII-B of the Constitution of the State of Oklahoma and Section 3 of Article VII of the Constitution of the State of Oklahoma which relate to judicial selection.

1 SECTION 2. The Secretary of State shall refer to the people for
2 their approval or rejection, as and in the manner provided by law,
3 the following proposed amendment to the Constitution of the State of
4 Oklahoma by adding a new Section 3A to Article VII thereof, to read
5 as follows:

6 Section 3A. A. Elections. Beginning in the general election
7 in 2018, the voters shall elect all Justices of the Supreme Court,
8 all Judges of the Court of Criminal Appeals and all Judges of the
9 Court of Civil Appeals at a nonpartisan election on a statewide
10 ballot.

11 B. Transition Elections. In 2018, all Justices of the Supreme
12 Court, all Judges of the Court of Criminal Appeals and all Judges of
13 the Court of Civil Appeals shall be elected at a nonpartisan
14 election on a statewide ballot at the general election. Following
15 the 2018 transition election, any procedure for the election of
16 Justices or Judges shall be established by statute; provided the
17 statute shall not require the election of more than one-third (1/3)
18 of any appellate court to stand for election at one time with
19 exception for any special election that may be necessary. Provided
20 further, statute shall not allow any Justice or Judge to be elected
21 on less than a statewide ballot. Following the 2018 transition
22 election, the term of office for Justices and Judges shall be six
23 (6) years.

1 C. Qualifications for candidacy for judicial positions shall be
2 established by statute. In the event of a judicial vacancy at any
3 level, the Governor shall, by appointment, fill such vacancy until
4 the next election for statewide officers, and at such election the
5 vacancy for the unexpired term shall be filled at a nonpartisan
6 election in a manner provided by statute.

7 D. The Judicial Nominating Commission is hereby abolished.

8 E. Any previously stated right to a judicial seat provided for
9 in this Constitution is hereby extinguished. If any court of
10 competent jurisdiction shall rule that a Justice or Judge whose term
11 has not expired by the general election of 2018 is entitled to
12 finish said term notwithstanding this provision, the remainder of
13 this provision shall remain in full force and effect.

14 SECTION 3. The Ballot Title for the proposed Constitutional
15 amendments as set forth in SECTIONS 1 and 2 of this resolution shall
16 be in the following form:

19 THE GIST OF THE PROPOSITION IS AS FOLLOWS:

20 This resolution amends the Oklahoma Constitution. It changes
21 the way Justices and Judges of the Supreme Court, Court of
22 Criminal Appeals and Court of Civil Appeals are selected.

23 Currently these Justices and Judges are nominated by a judicial
24 nominating commission, with final selection by the Governor

1 although the Governor's choice is limited to the three names
2 submitted to the Governor by the Judicial Nominating Commission.
3 The amendment would change the selection method so that
4 appellate judges are now chosen by the people in elections
5 similar to the manner that district judges are now selected.
6 The terms of office would be six years.
