9 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

10 SECTION 1. AMENDATORY 59 O.S. 2011, Section 199.10, as
11 last amended by Section 8, Chapter 260, O.S.L. 2014 (59 O.S. Supp.
12 2015, Section 199.10), is amended to read as follows:

13 Section 199.10. A. All licenses issued under the provisions of
14 the Oklahoma Cosmetology and Barbering Act shall be issued for a
15 period of one (1) year. The expiration date of the license shall be
16 the last day of the month in which the applicant's birthday falls.
17 The public display of a licensee's personal residential address on
18 the face of any license issued pursuant to the provisions of the
19 Oklahoma Cosmetology and Barbering Act shall be prohibited on and
20 after July 1, 2016, and such personal address information, if
21 publically displayed on a valid license, may be redacted by the
22 licensee until the license is renewed and no longer bears his or her
23 personal residential address.

1 B. Applications for renewal must be made on or before the last
2 day of the month in which the applicant's birthday falls, and shall
3 be accompanied by the appropriate fees.

4 C. Any person who fails to renew the license within the
5 required time may make application for renewal at any time within
6 five (5) years from the expiration date of the license by paying the
7 regular renewal license fee and a late fee of Ten Dollars (\$10.00),
8 which becomes due two (2) months after the expiration date.

9 D. Any person who fails to renew within the required time may
10 make application with subsequent renewal and penalty fees.

11 E. Before a person may take an examination to renew an expired
12 license after a period of five (5) years, such person shall register
13 in a cosmetology or barber school for the given number of review
14 hours in accordance with the following timetable and schedule based
15 upon the type of license held.

10 F. Each person holding a license shall notify the Board of any
11 change in the mailing address of such person within thirty (30) days
12 after any change.

13 ~~SECTION 2. This act shall become effective July 1, 2016.~~

14 ~~SECTION 3. It being immediately necessary for the preservation~~
15 ~~of the public peace, health and safety, an emergency is hereby~~
16 ~~declared to exist, by reason whereof this act shall take effect and~~
17 ~~be in full force from and after its passage and approval.~~
